#### WHITEHALL, December 22, 1910.

H IS Majesty the King has been pleased to award the Edward Medal of the Second Class to Mr. John Evans, an Engine Driver in the employ of the North Eastern Railway Company, under the following circumstances :--

On the 17th October Evans was driving a locomotive with a set of empty trucks on the North Eastern Railway near Amble, in Northumberland, when he saw a little child in the four-foot way in front of the train, which was moving at a good pace. He shut off the steam, and, jumping off his engine, managed to reach the child and fall back with her in his arms clear of the rails before the engine reached the spot. His prompt action in the face of danger undoubtedly saved the child's life.
