#### PRESENT,

The King's Most Excellent Majesty in Council.

HEREAS the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a Representation that he has received a copy of an Interlocutor of the Sheriff-Substitute of Lanarkshire at Hamilton, dated the 5th January 1911, finding that the non-parochial Burial Ground known as Meikle Earnock Graveyard, in the Parish of Hamilton, in the County of Lanarkshire, is in a condition which is offensive and contrary to decency:

And whereas in the said Representation it is recommended that the said Burial Ground should be forthwith closed in terms of the said Act.

Now, therefore, His Majesty in Council is pleased to give notice of such Representation, and to order that the same be taken into consideration by a Committee of His Majesty's Most Honourable Privy Council on the thirteenth day of April next.

And His Majesty is further pleased to direct that this Order, or notice thereof, be published in the Edinburgh Gazette, and that copies of this Order, or notice thereof, be fixed as required by the above-mentioned Act on the doors of the church of, or on some other conspicuous places within, the parish affected by such Representation one month before such Representation is so considered.

Education (Scotland) Act, 1908.

Order No. 10 by the Scotch Education Department.

SCHOOL BOARD OF GLASGOW. SCHOOL BOARD OF MARYHILL. SCHOOL BOARD OF SPRINGBURN.

At Dover House, Whitehall, the third day of March 1911.

By the Lords of the Committee of the Privy Council on Education in Scotland.

HEREAS by subsection (1) of section 22 of the Education (Scotland) Act, 1908 (8 Edward VII., cap. 63), it is enacted that where it is represented to the Department by a school board that it would be expedient that the district or part of a district of the said school board should be united with the adjacent district or part of district of another school board so as for all purposes to constitute a district under one school board, the Department shall consult with the authorities concerned and may cause a local inquiry to be held, and, if they are of opinion that the districts should be united, may by order provide for uniting the said districts as aforesaid:

And whereas it has been represented to the Department by the School Board of Glasgow that it would be expedient that the district of the said School Board should be united with (1) the adjacent district of the School Board of Maryhill, and (2) the adjacent district of the School Board of Springburn so as for all purposes to constitute a district under one School Board:

And whereas the Department have consulted

with the said School Board of Maryhill and the said School Board of Springburn, being the authorities concerned, and the said School Boards are agreed that their respective districts should be united as aforesaid with the district of the School Board of Glasgow:

And whereas after due consideration of the matter the Department are of opinion that the said districts should be united as aforesaid:

And whereas it is expedient that the said districts should be united as aforesaid:

And whereas the proposed Order was duly published in the Edinburgh Gazette of 17th January 1911, in terms of subsection (2) of of section 22 as aforesaid:

And whereas all objections and representations respecting the same have been duly considered:

Now therefore the Department in terms of the section above recited and in virtue of the powers in that behalf conferred upon them have ordered and hereby order as follows, *videlicit*:—

1. From and after the date of the commencement of this Order, the School Board of Maryhill and the School Board of Springburn shall cease to exist, and the districts of the said School Boards shall be united with the district of the School Board of Glasgow so as for all purposes to constitute a district under the School Board of Glasgow.

2. The said School Board of Glasgow shall consist of twenty-five members. The members of the said School Board shall be elected for the first time on Friday the seventh day of April 1911, conform to such regulations as may be prescribed by the Department in virtue of their statutory powers, and the Clerk to the School Board of Glasgow is hereby appointed returning officer on the occasion of that election.

3. Save as is hereinafter provided, the School Board of Glasgow shall take over all the teachers, officers, clerks, janitors and other servants in the employment of the said School Boards of Maryhill and Springburn at the date of the commencement of this Order, and the said teachers, officers, clerks, janitors, and other servants shall become teachers, officers, clerks, janitors and servants of the School Board of Glasgow, upon the same terms and subject to the same conditions with respect to salary, promotion, retiring allowance, and all other matters as the teachers, officers, clerks, janitors, and other servants already in the employment of the said School Board, and shall receive from the said School Board not less salary, wages, or other remuneration than they may have become entitled to receive from the School Board of Maryhill or the School Board of Springburn as the case may be at the last ordinary revision of salaries, wages, or other remuneration prior to the date thereof:

Provided always

(1) that the School Board of Glasgow shall not be bound to take over the Clerk and Treasurer or the principal attendance officer of the School Board of Maryhill, but in the event of their resolving not to do so, or in the event of one or other or both of the said Clerk and Treasurer, and the said principal attendance officer preferring not to enter the service of the School Board of Glasgow, such officer or officers shall, subject to the approval of the Department, receive compensation from the School Board of Glasgow calculated at a rate not less than

that provided for "existing officers" by section 120 of the Local Government (Scotland) Act, 1889; and

(2) that the School Board of Glasgow shall not be bound to take over the Clerk and Treasurer to the School Board of Springburn, but such officer shall receive a gratuity of two hundred pounds as compensation from the

School Board of Glasgow.

- 4. From and after the date of the commencement of this Order the whole property heritable and moveable, real and personal, belonging to the School Boards of Maryhill and Springburn, whether held by them in absolute ownership or in trust shall be vested in and become the property in absolute ownership or in trust, as the case may be, of the School Board of Glasgow. And all debts, obligations, liabilities, prestations, and others, including, without prejudice to the foregoing generality, building debts and obligations for retiring allowances, in which at the date hereof the School Boards of Maryhill and Springburn may be respectively liable, shall from and after the date of the commencement of this Order become debts, obligations, liabilities, prestations, and others, of the School Board of Glasgow, who shall implement and discharge the same from time to time as they severally become due.
- 5. In this Order the expression "the Department" means the Scotch Education Department.

6. This Order shall commence to have effect immediately for all purposes connected with the election of the School Board, and on the seventh day of April one thousand nine hundred and eleven, for all other purposes.

SCHOOL BOARD OF RENFREW (LANDWARD).

SCHOOL BOARD OF RENFREW (BURGH).

HEREAS by subsection (1) of section 22 of the Education (Scotland) Act, 1908 (8 Edward VII., cap. 63), it is enacted that where it is represented to the Department by a school board that it would be expedient that the district or part of a district of the said school board should be united with the adjacent district or part of district of another school board, so as for all purposes to constitute a district under one school board, the Department shall consult with the authorities concerned, and may cause a local inquiry to be held, and, if they are of opinion that the districts should be united, may by order provide for uniting the said districts as aforesaid:

and the said principal attendance officer preferring not to enter the service of the School Board of Glasgow, such officer or officers shall, subject to the approval of the Department, receive compensation from the School Board of Glasgow calculated at a rate not less than

all purposes to constitute a district under one | school board:

And whereas the Department, after consulting with the authorities concerned and causing a local inquiry to be held, are of opinion that the said districts should be united as aforesaid:

And whereas it is expedient that the said districts should be united as aforesaid:

Now, therefore, the Department, in virtue of the powers in that behalf conferred upon them by the enactment above recited, do hereby order as follows, videlicet :-

- 1. The district of the School Board of the Parish of Renfrew (Landward) shall, from and after the date at which this Order shall commence to have effect, be united with the district of the School Board of the Burgh of Renfrew so as for all purposes to constitute a district under one School Board.
- 2. The existing School Boards shall cease to exist, and there shall be established in their room for the districts united as aforesaid one school board to be called "The School Board of Renfrew.'
- 3. The said School Board of Renfrew (hereinafter referred to as "the School Board"), shall consist of eleven members. The members of the said School Board shall be elected for the first time on Saturday the thirteenth day of May 1911, conform to such regulations as may be prescribed by the Department in virtue of their statutory powers, and Mr. Thomas Anderson, Board Room, Blythswood Testimonial School, Renfrew, is hereby appointed to be the returning officer on the occasion of that election.
- 4. The whole property heritable and moveable, real and personal, including the respective school funds and any funds held in trust, belonging to the existing school boards, and all debts and obligations due to the existing school boards, shall be transferred to and vested in the School Board in property or in trust as the case may be; and all teachers, janitors, officers, and other employees in the service of the existing school boards shall be transferred to, and become teachers, janitors, officers, and employees in the service of the School Board.
- 5. The whole debts and liabilities of the existing school boards shall be taken over by, and become debts and liabilities of, the School Board.
- 6. The whole expenses of the proceedings in connection with this Order shall be defrayed out of the school fund of the School Board.
- 7. In this Order the expression "the Department" means the Scotch Education Department.
- 8. This Order shall commence to have effect immediately for all purposes connected with the election of the School Board, and on the thirteenth day of May one thousand nine hundred and eleven, for all other purposes.

His Majesty the King has been graciously pleased to award the Edward Medal of the Second Class to Mr. Albert H. Adcock for risking his life to save a little girl from being run over by a train. On the morning of August 25th, 1909, at St. John, New Brunswick, a train from Montreal was entering the train-shed, when a little girl about five years old ran across the track in front of the engine. The engine driver applied his brakes, but could not stop the train in time, and the child would have been killed had not Adcock with great quickness and presence of mind jumped at once to the centre of the track, seized the child, and swung her clear of the track. The engine brushed Adcock's coat as he saved the child, showing how narrow was his own escape.
