The King's Most Excellent Majesty in Council.

HEREAS by the Dockyard Ports Regulation Act, 1865, it is enacted that it shall be lawful for His Majesty in Council, from time to time, by Order in Council to define the limits of a Dockyard Port for the purposes of that Act, and to make Regulations in relation to any Dockyard Port for all or any of the purposes in the said Act particularly mentioned, and for such other purposes as from time to time seem necessary, with a view to the proper protection of His Majesty's Vessels, dockyards, or property, or to the requirements of His Majesty's Naval Service.

And whereas the Harbour of Rosyth is a "Dockyard Port" within the meaning of the said Act.

And whereas it appears expedient to the requirements of His Majesty's Naval Service that the limits of the Dockyard Port of Rosyth should be defined.

And whereas the provisions of section one of the Rules Publication Act, 1893, have been complied with.

Now, therefore, His Majesty, by virtue of the powers in this behalf by the said Act or otherwise in Him vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

Preliminary.

- 1. This Order shall take effect from the date hereof.
- 2. The terms used in this Order shall have the same meaning as in the said Dockyard Ports Regulation Act.

Dockyard Port of Rosyth.

3. For the purposes of the said Act and of this Order the limits of the Dockyard Port shall be as follows:—

All the waters, bays, creeks, and rivers so far as the tide flows, excepting the Harbours of Charlestown, South Queensferry, Port Edgar and Inverkeithing, lying between the lines drawn as follows:—

On the East by a line drawn South (true) through the South Point of Carron Harbour in the County of Fife to the South Shore of the Forth.

On the West by a line drawn North (true) through Carriden House to the North Shore of the Forth.

Delineation of Limits.

4. On the Chart accompanying this Order are marked all the limits referred to therein.

5. The regulations contained in the Schedule appended hereto shall have effect in relation to the Dockyard Port of Rosyth.

SCHEDULE.

REGULATIONS for the PROTECTION of the DOCK-YARD PORT of ROSYTH and of HIS MAJESTY'S PROPERTY therein, and for Anchoring, Berthing, Mooring, and Breaming in that Port.

Limits of the Dockyard Port of Rosyth.

1. The Dockyard Port of Rosyth shall be :-

All the waters, bays, creeks, and rivers so far as the tide flows, excepting the Harbours of Charlestown, South Queensferry, Port Edgar and Inverkeithing lying between the lines drawn as | has been conveyed to mariners by notice issued

On the East by a line drawn South (true) through the South Point of Carron Harbour in the County of Fife to the South Shore of the Forth.

On the West by a line drawn North (true) through Carriden House to the North

Shore of the Forth.

2. All merchant or other private vessels shall be subject to the direction of the King's Harbour Master.

3. No merchant or other private vessel shall lie, or be moored, so as to impede the free approach to His Majesty's Dockyard at Rosyth.

4. No merchant or other private vessel shall, without licence in writing from the King's Harbour Master be moored or fastened to any of the Forts, or to any Government moorings, buoys, breakwaters, jetties, piles, or vessels in

the Dockyard Port.

5. Moorings for His Majesty's Ships, mark buoys, and other aids to navigation, and such other buoys as may be required for any purpose in connection with naval operations, may be placed by the King's Harbour Master in such positions as he may from time to time consider the requirements of His Majesty's Service demand.

6. No merchant or other private vessel shall be anchored or moored within seventy-five fathoms from the centre of any Government moorings, nor in such a position as to be liable to foul any of His Majesty Ships at those moor-

- 7. No person shall lay moorings for private vessels in the Dockyard Port, without the permission in writing, of the King's Harbour Master, and all such moorings shall be in such positions as the King's Harbour Master shall deem fit, and shall be forthwith removed on the requisition of the King's Harbour Master to that
- 8. If at any time the anchor of any merchant or other private vessel hooks any Government moorings, or any electric cables, or moorings of buoys, the master, or other person having the charge or command of such vessel shall not proceed to unhook the same, but shall forthwith give notice thereof to the King's Harbour Master, in order that aid may be given for clearing such moorings or cables without doing damage to the same.
- 9. No merchant or other private vessel shall make fast to, or lie at, any of the buoys marking the channels or shoals in the Dockyard Port.
- Merchant and other private vessels moored, anchored or placed within the Dockyard Port shall when directed to do so by the King's Harbour Master remove to such position as he shall direct. If from having no crew on board or from any other cause the vessel does not remove as directed the King's Harbour Master may remove the said vessel and recover the expense incurred in so doing from her owner.

11. No merchant or other private vessel shall be breamed in the port within two hundred yards from any of His Majesty's docks, dockyards, arsenals, wharves or powder magazines.

12. No merchant or other private vessel shall anchor on the lines of any electric cable laid down in the Dockyard Port when such line is indicated by whitewashed posts or other discernible marks erected on shore, and a warning

by the Admiralty and published in the "London Gazette.

13. No boats are to approach within 100 feet of His Majesty's Dockyard or other Government Establishments unless proceeding to or from the same on duty or with permission from the

King's Harbour Master.

14. Whenever it may be necessary for mining or gunnery operations or experiments, dredging operations, or other Naval purposes to reserve any area for such operations or purposes, the area will be marked by buoys coloured green and white, or by posts coloured red; and after 21 days' warning notice has been issued by the Admiralty, and published in the "London Gazette" no vessel shall anchor within or pass through the area so marked, unless compelled to do so by stress of weather, or to avoid acci-' dent; nor when such area is uncovered or nearly uncovered at low water shall any person pass through it, or remain in it, unless by permission of, and under such arrangements as may be from time to time made by, the officer in charge of such operations.

Penalties.

15 The master of every merchant or other private vessel to which this Order relates shall observe and cause to be observed the provisions of this Order as far as it relates to his vessel, and if any master or other person acts in any respect in contravention of any of the foregoing provisions and regulations of this Order, he shall for every such offence be liable to a penalty not exceeding the sum of Ten pounds.

PROPOSED ORDER BY THE SCOTCH EDUCATION DEPARTMENT.

SCHOOL BOARD OF MUSSELBURGH (BURGH).

SCHOOL BOARD OF INVERESK (LANDWARD).

WHEREAS by subsection (1) of section 22 of the Education (Scotland) Act, 1908 (8 Edward VII., cap. 63), it is enacted that where it is represented to the Department by a school board that it would be expedient that the district or part of a district of the said school board should be united with the adjacent district or part of district of another school board, so as for all purposes to constitute a district under one school board, the Department shall consult with the authorities concerned, and may cause a local inquiry to be held, and, if they are of opinion that the districts should be united, may by order provide for uniting the said districts as aforesaid:

And whereas it has been represented to the Department by the School Board of the Burgh of Musselburgh that it would be expedient that the district of the said School Board should be united with the adjacent district of the School Board of the Parish of Inveresk (Landward) so as for all purposes to constitute a district

under one school board:

And whereas the Department, after consulting with the authorities concerned and causing a local inquiry to be held, are of opinion that the said districts should be united as aforesaid:

And whereas it is expedient that the said

districts should be united as aforesaid:

Now therefore the Department, in virtue of the powers in that behalf conferred upon them by the enactment above recited, do hereby order as follows, videlicit :-

1. The district of the School Board of the Burgh of Musselburgh shall, from and after the date at which this Order shall commence to have effect, be united with the district of the School Board of the Parish of Inveresk (Landward) so as for all purposes to constitute a district under one school board.

2. The existing School Boards shall cease to exist and there shall be established in their room for the districts united as aforesaid one school board to be called "The School Board of the

Parish of Inveresk."

3. The said School Board of the Parish of Inveresk (hereinafter referred to as "the School Board ") shall consist of nine members. The members of the said School Board shall be elected for the first time on Saturday the twentieth day of May 1911, conform to such regulations as may be prescribed by the Department in virtue of their statutory powers, and Mr. John Richard-

son, 183 High Street, Musselburgh, is hereby appointed to be the returning officer on the occasion of that election.

4. The whole property heritable and moveable, real and personal, including the respective school funds and any funds held in trust, belonging to the existing school boards, and all debts and obligations due to the existing school boards shall be transferred to and vested in the School Board in property or in trust as the case may be; and all teachers, janitors, officers, and other employees in the service of the existing school boards shall be transferred to, and become teachers, janitors, officers, and employees in the service of the School Board.

5. The whole debts and liabilities of the existing school boards shall be taken over by, and become debts and liabilities of, the School

Board.

6. The whole expenses of the proceedings in connection with this Order shall be defrayed out of the school fund of the School Board.

7. In this Order the expression "the Department" means the Scotch Education Department.

8. This Order shall commence to have effect immediately for all purposes connected with the election of a School Board, and on the twentieth day of May one thousand nine hundred and eleven for all other purposes.

SCHOOL BOARD OF CAMPBELTOWN (BURGH).

SCHOOL BOARD OF CAMPBELTOWN (LANDWARD).

WHEREAS by subsection (1) of section 22 of the Education (Scotland) Act, 1908 (8 Edward 7, cap. 63), it is enacted that where it is represented to the Department by a school board that it would be expedient that the district or part of a district of the said school board should be united with the adjacent district or part of district of another school board, so as for all purposes to constitute a district under one school board, the Department shall consult with the authorities concerned and may cause a local inquiry to be held, and, if they are of opinion that the districts should be united, may by order provide for uniting the said districts as aforesaid:

And whereas it has been represented to the Department by the School Board of Campbeltown (Burgh) that it would be expedient that the district of the said School Board should be united with the adjacent district of the School Board of Campbeltown (Landward) so as for all purposes to constitute a district under one school board:

And whereas the Department, after consulting with the authorities concerned and causing a local inquiry to be held, are of opinion that the said districts should be united as aforesaid:

And whereas it is expedient that the said districts should be united as aforesaid:

Now therefore the Department, in virtue of the powers in that behalf conferred upon them by the enactment above recited, do hereby order as follows, videlicit:

(1) The district of the School Board of the Burgh of Campbeltown shall from and after the date at which this order shall commence to have effect, be united with the district of the School Board of the Parish of Campbeltown (Landward) so as for all purposes to constitute a district under one school board.

(2) The existing school boards of the Burgh of Campbeltown and the Parish of Campbeltown (Landward) shall cease to exist, and there shall be established in their room for the districts united as aforesaid one school board to be called

the School Board of Campbeltown.

(3) The said School Board of Campbeltown (hereinafter referred to as the "School Board") shall consist of nine members. The members of the said School Board shall be elected for the first time on Wednesday the 17th day of May 1911, conform to such regulations as may be prescribed by the Department in virtue of their statutory powers, and Mr. David Murray Maxtone, Campbeltown, is hereby appointed to be the returning officer on the occasion of that

(4) The whole property, heritable and moveable, real and personal, including the respective school funds and any funds held in trust belonging to the existing school boards, and all debts and obligations due to the existing school boards, shall be transferred to and vested in the School Board, and shall be held by the said School Board in property or in trust as the case may be; and, save as hereinafter provided, all teachers, janitors, officers, and other employees in the service of the existing school boards shall be transferred to, and become teachers, janitors, officers, and employees in the service of the School Board

Provided always that the School Board of Campbeltown shall not be bound to take over the Clerk and Treasurer to the School Board of the Parish of Campbeltown (Landward), but such Officer shall receive such compensation from the School Board of Campbeltown as may be fixed by the Department.

(5) The whole debts and liabilities of the existing school boards shall be taken over by and become debts and liabilities of the School

(6) With respect to the deficiency in the School Fund of the School Board and the sum required to meet the same, the following provisions shall

have effect, viz.:—
(a) The annual sum required to meet the interest and principal or part of principal of the amount due on bank overdraft by the School Board of the Burgh of Campbeltown as at the date of the commencement of this Order, shall be raised by a rate to be levied within the district of the said School Board of the Burgh of Campbeltown, until the said debt shall have been extinguished.

(3) The annual sum required to meet the interest and principal or part of principal of the amount due on bank overdraft by the by a rate to be levied within the district of the said School Board of the Parish of Campbeltown (Landward), until the said debt

shall have been extinguished.

(c) Quoad ultra, the deficiency in the school fund shall be allocated upon the districts of the existing school boards so that for the financial year from Whitsunday 1911 to Whitsunday 1912, the school rate to be levied in the district of the School Board of Campbeltown (Landward) shall exceed the school rate levied in the said district for the financial year from Whitsunday 1910 to Whitsunday 1911, by threepence in the pound, and thereafter in each succeeding financial year shall exceed the school rate levied in the said district in the preceding financial year by threepence in the pound, or, in the event of the difference being less than threepence, by such smaller sum per pound as may bring the said rate per pound up to an equality with the school rate per pound levied in the district of the School Board of the Burgh of Campbeltown.

(d) When the school rate per pound levied in the district of the School Board of the Parish of Campbeltown (Landward) has been brought up as aforesaid to an equality with the school rate per pound levied in the district of the School Board of the Burgh of Campbeltown, the deficiency in the School Fund of the School Board (except as hereinbefore provided) shall thenceforth be met by a uniform rate levied in the district of

the said School Board.

(e) For the purposes of this Order, the school rate per pound shall be calculated in the manner prescribed by section 25 of the Education (Scotland) Act, 1908.

(7) The whole expenses of the proceedings in connection with this Order shall be defrayed out of the School Fund of the School Board.

(8) In this Order the expression "the Department" means the Scotch Education Department.

(9) This Order shall commence to have effect immediately for all purposes connected with the election of the School Board, and on the sixteenth day of May one thousand nine hundred and eleven for all other purposes.

(To provide a new and additional Water Supply to the Burgh of Kelso and Districts and Places adjacent thereto; To Construct Works; Diversion of Path or Road; Breaking up of Diversion of Path or Road; Breaking up of by an embankment to be constructed and Roads, &c.; To Divert, take, impound, dis-formed across the said Heatherhope Burn at
