#### A ROYAL PROCLAMATION.

For appointing a Day for the Celebration in His Majesty's Indian Dominions of the Solemnity of the Coronation of His Majesty.

GEORGE, R. I.

WHEREAS upon the death of our late Sovereign of happy memory, King Edward, upon the sixth day of May, in the Year of our Lord one thousand nine hundred and ten, We did ascend the Throne under the style and title of George the Fifth, by the Grace of God, King of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, Defender of the Faith, Emperor of India;

And whereas, by Our Royal Proclamations bearing date the nineteenth day of July and the seventh day of November, in the year of our Lord one thousand nine hundred and ten, in the First Year of Our Reign, We did publish and declare Our Royal intention, by the Favour and Blessing of Almighty God, to celebrate the Solemnity of Our Royal Coronation upon the twenty-second day of June one thousand nine hundred and eleven;

And whereas it is Our wish and desire Ourselves to make known to all Our loving Subjects within Our Indian Dominions that the said Solemnity has so been celebrated, and to call to Our Presence Our Governors, Lieutenant-Governors, and other of Our Officers, the Princes, Chiefs, and Nobles of the Native States under Our Protection, and the Representatives of all the Provinces of Our Indian Empire :

Now We do, by this Our Royal Proclamation, declare Our Royal intention to hold at Delhi, on the twelfth day of December one thousand nine hundred and eleven, an Imperial Durbar for the purpose of making known the said Solemnity of Our Coronation; and We do hereby charge and command Our right trusty and wellbeloved Counsellor, Charles, Baron Hardinge of Penshurst, Our Viceroy and Governor-General of India, to take all necessary measures in that behalf.

> Given at Our Court at Buckingham Palace, this twenty-second day of March, in the year of our Lord one thousand nine hundred and eleven, and in the First Year of Our Reign.



#### GLASGOW AND SOUTH WESTERN RAILWAY.

(Construction of railways and acquisition of

tension of time for compulsory acquisition of certain lands for Glasgow and Renfrew District Railway; abandonment of railways Nos. 7 and 8 authorised by the Glasgow and South Western Railway Act, 1899; amalgamation of undertaking of Ayr and Maybole Junction Railway Company with Glasgow and South Western Railway Company; further powers to Company and Joint Committees of Company and other Companies as to holding, leasing and disposing of superfluous lands; additional capital and borrowing powers; application of funds; amendment of Acts and Orders.)

OTICE is Hereby Given that Application by Petition under and in pursuance of the provisions of the Private Legislation Procedure (Scotland) Act, 1899, is intended to be made in the month of April next to the Secretary for Scotland by the Glasgow and South Western Railway Company (hereinafter referred to as " the Company ") for an Order for the following purposes, or some of them (that is to say) :-

The procedure, subsequent to the deposit of the Petition, will be by way of Provisional Order unless it be otherwise decided in terms of the Private Legislation Procedure (Scotland) Act, 1899, in which case the procedure may be by way of Private Bill, and this Notice will, subject to the Standing Orders of Parliament, apply to such Bill.)

1. To empower the Company to make and maintain the new railways hereinafter described together with all proper stations sidings approaches works and conveniences connected therewith (that is to say):-

- (1) A Railway (No. 1) wholly situate in the Parish and Royal Burgh of Renfrew in the County of Renfrew commencing by a junction with the Company's Paisley and Renfrew Railway at a point at or near the north-east side of Meadowside Street one hundred and sixty yards or thereabouts measured in a northwesterly direction from the northmost corner of that street at its junction with Ferry Road Renfrew and terminating on the east side of the Pudzeoch Burn at a point sixty yards or thereabouts measured in an easterly direction from the said northmost corner of Meadowside Street.
- (2) A Railway (No. 2) wholly situate in the Parish and Royal Burgh of Renfrew in the County of Renfrew and partly upon works proposed to be authorised by the Clyde Navigation Bill now pending in Parliament commencing by a junction with the said intended Railway (No. 1) at its termination as hereinbefore described and terminating on the quay or wharf proposed to be authorised by the said Bill on the south side of the River Clyde at a point seventy yards or thereabouts measured in an easterly direction from the Ferry Inn Renfrew.

2. To empower the Company to purchase and acquire by compulsion or agreement and to hold lands houses and buildings and easements and servitudes in and over the same for the lands in counties of Renfrew and Ayr; ex- purposes of the intended railways and works and for the general purposes of their Undertaking and for the purpose of extending their station siding and other accommodation and for other purposes to be authorised by the intended Order or Act and also to acquire by compulsion or agreement the lands houses and buildings hereinafter described and easements and servitudes in and over the same and to confirm the purchase and acquisition of any portions of such lands, houses and buildings which may have already been acquired (that is to say) :—

- Certain lands in the Parish of Paisley in the County of Renfrew situated on the north side of and adjoining the Company's Paisley Canal Line between Bellahouston Station and East Henderston farmsteading.
- (2) Certain lands in the Parish of Paisley in the County of Renfrew situated on the south side of and adjoining the Company's main line west of and near to Elderslie Station.
- (3) Certain lands in the Parish of Renfrew in the Royal Burgh of Renfrew and in the Parish of Renfrew in the County of Renfrew situated on both sides of and adjoining the Company's Paisley and Renfrew Railway west of and near to South Renfrew Station.
- (4) Certain lands in the Parish of Kilmacolm in the County of Renfrew situated on the west side of the Company's Greenock Branch at Kilmacolm Station.
- (5) Certain lands in the Parish and Burgh of Kilwinning in the County of Ayr situated on the east side of and adjoining the Company's Ayr Branch at Kilwinning Station.
- (6) Certain lands in the Parish of Kilwinning in the County of Ayr, situated on the south side of and adjoining the Company's Doura Branch West of Nethermains Level Crossing near Kilwinning.
- (7) Certain lands in the Parish of Dundonald in the Burgh of Troon, in the County of Ayr, situated on the east side of and adjoining the Company's Troon Loop Line at Troon Passenger Station.
- (8) Certain lands in the Parish of Dundonald, in the County of Ayr, situated on the east side of and adjoining the Company's Ayr Branch north of Lochgreen Junction near Troon.

(13) Certain lands in the Parish of Dundonald in the County of Ayr situated at or near Parkthorn Quarries and lying partly on the south-east side of and adjoining the Company's line between Drybridge and Barassie Stations and partly on the south-east side of the public road on the western side of the said Quarries.

3. To confer upon the Company all necessary proper and usual powers and to make all such provisions as may be subsidiary to or consequential upon the main objects of the intended application with respect to lateral and vertical deviations whether within or beyond the limits prescribed by the Railways Clauses Consolidation (Scotland) Act 1845 and to interference with public and private property rights and interests and other matters and to provide that the Company shall not be liable under the 39th section of the Railways Clauses Consolidation (Scotland) Act 1845 to repair or maintain the surface of any road which shall be carried over either of the intended railways by a bridge or bridges or the immediate approaches thereto in any case where the levels of such road or approaches shall not be permanently and prejudicially altered.

4. To authorise the Company to purchase so much only as may be required for the purposes of the intended Order or Act of any house or other building manufactory work or other premises or any easement or servitude in under or over the same without being subject to the liability imposed by Section 90 of the Lands Clauses Consolidation (Scotland) Act, 1845. 5. To authorise the crossing stopping up

5. To authorise the crossing stopping up altering or diverting whether temporarily or permanently of all roads highways footpaths railways tramways canals foreshores streams rivers sewers watercourses gas and water pipes and electric apparatus within or adjoining to the aforesaid parishes or other places which it may be necessary to cross stop up alter or divert in executing the several purposes of the intended Order or Act and to extinguish all rights of way over and to vest in the Company the site and soil of the portions of roads highways and footpaths proposed to be stopped up.

6. To empower the Company to levy and recover tolls rates and charges for the use of the intended railways and works and for the conveyance and accommodation of traffic thereon and thereat and to alter existing tolls rates and charges and to confer vary and extinguish exemptions from the payment of tolls rates and charges.

7. To authorise the abandonment and relinquishment of the construction by the Company of Railway No. 7 and Railway No. 8 authorised by the Glasgow and South Western Railway Act 1899 and to release the Company and all other parties from all liability penalties forfeitures and obligations for or in respect of the said railways and works or the non-construction or the abandonment thereof and to make provision with respect to the retention sale feu lease or other disposition of the lands acquired for the purposes of the said Railways and works upon such terms as may be agreed upon or prescribed or provided by the intended Order or Act and to confer and give effect to any agreement which may be made prior to the passing of the intended Order or Act with reference to any of the purposes aforesaid.

8. To extend the time limited by the Glasgow and Renfrew District Railway Act, 1897, as extended by the Glasgow and South Western Railway Act, 1900, the Caledonian Railway Act, 1902, the Glasgow and South Western Railway (Darvel and Lanarkshire Railway Transfer) Order, 1904, the Glasgow and South Western Railway Order, 1906, and the Glasgow and South Western Railway Order, 1908, for the compulsory purchase of certain of the lands required for the construction of the railways authorised by the said Act of 1897, and the works connected therewith.

9.
