## PAISLEY DISTRICT TRAMWAYS.

(Defining and regulating the Issue of the Capital of the Company; Special Powers as to Creation and Issue of Authorised Capital; Formation of Sinking or Reserve Funds; Voting Powers; Incorporation, Amendment and Repeal of Acts and Orders.)

OTICE is hereby given that application is intended to be made to the Secretary for Scotland in the present month of April by Petition under the provisions of the Private Legislation Procedure (Scotland) Act 1899 by or on behalf of the Paisley District Tramways Company (hereinafter called "the Company") for a Provisional Order (hereinafter called "the Order") for effecting the following or some of the following objects and purposes (that is to say) :--

1. To define the Share Capital of the Company and to regulate the issue thereof and to amend, vary or repeal the Provisions of the Paisley District Tramways Orders 1901, 1904, 1905, and 1908 (hereinafter called "the Orders of 1901

to 1908") relating thereto and to confer further and other powers on the Company.

2. To define the powers of the Company with respect to the creation and issue of Preference Shares and to empower the Company to create and issue such shares to such amount and on such terms and conditions and with such priorities as regards capital and dividend and with such rights, privileges and liabilities including power to give a priority to such shares as regards both dividend and capital and power to pay arrears or deficiency of dividends thereon. To provide that when on a distribution of the Company's assets the holders of Preference Shares shall have received payment of the sums paid up thereon and all arrears or deficiencies of dividend they shall have no further right of participation in the assets of the Company.

3. To empower the Company to form special sinking, contingency or reserve funds for the repayment of any mortgages, bonds or debentures on the undertaking and any other borrowed moneys and of any issue of Preference Shares and arrears or deficiency of interest and dividend thereon. To authorise the appointment of Trustees to hold and administer such funds, to provide for the application thereof and the purchase and redemption of such mortgages and shares and to confer such powers on the Trustees as the Company think requisite.

4. To empower the Company to confer voting and other powers on the holders of Preference Shares.

5. To vary or extinguish all rights and privileges inconsistent with or which would or might interfere with any of the objects of the Order and to confer on the Company other rights and privileges.

6. To alter, amend, extend, and if need be, to repeal the provisions or some of the provisions of the Orders of 1901 to 1908, the Tramways Act 1870, the Companies Clauses Consolidation (Scotland) Act 1845, the Companies Clauses Act 1863 and any other Act or Order relating to the Company.

The Petition for the Order and the Draft Order and printed copies thereof will be lodged on or before the 17th day of April instant at the Office of the Secretary for Scotland, Whitehall, London, and on or before the same day printed copies of the Draft Order will also be deposited in the Office of the Clerk of the Parliaments, House of Lords and in the Private Bill Office of the House of Commons.

The procedure subsequent to the Deposit of the Petition for and the Draft Order in the Office of the Secretary for Scotland will be by way of Provisional Order unless it is otherwise decided in terms of the Private Legislation Procedure (Scotland) Act 1899, in which case the procedure may be by way of Private Bill and this Notice will subject to the Standing Orders of Parliament apply to such Bill.

the district or part of a district of the said school board should be united with the adjacent district or part of district of another school board, so as for all purposes to constitute a district under one school board, the Department shall consult with the authorities concerned and may cause a local inquiry to be held, and, if they are of opinion that the districts should be united, may by order provide for uniting the said districts as aforesaid :

And whereas it has been represented to the Department by the School Board of Campbeltown (Burgh) that it would be expedient that the district of the said School Board should be united with the adjacent district of the School Board of Campbeltown (Landward) so as for all purposes to constitute a district under one school board :

And whereas the Department, after consulting with the authorities concerned and causing a local inquiry to be held, are of opinion that the said districts should be united as aforesaid :

And whereas it is expedient that the said districts should be united as aforesaid

And whereas a Proposed Order to that effect was duly published in the Edinburgh Gazette of 10th March 1911, in terms of subsection (2) of section 22 as aforesaid :

And whereas all objections and representations respecting the same have been duly considered :

Now therefore the Department, in virtue of the powers in that behalf conferred upon them by the enactment above recited, do hereby order as follows, videlicit :-

(1) The district of the School Board of the Burgh of Campbeltown shall from and after the date at which this order shall commence to have effect, be united with the district of the School Board of the Parish of Campbeltown (Landward) so as for all purposes to constitute a district under one school board.

(2) The existing school boards of the Burgh of Campbeltown and the Parish of Campbeltown (Landward) shall cease to exist, and there shall be established in their room for the districts united as aforesaid one school board to be called " the School Board of Campbeltown."

(3) The said School Board of Campbeltown (hereinafter referred to as the "School Board ") shall consist of nine members. The members of the said School Board shall be elected for the first time on Wednesday the 17th day of May 1911, conform to such regulations as may be prescribed by the Department in virtue of their statutory powers, and Mr. David Murray Max-tone, Campbeltown, is hereby appointed to be the returning officer on the occasion of that election.

(4) The whole property, heritable and moveable, real and personal, including the respective school funds and any funds held in trust belonging to the existing school boards, and all debts and obligations due to the existing school boards, shall be transferred to and vested in the School Board, and shall be held by the said School Board in property or in trust as the case may be ; and, save as hereinafter provided, all teachers, janitors, officers, and other employees in the service of the existing school boards shall be transferred to, and become teachers, janitors, officers, and employees in the service of the School Board

Provided always that the School Board of Campbeltown shall not be bound to take over the immediately for all purposes connected with the

Clerk and Treasurer to the School Board of the Parish of Campbeltown (Landward), but such Officer shall receive a pension of fifteen pounds (£15) annually as compensation from the School Board of Campbeltown.

(5) The whole debts and liabilities of the existing school boards shall be taken over by and become debts and liabilities of the School Board

(6) With respect to the deficiency in the School Fund of the School Board and the sum required to meet the same, the following provisions shall have effect, viz. :-

(a) The annual sum required to meet the interest and principal or part of principal of the amount due on bank overdraft by the School Board of the Burgh of Campbeltown as at the date of the commencement of this Order, shall be raised by a rate to be levied within the district of the said School Board of the Burgh of Campbeltown, until the said debt shall have been extinguished.

(b) The annual sum required to meet the interest and principal or part of principal of the amount due on bank overdraft by the School Board of the Parish of Campbeltown (Landward) as at the date of the commencement of this Order, shall be raised by a rate to be levied within the district of the said School Board of the Parish of Campbeltown (Landward), until the said debt shall have been extinguished.

(c) Quoad ultra, the deficiency in the school fund shall be allocated upon the districts of the existing school boards so that for the financial year from Whitsunday 1911 to Whitsunday 1912, the school rate to be levied in the district of the School Board of Campbeltown (Landward) shall exceed the school rate levied in the said district for the financial year from Whitsunday 1910 to Whitsunday 1911, by twopence in the pound, and thereafter in each succeeding financial year shall exceed the school rate levied in the said district in the preceding financial year by twopence in the pound, or, in the event of the difference being less than twopence, by such smaller sum per pound as may bring the said rate per pound up to an equality with the school rate per pound levied in the district of the School Board of the Burgh of Campbeltown.

(d) When the school rate per pound levied in the district of the School Board of the Parish of Campbeltown (Landward) has been brought up as aforesaid to an equality with the school rate per pound levied in the district of the School Board of the Burgh of Campbeltown, the deficiency in the School Fund of the School Board (except as hereinbefore provided) shall thenceforth be met by a uniform rate levied in the district of the said School Board.

(e) For the purposes of this Order, the school rate per pound shall be calculated in the manner prescribed by section 25 of the Education (Scotland) Act, 1908.

(7) The whole expenses of the proceedings in connection with this Order shall be defrayed out of the School Fund of the School Board.

(8) In this Order the expression "the Department " means the Scotch Education Department.

(9) This Order shall commence to have effect

\* Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
