## FACTORY AND WORKSHOP ACT, 1901.

In pursuance of Section 1 of the Rules Publication Act, 1893, notice is hereby given that the Secretary of State for the Home Department proposes, at the expiration of 40 days from the publication of this notice, to make Orders under the Factory and Workshop Act, 1901:

(1) Applying the provisions of Section 116 (relating to particulars of work or wages to be given to piece-workers) with modifications, to factories and workshops in which the manufacture of chocolates or sweetmeats, and any work incidental thereto, is carried on, and to out-workers employed in such processes, and the occupiers and contractors by whom they are employed.
