And We do by these Presents will and ordain that this Our Commission shall continue in full force and virtue, and that you, Our said Commissioners, or any three or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment.

And We do further ordain that you, or any three or more of you, have liberty to report your proceedings under this Our Commission from time to time if you shall judge it expedient so to do:

And Our further will and pleasure is that you do, with as little delay as possible, report to Us, under your hands and seals, or under the hands and seals of any three or more of you, your opinion upon the matters herein submitted for your consideration.

## ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 12TH MARCH 1912.)

### THE WART DISEASE OF POTATOES ORDER OF 1912.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Destructive Insects and Pests Acts, 1877 and 1907, do order, and it is hereby ordered, as follows:—

#### *Application of the Order.*

1. This Order shall apply to Great Britain.

#### *Definitions.*

2. In this Order—
  - "The Board" means the Board of Agriculture and Fisheries:
  - "The Local Authority" means as regards any District the Local Authority for the District under the Diseases of Animals Act, 1894:
  - "Disease" means the disease affecting potatoes which is known as *Synchytrium endobioticum*, or Wart Disease of potatoes, Black Scab, Cauliflower disease, or Potato canker; and "diseased" means affected with disease:
  - "Tubers" means tubers of the potato plant.

#### *Notification of Disease.*

3. The occupier of any premises on which disease exists, or appears to exist, shall forthwith notify the fact by post or otherwise to the Board, or to an Inspector or other officer of the Board or of the Local Authority authorised to receive such notification, and where practicable a specimen showing the disease shall accompany the notice.

#### *Precaution to be adopted in case of an Outbreak or Supposed Outbreak of Disease.*

4. No tubers shall be removed from any premises on which disease exists or appears to exist until after the investigation required by the next Article.

#### *Investigation by Local Authority.*

- 5.—(1) The Local Authority on receiving in any manner notice of the existence or apparent existence of disease shall forthwith take such steps as may be necessary to determine on what premises the disease exists, and shall cause notice of such determination to be served on the occupier of each of such premises, which, within the limits specified in the notice, shall thereupon become "infected premises" and continue to be infected premises until the notice is withdrawn in accordance with Article 9, but the limits of the infected premises may be extended by a notice served by the Local Authority on the occupier of the infected premises.

(2) The notice shall as far as practicable include in the infected premises only those lands in which there are or recently have been diseased tubers.

*Action to be taken after Preliminary Investigation.*

6.—(1) The Local Authority may at any time and from time to time by a notice served on an occupier of infected premises require him to adopt such measures for prevention of the spread of the disease as are authorised by this Article and specified in the notice.

(2) A notice under this Article may require the occupier of the premises to adopt any one or more of the following measures :—

- (a) to destroy any part of the crop, except the tubers, by fire or such other suitable method as may be specified in the notice ;
- (b) to boil thoroughly all diseased tubers ;
- (c) to take such other steps as the Local Authority may consider necessary to prevent the disease being conveyed to other premises.

(3) Nothing in this Order shall prevent the destruction by the owner thereof, by fire or other effective method, of any diseased tubers.

(4) A notice under this Article may prescribe the time within which the adoption of any measure thereby prescribed shall be completed.

*Power to Prohibit the Planting of Potatoes on Infected Premises.*

7. The Local Authority may by a notice served on the occupier of any infected premises prohibit the planting of potatoes in the infected premises except under such conditions as may be prescribed in the notice.

*Prohibition of Use and Sale of Diseased Potatoes for Seed.*

8. It shall not be lawful to use any diseased tubers for planting, or to sell or offer for sale diseased tubers for that purpose, and an Inspector of the Local Authority acting under their directions may by a notice served on the occupier of any infected premises prohibit the removal of any tubers from the infected premises except under such conditions as the Inspector acting under such directions may consider necessary to prevent any diseased tubers being so used or sold or otherwise disposed of for planting.

*Withdrawal of Notices of Infected Premises.*

9. A notice constituting any premises infected premises may be withdrawn by a notice signed by an Inspector or other officer of the Board. Unless there are special circumstances a notice of withdrawal shall not be issued as regards any premises until the expiration of three years from the date of the notice declaring the premises infected.

*Copies of Notices and Returns of Proceedings to be sent to the Board.*

10.—(1) A copy of every notice served under this Order shall be sent to the Board by the Inspector or officer by whom the notice is signed.

(2) The Local Authority shall, in a form to be provided by the Board, notify the Board of any outbreak of disease.

*Information to be given as to Diseased Potatoes.*

11. Every person who has or has had in his possession or under his charge any diseased tubers, and every person who as auctioneer, salesman, or otherwise has sold or offered for sale any such tubers, shall, if so required in writing by the Board, or the Local Authority, or an Inspector of the Board or of the Local Authority, give the Board, or the Local Authority, or the Inspector, as the case may be, all such information as he possesses as to the persons in whose possession or under whose charge they are or have been ; Provided that any information given under this Article shall not be available as evidence against the person giving the same in any prosecution under this Order, except in respect of an alleged failure to comply with this Article.

*Powers of Entry.*

12. Any Inspector or other officer appointed in that behalf by the Local Authority, upon production if so required of his appointment or authority, may for the purpose of enforcing this Order enter any premises and examine any plant or tubers thereon.

*Notification of Order.*

13. This Order shall be published by the Local Authority in accordance with any direction given by the Board.

*Powers of the Board and their Inspectors.*

14. The powers conferred by this Order on a Local Authority or an Inspector of a Local Authority may be exercised by the Board or an Inspector of the Board respectively, and any notice served by a Local Authority or an Inspector of a Local Authority may be altered or revoked by a notice under this Order served by the Board or an Inspector of the Board.

*Offences.*

15. Every person shall be liable on conviction to a penalty not exceeding ten pounds, who—

- (1) fails to give notification of disease as required by Article 3 ; or
- (2) fails to adopt such measures for prevention of the spread of the disease as are specified in a notice served on him under Article 6 ; or
- (3) removes any tubers in contravention of this Order or any notice served thereunder ; or
- (4) plants potatoes in infected premises in contravention of a notice served under this Order ; or
- (5) uses or sells or offers for sale diseased tubers for planting ; or
- (6) refuses or fails to give any information required under Article 11, or gives false information ; or
- (7) wilfully obstructs or impedes any Inspector or other officer in the course of his duties under this Order.

*Execution of the Order.*

16.—(1) Each Local Authority shall carry

into effect this Order within their District, and shall appoint such Inspectors or other officers for that purpose as may be necessary.

(2) Any duty or power imposed or conferred on a Local Authority by this Order may be performed or exercised by an Inspector of the Local Authority acting under and in accordance with any directions in that behalf given by the Local Authority.

(3) For the purposes of this Order a notice shall be deemed to be served on a person if it is delivered to him personally or left for him at his last known place of abode or business or sent through the post in a letter addressed to him there, and a notice or other document purporting to be signed by the clerk or an Inspector of a Local Authority or an Inspector of the Board shall be *prima facie* evidence that it was signed by him and duly authorised by the Local Authority or the Board.

#### *Revocation of Order.*

17. The Destructive Insects and Pests Order of 1910 shall cease to apply to Wart Disease or Black Scab of Potatoes.

#### *Commencement.*

18. This Order shall come into operation on the thirteenth day of March nineteen hundred and twelve.

#### *Short Title.*

19. This Order may be cited as the WART DISEASE OF POTATOES ORDER OF 1912.

### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 15TH MARCH 1912.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :—

The provisions of the Importation of Dogs Order of 1901 and of the Importation of Canine Animals Order of 1909 shall apply respectively to a dog or a canine animal taken from the United Kingdom, the Channel Islands, or the Isle of Man into a port in any country out of the United Kingdom (except the Channel Islands or the Isle of Man), as if the animal were

an imported animal, unless it is shown to the satisfaction of the Board that the animal has not been landed in that country and that while on board it has not been allowed to come in contact with any dog or other canine animal from that country, and unless the landing of the animal in Great Britain is authorised by a licence of the Board previously obtained.

### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 21ST MARCH 1912.)

### FOREIGN HAY AND STRAW ORDER OF 1912.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :—

#### *Prohibition of Landing of Hay and Straw.*

1. The landing in Great Britain of hay or straw brought from any country out of the United Kingdom which is not mentioned in the Schedule to this Order, is hereby prohibited, except as hereinafter expressly provided.

#### *Exceptions.*

2.—(1) This Order shall not apply to—

(a) hay or straw which at the time of importation is being used for packing merchandise ; or

(b) manufactured straw not intended for use as fodder or litter for animals ; or

(c) hay or straw which is landed at a Foreign Animals Wharf for the purpose of being there destroyed or otherwise disposed of in accordance with any instructions given by the Board of Agriculture and Fisheries ; or

(d) hay or straw which is authorised to be landed for use otherwise than as fodder or litter for animals by a licence granted by an Inspector or other Officer of the Board of Agriculture and Fisheries, which licence shall contain such conditions as in the opinion of the Board are necessary to prevent the introduction of disease by the hay or straw.

(2) The expression "animals" means horses, asses, and mules ; cattle, sheep, goats, and all other ruminating animals ; and swine.

*Offences.*

3.—(1) If any hay or straw shall be landed in contravention of this Order, the owner thereof and the owner and the lessee and the occupier of the place of landing, and the person causing, directing, or permitting the landing, and the owner and the charterer and the master of the vessel from which the same is landed, shall, each according to and in respect of his own acts or defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.

(2) If any person does any act in contravention of a condition imposed by a licence under this Order he shall be deemed guilty of an offence under the said Act.

*Revocation of Orders.*

4. The Foreign Hay and Straw Order of 1908 and any Order amending that Order are hereby revoked, and any licence under any Order hereby revoked shall have effect as a licence under this Order.

*Commencement.*

5. This Order shall come into operation on the first day of April nineteen hundred and twelve.

*Short Title.*

6. This Order may be cited as the FOREIGN HAY AND STRAW ORDER OF 1912.

**SCOTTISH INSURANCE COMPANIES  
(SUPERANNUATION FUND).**

(Establishment of Fund for Provision of Superannuation, Sickness, and Disablement Allowances for Employees of certain Scottish Insurance and Banking Companies; Incorporation of Managing Body of Fund or Con-

stitution of Committee of Management; Contributions by Companies; Employees entitled to Benefit of Fund; Increase of Benefits; Continuance of Benefits; Transfer of Services of Employee to Another Company; Employee Ceasing to be Employed; Provisions in case of Voluntary Allowances by Companies; Additional Benefits; Benefits not Attachable by Creditors; Management and Administration of Fund; Meetings of Managing Body; Investment of Funds; Audit of Accounts and Investigation of Assets and Liabilities; Surplus of and Deficiency in Fund; Admission of other Companies as Contributing Companies; Contributing Companies and their Employees to be exempt from Provisions of National Insurance Act, 1911; Application of Funds; Agreements; Repeal or Amendment of Acts and Variation of Memoranda and Articles of Association; and other purposes.)

NOTICE is hereby given, that application is intended to be made to the Secretary for Scotland in the ensuing month of April by (among others) the Companies hereinafter mentioned, or some of them (in this Notice hereinafter referred to as "the contributing Companies"), for a Provisional Order (hereinafter called "the Order") under the Private Legislation Procedure (Scotland) Act, 1899, for all or some of the purposes hereinafter stated. The Companies hereinbefore referred to are:—

The Scottish Widows' Fund and Life Assurance Society, the Edinburgh Life Assurance Company, the Scottish Union and National Insurance Company, the Standard Life Assurance Company, the Scottish Amicable Life Assurance Society, the Scottish Equitable Life Assurance Society, the Northern Assurance Company, Limited, the Scottish Provident Institution, the Scottish Life Assurance Company, Limited, and the Scottish Temperance Life Assurance Company, Limited.

The purposes of the Order are all or some of the following, among others:—

To establish a Fund (hereinafter called "the Fund") to be formed by contributions from the contributing Companies for the provision of superannuation allowances, sickness allowances, and disablement allowances for the benefit of persons, or certain classes of persons, employed by the contributing Companies within the United Kingdom or within some part or parts thereof.

To constitute or incorporate a body of trustees or the managers for the time being of the contributing Companies, or such other representatives of the contributing Companies as may be prescribed by the Order, into a body corporate, with perpetual succession and a Common Seal, under the name of "The Scottish Insurance Companies Superannuation Fund," or such other name as the Order may provide, for the purpose of managing and administering the Fund; or the Order may, if thought fit, constitute for those purposes, or provide for the constitution of a Committee under such title as may be thereby provided representative of

the contributing Companies, and in that case the Order will make such provisions as may be necessary or expedient for the appointment and retirement of members of the Committee.

To fix or provide for fixing the amount to be contributed to the Fund by the contributing Companies respectively.

To provide that every employee of a contributing Company, with such exceptions as may be provided in the Order, whose salary does not exceed the sum of £160 per annum or such other sum as may be named in the Order, shall, unless he otherwise elects, as the Order may provide, be entitled to be paid out of the Fund without contribution on his part a superannuation allowance, a sickness allowance, and a disablement allowance of the amount in the circumstances and for the period to be prescribed in the Order (which allowances are hereinafter referred to as "the minimum benefits of the Fund"), and to provide that the minimum benefits of the Fund shall be guaranteed by the contributing Companies each to its own employees entitled to such benefits.

To provide for the increase from time to time in certain circumstances of the minimum benefits of the Fund or the limit of salary of the employees entitled thereto, and to authorise the contributing Companies or the managing body of the Fund by arrangement with those Companies to admit to the benefits of the Fund, or some of them, employees whose salaries exceed the prescribed limit upon such terms (including contributions by the employees) as may be agreed upon with such employees or provided by the Order.
