The King has been pleased to approve of the Albert Medal of the Second Class being conferred upon Mr. Edward Bell, in the employ of the Canadian Copper Company, of Copper Cliff, Ontario, Canada, for gallantry in saving life, as detailed below:—

On the 11th July 1911 a disastrous forest fire broke out in the neighbourhood of the town of South Porcupine, Ontario, destroying the town and a mining camp, and the perilous position of the inhabitants was aggravated by a sudden tornado.

A party, including the manager of the Dome Mines and his family and two employees of the mining company, managed with great difficulty to pass through the smoke and flames to some water barrels, but then collapsed from exhaustion, and were unable to use the water so as to keep their clothes from catching fire from the showers of sparks.

Bell, notwithstanding the dense smoke, which had incapacitated the party, went to their rescue, and stood by them for nearly two hours, damping their clothes, and by this and other means preventing further injury by fire. By his courageous action he was instrumental in saving the lives of seven persons.

Motor Cars.

Use of Motor Cars on Highways.

THE MOTOR CARS (USE AND CONSTRUCTION) (SCOTLAND) ORDER, 1912. DATED MARCH 30, 1912.

In pursuance of the powers given to me by the Motor Car Acts, 1896 and 1903, and by any other statutes in that behalf, I, the undersigned, His Majesty's Secretary for Scotland, do hereby make the following Regulations applicable to Scotland, with respect to the use of motor cars on highways and the conditions under which they may be used, viz.:—

- Article IV. of the Motor Cars (Use and Construction) (Scotland) Order, 1904, shall, from and after the fifteenth day of April, one thousand nine hundred and twelve, have effect as if there were added as Regulation No. (7) of that Article the following Regulation; that is to say,—
 "(7) He shall not use any cut-out,
 - "(7) He shall not use any cut-out, "fitting, or other apparatus or device, "which will allow the exhaust gases "from the engine of the motor car to "escape into the atmosphere without first passing through a silencer, expansion chamber, or other contrivance suitable and sufficient for reducing as "far as may reasonably be practicable the noise which would otherwise be "caused by the escape of the said gases: "Provided that this Regulation shall apply only to a motor car propelled by an internal combustion engine and "shall not extend to a motor cycle."
- 2. Where in any Order under the Motor Car Acts, 1896 and 1903, applicable to Scotland, the Motor Cars (Use and Construction) (Scotland) Order, 1904, is referred to, such reference shall be deemed to mean and include a reference to the said Order as amended by this Order.
- 3. This Order may be cited as "The Motor Cars (Use and Construction) (Scotland) Order, 1912."

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 30TH MARCH 1912.)

THE AMERICAN GOOSEBERRY MILDEW (FRUIT) ORDER OF 1912.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Destructive Insects and Pests Acts, 1877 and 1907, do order, and it is hereby ordered, as follows:

Application of the Order.

1. This Order shall apply to England and Wales.

Definitions.

- 2. In this Order-
- "The Board" means the Board of Agriculture and Fisheries:
- "The Local Authority" means as regards any District the Local Authority for the District under the Diseases of Animals Act, 1894:
- "Disease" means the disease affecting gooseberry and current bushes which is known as Sphaerotheca mors-uvae or American Gooseberry Mildew; and "diseased" means affected with disease.

Prohibition of Sale of Diseased Gooseberries.

3. The sale or exposure for sale of diseased gooseberries is hereby prohibited, and any person who knowingly sells or exposes for sale diseased gooseberries or causes or permits any such sale or exposure shall be liable on conviction to a penalty not exceeding ten pounds.

Regulation of Importation of Gooseberries.

- 4. (1) The landing in England or Wales of any gooseberries brought from any place outside Great Britain (except the Channel Islands) is prohibited except where there is attached to the package in which the fruit is imported a label bearing the words "Imported gooseberries." and stating the name of the consignor and the country and district in which the fruit was produced.
- (2) The label required by this article shall not be erased or obliterated or detached from the package so long as any of the imported gooseberries remain therein.

Information to be given as to Imported Gooveberries.

5. Every person who has or has had in his possession any imported gooseberries, and every person who as auctioneer, salesman or otherwise has sold or offered for sale any imported gooseberries, shall, if so required in writing by the Board, or the Local Authority, or an Inspector of the Board or of the Local Authority, give the Board, or the Local Authority, or the Inspector, as the care may be, all such information as he possesses as to the country and district in which the fruit was produced and the consignor by whom, and the consignee to whom, the fruit was consigned to England or Wales. Provided that any information given under this Article shall not be available as evidence against the person giving the same in any proceedings under this Order, except in respect of an alleged failure to comply with this Article.

Cleansing of Packages containing Diseased Gooseberries.

6. A package which has contained diseased gooseberries shall, on the removal of all gooseberries therefrom and before the package is used for packing gooseberries or any other description of fruit, be thoroughly cleansed by washing or other suitable method by the owner or other person in charge of the package.

Powers of Inspectors to Enforce Cleansing of Packages.

7. An Inspector of the Local Authority or of the Board may by notice served on any person who has in his possession or under his charge a package which contains or has contained any imported gooseberries or any diseased gooseberries, whether imported or not, require such person to cleanse the package thoroughly to his satisfaction by washing or other suitable method, or if such person so prefer, to destroy the same forthwith in the presence of the Inspector, and for the purpose of cleansing to remove from the package any fruit therein.

Powers of Entry.

8. Any Inspector or other officer appointed in that behalf by the Local Authority, or by the Board, may upon production if so required of his appointment or authority enter any premises on which he has reason to believe that there are any imported or diseased gooseberries or is any package which contains or has contained any such gooseberries, and examine the gooseberries and packages on such premises.

Offences.

- 9. Every person shall be liable on conviction to a penalty not exceeding ten pounds, who—
 - (1) in contravention of this Order erases or obliterates or detaches a label from a package; or
 - (2) refuses or fails to give any information required under Article 5, or gives false information; or
 - (3) knowingly fails to cleanse any package in accordance with Article 6; or
 - (4) when served with a notice under Article 7 fails to cleanse or destroy in the prescribed manner the package to which the notice relates, or to remove the fruit therefrom; or
 - (5) wilfully obstructs or impedes any Inspector or other officer in the course of his duties under this Order.

Execution of the Order.

10. Each Local Authority shall carry into effect this Order within their District, and shall appoint such Inspectors or other officers for that purpose as may be necessary.

Commencement.

11. This Order shall come into operation on the first day of April nineteen hundred and twelve.

Short Title.

12. This Order may be cited as the AMERICAN GOOSEBERRY MILDEW (FRUIT) ORDER OF 1912.
