SCOTTISH OFFICE, WHITEHALL, April 17, 1912.

THE King has been pleased to issue a Warrant under His Majesty's Royal Sign Manual to the following effect :---

GEORGE R. & I.

GEORGE THE FIFTH, by the Grace of God of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas King, Defender of the Faith, To all whom these Presents may concern Greeting.

WHEREAS by the Small Landholders (Scotland) Act, 1911, it is amongst other things enacted that the Chairman of the Scottish Land Court constituted by the said Act shall forthwith on his appointment have the same rank and tenure of office as if he had been appointed a Judge of the Court of Session.

AND WHEREAS it has been humbly represented unto Us that it is expedient to determine the style and title to which the Chairman of the Scottish Land Court is entitled, and also to determine the style and designation to be borne by the wife of the Chairman of the Scottish Land Court, and to fix and define their respective places in the Scale of General Precedence in Scotland and in the Scale of Precedence for Ladies in Scotland.

Now KNOW YE that We have ordained and declared, and of Our Royal Prerogative Proper Motion and Good Pleasure do by these Presents ordain and declare, that the Chairman of the Scottish Land Court shall be designated for life by the style and title of "Lord" with the prefix "Honourable," by which style and title a Judge of the Court of Session is commonly

known and addressed: We do also by these Presents ordain and declare that the wife of the Chairman of the Scottish Land Court shall be entitled to assume and use the title "Lady," and to continue to use the same during the life of her husband and after his death so long as she remains a widow.

AND Our further Will and Pleasure is that the said Chairman of the Scottish Land Court shall have on all occasions the place, pre-eminence, and precedence in Scotland accorded to a Senator of the College of Justice, taking rank amongst the Lords of Session according to seniority of appointment; and that the wife of the Chairman of the Scottish Land Court shall in like manner have the precedence accorded to wives of Knights Bachelor and wives of Senators of the College of Justice who take precedence amongst themselves according to the dates of their husband's creation as Knights or appointment as Senators of the College of Justice respectively.

OUR WILL AND PLEASURE THEREFORE IS that Lyon King of Arms, to whom cognisance of matters of this nature in Scotland doth properly belong, do see this Order observed and kept, and do cause the same to be recorded in the Lyon Office in Edinburgh, to the end that Our Officers of Arms there and all others upon occasion may take full notice and have knowledge thereof, and for so doing this shall be his Warrant.

Given at Our Court at Sandringham the 16th day of April 1912, in the Second year of Our Reign.

RULES PUBLICATION ACT, 1893.

In conformity with the provisions of the Statute 56 and 57 Victoria, cap. 66, notice is hereby given that the Secretary of State for India in Council proposes, with the advice and assistance of the Civil Service Commissioners, at the expiration of forty days from the date of this Gazette (16th April), to make an alteration as shown below in the Regulations for the admission of candidates to the Civil Service of 22 Victoria, cap. 106.

After Regulation 2 it is proposed to insert the following new Regulation 3, viz. :--

3. No person who, in a previous year, accepted the offer of an nomination as a selected candidate for the Civil Service of India and subsequently resigned his position as a selected candidate, will be admitted to the examination.

The regulations at present bearing the numbers 3 to 9 will be re-numbered 4 to 10 in consequence.

It is intended that the change shall come into force for the Open Competitive Examination of 1912 and subsequent years.
