THE King Commands that the Court shall wear Mourning from this day for Four Weeks, for his late Majesty the King of Denmark, K.G., G.C.B., G.C.V.O., Uncle of His Majesty, and Brother of Her Majesty Queen Alexandra, viz.:—

The Ladies to wear black Dresses, white Gloves, black or white Shoes, Feathers, and Fans; Pearls, Diamonds, or plain gold or silver Ornaments

The Gentlemen to wear Crêpe Band on Left Arm in Uniform or Court Dress.

The Court to change to Half Mourning on Wednesday the 5th June next, viz.:—

The Ladies to wear black Dresses, with coloured Ribbons, Flowers, Feathers, and Ornaments, or grey or white Dresses, with black Ribbons, Flowers, Feathers, and Ornaments.

The Gentlemen to continue the same Mourning.

And on Wednesday the 12th June next, the Court to go out of Mourning.

WHEREAS the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a Repre-

sentation that he has received a copy of an Interlocutor of the Sheriff-Substitute of the County of Kinross, dated the 21st November 1911, and made on a Petition of the County Council of the said County, finding that the Burial Ground known as Old Fossoway Churchyard, in the Parish of Fossoway, in the County of Kinross, is offensive and contrary to decency:

And whereas in the said Representation it is recommended that the said Burial Ground should be closed in terms of the said Act, subject to reservation of the right of interment, at decease, in the family lair or burying place of the Anderson family in the said Churchyard, for the five persons hereinafter named (being the surviving sons and daughters of the late James Anderson, Carnbo), viz., John Anderson, Robert Anderson, and James R. Anderson, and Margaret Anderson and Euphemia H. Anderson, with a further reservation of the right of interment at decease for William Mercer, The Moss, Muckhart. Subject to the usual provisions as regards all interments in the said burial ground after the date of the closing Order that the exercise of the right of burial shall not be injurious to the public health or offensive or contrary to decency, and that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin.

Now, therefore, His Majesty in Council is pleased to give notice of such Representation, and to order that the same be taken into consideration by a Committee of the Privy Council on the 24th day of June next.
