Greeting!

Whereas We have deemed it expedient that a Commission should forthwith issue to report on the means of supply and storage of Liquid Fuel in peace and war and its application to warship engines whether indirectly or by internal combustion.

Now know ye that We, reposing great trust and confidence in your knowledge and ability, have authorised and appointed, and do by these Presents authorise and appoint you the said John Arbuthnot, Baron Fisher (Chairman); George Lambert; Sir Boverton Redwood; Sir Philip Watts; Sir Henry John Oram; Sir John Rushworth Jellicoe; Sir William Matthews; Sir Thomas Henry Holland; Sir Thomas Edward Thorpe; Alexander Gracie; Humphrey Owen Jones; and Alfred Fernandez Yarrow to be Our Commissioners for the purposes of the said inquiry.

And for the better effecting the purposes of this Our Commission, We do by these Presents give and grant unto you, or any three or more of you, full power to call before you such persons as you shall judge likely to afford you any informa-
