FACTORY AND WORKSHOP ACT, 1901.

(3) of the Rules Publication Act, 1893, that on the 23rd August 1912 he made an Order under section 116 of the Factory and Workshop Act, 1901, applying the provisions of that section with modifications to Shipbuilding Yards.

This Order re-enacts the previous Order of the 30th December 1909 (which applied to Shipbuilding Yards so far as concerned the work of platers, riveters, and caulkers), and extends it to the work of all persons employed in Shipbuilding Yards on the building or repairing of a ship.

* Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.


