WHEREAS there was this day read at the Board a Scheme prepared by the Scotch Education Department, in pursuance of Section 16 (2) of The Education (Scotland) Act, 1908, for the allocation of the balance of the Education (Scotland) Fund for 1912-13:

And whereas the said Scheme has, in accordance with the provisions of the said Act, been laid before both Houses of Parliament and no address praying His Majesty to withhold His assent from the said Scheme or any part thereof has been presented:

Now, therefore, His Majesty, having taken the said Scheme (a copy whereof is hereunto annexed) into consideration, is pleased, by and with the advice of His Privy Council, to approve thereof, and to prescribe the first day of April 1912, as the date from which the same shall be in force.

MINUTE OF THE COMMITTEE OF COUNCIL ON EDUCATION IN SCOTLAND, DATED THE 28TH JUNE 1912, AMENDING THE MINUTE OF 10TH JUNE 1912, PROVIDING FOR THE ALLOCATION OF THE BALANCE OF THE EDUCATION (SCOTLAND) FUND.

At Dover House, Whitehall, the 28th day of June 1912.

By the Lords of the Committee of His Majesty's Most Honourable Privy Council on Education in Scotland.

Read :-

Section 16 (2) and (3) of the Education (Scotland) Act, 1908, and the Scheme of Allocation approved by Order in Council dated 10th November 1911.

Resolved: --

That the said Scheme be amended in terms of Section 16 (3) so as to read as follows:—

(1) The Balance of the Education (Scotland)
Fund remaining in any year after providing for the first charges upon the Fund under section 16, subsections (1) (a) to (1) (f) of the Act shall be allocated among the various Secondary Education Districts as regards one-half of the amount according to the "population" of the districts and as regards one-half of the amount according to the "population" multiplied by the "cost of education" and divided by the "valuation" of the district.

Provided that when the total sum so allotted to any district is less than the sum determined by the Department to be the minimum sum necessary for the efficient carrying out of the purposes of section 17 of the Act, other than the making of grants under section 17 (8) and the addition to the Fee Grant under section 17
