



USE OF MOTOR CARS ON HIGHWAYS.

THE MOTOR CARS (USE AND CONSTRUCTION)
(SCOTLAND) ORDER (No. 2), 1912. DATED
DECEMBER 7, 1912.

In pursuance of the powers given to me by the Motor Car Acts, 1896 and 1903, and by any other statutes in that behalf, I, the undersigned, His Majesty's Secretary for Scotland, do hereby make the following Regulations applicable to Scotland, with respect to the use of motor cars on highways and the conditions under which they may be used viz:—

1. Article IV. of the Motor Cars (Use and Construction) (Scotland) Order, 1904, shall have effect as if there were added as Regulation No. (7) of that Article the following Regulation; that is to say,—

"(7) He shall not use any cut-out, fitting, or other apparatus or device, which will allow the exhaust gases from the engine of the motor car to escape into the atmosphere without first passing through a silencer, expansion chamber or other contrivance, suitable and sufficient for reducing as far as may reasonably be practicable the noise which would otherwise be caused by the escape of the said gases:

"Provided that this Regulation shall "apply only to a motor car propelled by an "internal combustion engine."

2. The Motor Cars (Use and Construction) (Scotland) Order 1912, is hereby rescinded.

3. Where in any Order under the Motor Car Acts, 1896 and 1903, applicable to Scotland, the L S.

(DUNDEE COMBINATION PARISH AND PARISH OF MAINS AND STRATHMARTINE.)

HEREAS it has been represented to me by the Dundee Combination Parish Council that I should issue an Order under Section 51 of the Local Government (Scotland) Act 1889 and Section 46 of the Local Government (Scotland) Act 1894, annexing to the Dundee Combination Parish those portions of the Parish of Mains and Strathmartine which by the Dundee Extension and Improvement Act 1892 and the Dundee Corporation Order Confirmation Act, 1907, were respectively annexed to the City and Royal Burgh of Dundee; and whereas, after consulting with the authorities concerned and causing a local enquiry to be held, I am of opinion that it is expedient to give effect to the said representation.

Now THEREFORE I, the Right Honourable Thomas McKinnon Wood, His Majesty's Secretary for Scotland, do, in virtue of the powers conferred upon me by the Local Government (Scotland) Acts, order as follows:—
(1) The portions of the said Parish of Mains

and Strathmartine above described (hereinafter referred to as the transferred area) shall cease to form part of the Parish of Mains and Strath-martine and shall form part of the Dundee Combination Parish.

(2) The Dundee Combination Parish Council shall assume responsibility for, and shall relieve the Parish Council of Mains and Strathmartine of all advances which the latter body may be called upon to make for, or on account of, any pauper whose claim is derived (1) from birth in the transferred area prior to the fifteenth day of May, 1913, or (2) from residence for the statutory period in the transferred area prior to the fifteenth day of May, 1913.

(3) Nothing herein contained shall affect the rights of creditors or of persons having vested interests; and all questions of adjustment consequent on the alterations of boundaries hereby made are expressly reserved.

(4) The amount per pound of Poor Rate, School Rate and any other rate levied by the Parish Council of Dundee Combination Parish, within the transferred area in virtue of the provisions of this Order shall not during seven years from the commencement of this Order exceed the rate per

area by the Parish Council of Mains and Strathmartine in respect of the year ending 15th May,

(5) This Order shall take effect as from the fifteenth day of May, 1913.

The above rate is to apply to all male workers (excepting all male learners) in the trade of making boxes or parts thereof made wholly or partially of paper, cardboard, chip, or similar material.

The above Trade Board have also given similar notice that they "have fixed" the following minimum time-rates for male learners, clear of all deductions, that is to say :-

When employed under 15 years 4s. 6d. a week. of age When employed at 15 and under 16 years of age 6s. 0d.

When employed at 16 and under 17 years of age

When employed at 17 and under 18 years of age

When employed at 18 and under 19 years of age ... 14s. 0d.

When employed at 19 and under 20 years of age ... 17s. 6d.

When employed at 20 and under ... 21s. 0d. 21 years of age ...

The learners' rates are weekly rates based on a week of 52 hours, but they shall be subject to a proportionate deduction or increase according as the number of hours actually spent by the learners in the factory or workshop in any week is less or more than 52.

A male learner is a worker under 21 years of age who, while employed, is engaged during the whole or a substantial part of his time in learning some branch or process of the trade.
