by the Merchant Shipping Act, 1894, that the Legislature of any British Possession may, by any Act or Ordinance, confirmed by His Majesty in Council, repeal wholly or in part any provisions of the said Act (other than those of the third part thereof which relate to emigrant ships) relating to ships registered in that Possession, but that any such Act or Ordinance shall not take effect until the approval of His Majesty has been proclaimed in the Possession, or until such time thereafter as may be fixed by the Act or Ordinance for the purpose.

And whereas it is among other things enacted by the Colonial Courts of Admiralty Act, 1890, that the Legislature of any British Possession may by any Colonial law—

(a) declare any court of unlimited civil jurisdiction, whether original or appellate, in that possession to be a Colonial Court of Admiralty, and provide for the exercise by such court of its jurisdiction under the said

Act, and limit territorially, or otherwise, the extent of such jurisdiction, and

(b) confer upon any inferior or subordinate court in that possession such partial or limited Admiralty jurisdiction under such regulations and with such appeal (if any) as may seem fit, subject to the proviso that any such Colonial law shall not confer any jurisdiction which is not by the said Act conferred upon a Colonial Court of Admiralty.

And whereas it is further enacted by the Colonial Courts of Admiralty Act, 1890, that every Colonial law which is made in pursuance of the said Act or affects the jurisdiction of or practice or procedure in any Court of such possession in respect of the jurisdiction conferred by the said Act, or alters any such Colonial law as above mentioned which has been previously passed, shall, unless previously approved by His Majesty through a Secretary of State, either be reserved for the signification of His Majesty's pleasure thereon, or contain a suspending clause providing that such law shall not come into operation until His Majesty's pleasure thereon has been publicly signified in the British Possession in which it has been passed.

And whereas by an Act passed in the Session held in the 15th and 16th years of the reign of Her Majesty Queen Victoria, entitled "An Act to grant a Representative Constitution to the Colony of New Zealand," it is, amongst other things, declared that no Bill which shall be reserved for the signification of His Majesty's pleasure thereon shall have any force or authority within the Colony of New Zealand until the Governor of the said Colony shall signify, either

by speech or message to the Legislative Council and House of Representatives of the said Colony, or by Proclamation, that such Bill has been laid before His Majesty in Council, and that His Majesty has been pleased to assent to the same.

And whereas by a Proclamation, dated the 10th day of September 1907, His late Majesty King Edward VII. was graciously pleased to change the style and designation of "the Colony of New Zealand" to "the Dominion of New Zealand."

And whereas a certain Bill (1912, No. 53) passed by the Legislative Council and House of Representatives of the said Dominion, entitled "An Act to amend the Shipping and Seamen Act, 1908." was presented to the Governor of the said Dominion for His Majesty's assent.

And whereas the said Bill was reserved by the said Governor for the signification of His Majesty's pleasure thereon.

And whereas the said Bill so reserved as aforesaid has been laid before His Majesty in Council, and it is expedient that the said Bill should be confirmed and assented to by His Majesty:

Now, therefore, His Majesty, in pursuance of the said Acts and in exercise of the powers thereby reserved to His Majesty as aforesaid, does by the present Order, by and with the advice of His Majesty's Privy Council, confirm and declare His Majesty's assent to the said Bill.

WHEREAS by the first section of the Colonial Probates Act, 1892, it is enacted as follows:—

"Her Majesty the Queen may, on being satisfied that the Legislature of any British possession has made adequate provision for the recognition in that possession of probates and letters af administration granted by the Courts of the United Kingdom, direct by Order in Council, that this Act shall, subject to any exceptions and modifications specified in the Order, apply to that possession and thereupon, while the Order is in force, this Act shall apply accordingly."

And whereas His Majesty is satisfied that the Legislatures of the British Possessions hereinafter mentioned have made adequate provision for the recognition in those Possessions of Probates and Letters of Administration granted by the Courts of the United Kingdom.

Now, therefore, His Majesty, by virtue and in exercise of the powers by the above-recited

Act in His Majesty vested, is pleased by and with the advice of His Most Honourable Privy Council to order, and it is hereby ordered, a follows:—

The Colonial Probates Act, 1892, shall apply to the British Possessions hereunder mentioned:

The Province of Alberta in the Dominion of Canada.

The Province of Saskatchewan, in the Dominion of Canada.

And the Right Honourable Lewis Harcourt, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

Order of the Department of Agricultum AND TECHNICAL INSTRUCTION FOR IRELAND. (DATED 11TH FEBRUARY 1913.)

THE IMPORTATION (SHEEP FROM SCOTLAND) ORDER OF 1912.

The Department of Agriculture and Techical Instruction for Ireland, by virtue and it exercise of the powers vested in them under the Agriculture and Technical Instruction (Ireland Act, 1899, the Diseases of Animals Acts, 189 to 1911, and of every other power enabling the in this behalf, do order, and it is hereby ordered as follows :-

Sheep from Scotland.

1. Sheep brought direct from a port in Sort Frederick Alexander Robertson, Esq., Indian | land to a port in Ireland specified in the First

Schedule to this Order, may be landed thereat subject to the conditions specified in this Order, and not otherwise.

Conditions of Importation.

- 2. The sheep if moved direct to the place of shipment from the farm or premises of their original owner shall be accompanied by—
 - (a) A statutory declaration made by the original owner that during the period o three months immediately preceding the date of the movement from his premises of the sheep to be imported into Ireland no case of foot-and-mouth disease, sheep scab, or other contagious disease of sheep existed on his premises.
 - (b) A certificate of a Veterinary Inspector of the Local Authority under the Diseases of Animals Acts of the district in which such premises are situate, given on the date of the movement of the sheep to the effect that on that date or on the day immediately preceding that date he had examined all the animals on the premises of the original owner of the sheep, and that no animal thereon was affected with or suspected of foot-and-mouth disease, sheep-scab, or other contagious disease to which sheep are liable.
- 3. If the sheep to be imported were purchased at a sale they shall be accompanied by the following certificate in addition to the declaration specified in Article 2 (a) of this Order:—
 - A certificate of a Veterinary Inspector of the Local Authority under the Diseases of Animals Acts for the district that all the animals exposed at the sale were inspected by him and found to be free from disease.
- 4. In the case of each consignment there must also be a declaration made at the port of shipment to Ireland by the Importer, or his authorised Agent, stating the place at which the sheep were purchased, and declaring that the sheep to be shipped are those to which the documents prescribed in Articles 2 and 3 of this Order relate.

Delivery of Documents.

5. The declarations and certificates required by this Order shall be delivered up to an Inspector of the Department at the port of landing.

Landing in Ireland.

- 6. (i.) On arrival at the port in Ireland the animals shall not be landed until they have been examined by a Veterinary Inspector of the Department and found to be free from disease.
- (ii.) The owner or master of the vessel in which the sheep are conveyed to Ireland shall afford all proper facilities for enabling the sheep to be examined on a part of the vessel that is fully open to daylight, and for securing the sheep for such examination.
- (iii.) No sheep shall be landed until the entire cargo of animals has been examined and found free from disease.

Movement from Port of Landing.

7. Before sheep landed under this Order are moved from the port of landing the owner or person in charge of such sheep shall on the

request of an officer of the Department furnish him with full particulars as to the destination of the animals.

Offences.

8. If an animal is landed or otherwise moved in contravention of this Order, the owner of the animal, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the animal, and the consignee or other person receiving or keeping it, knowing it to have been moved in contravention as foresaid, and the master of the vessel from which the animal is landed, and the occupier of the place from which the animal is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.

Interpretation.

- 9. In this Order—
- "The Department" means the Department of Agriculture and Technical Instruction for Ireland.
- "Animals" means cattle, sheep, goats, and
- swine.
 "Sale" includes a fair, market, or auction, and also an exhibition of animals.
- and also an exhibition of animals.
 "Person" includes any body of persons corporate or incorporate.
- corporate or incorporate.
 "Master" includes the person having the charge or command of a vessel.
- Other terms have the same meaning as in the Diseases of Animals Act, 1894.

Revocation of Orders.

10. The Orders described in the Second Schedule to this Order are hereby revoked from and after the commencement of this Order.

Commencement.

11. This Order shall come into operation on the seventeenth day of February nineteen hundred and thirteen.

Short Title.

12. This Order may be cited as the Importation (Sheep from Scotland) Order of 1912.
