- 3. Application for permission to attend the examination must be made in the writing of the candidate, at such times and in such manner as may be fixed by the Civil Service Commissioners.
- 4. A fee of £3 will be required from each candidate attending the examination.

The Civil Service Commissioners further give notice that an Open Competitive Examination for at least eight Second Class Clerkships in the National Health Insurance Commission (Wales) will be held at Cardiff and Wrexham, under the foregoing Regulations, commencing on the 20th May 1913.
