BURGH OF GRANGEMOUTH.

Mr. Alexander Stuart, Advocate, will hold a Public Inquiry at 11.30 a.m. on Tuesday the 6th May next, within the Council Chambers, Grangemouth, into the application of the Town Council of the Burgh of Grangemouth for Regulations under Section 9 of the Motor Car Act, 1903, restricting the speed of Motor Cars to Ten Miles an hour on portions of certain Highways in the Burgh of Grangemouth.

COUNTY OF RENFREW.

Local Government (Scotland) Acts.
