The King's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 30th day of April 1913, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an officer, seaman, or marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas by Order in Council of His late Majesty bearing date the eighteenth day of October 1909, sanction was given for certain Lieutenants of Your Majesty's Navy, employed in the various Departments of the Admiralty in London, to receive a uniform salary of £400 a year irrespective of seniority:

"And whereas we are of opinion that such salary is not now adequate in the case of Lieutenants of ten years' seniority and over:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the payment as from the first day of December 1912 of a uniform salary of £430 a year to the Lieutenants of

Your Majesty's Navy of ten years' seniority and over employed in any of the Departments of the Admiralty, with the exception of—

- (a) those employed in the Hydrographic Department, where the conditions are different, and
- (b) those promoted from Commissioned Warrant rank, who are serving under different regulations as regards pay and allowances:
- "The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."
