THIS day the Right Honourable John Poynder, Baron Islington, G.C.M.G., D.S.O., and the Right Honourable Sir Samuel Walker Griffith, G.C.M.G., Chief Justice of the High Court of the Commonwealth of Australia, having been appointed Members of His Majesty's Most Honourable Privy Council, were, by His Majesty's command, respectively sworn, and took their places at the Board accordingly.

WHEREAS the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a Representation that he has received a copy of an Interlocutor of the Sheriff-Substitute at Kirkwall, dated the 2nd November 1912, and made on a Petition of the Mainland District Committee of the County Council of the County of Orkney, finding that the Tankerness Churchyard, in the Parish of St. Andrews and the County of Orkney, is overcrowded and offensive or contrary to decency under Section 4 of the said Act:

And whereas in the said Representation it is recommended that the said Burial Ground should be closed in terms of the said Act, within twelve months of the date of the Closing Order, except for the burial of any person whose husband or wife has already been buried there. Provided always, as regards all interments in said Burial Ground after the date of the Closing Order, that the following conditions be observed: (1) that the exercise of the right of burial shall not be injurious to the public health or offensive or contrary to decency; (2) that notice shall be given to the Clerk to the Parish Council of St. Andrews on the day preceding that on which a grave is to be opened; (3) that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin.
