#### PRESENT,

The King's Most Excellent Majesty in Council.

WHEREAS by "The Burial Grounds (Scot-land) Act 1955 W land) Act, 1855," as amended by "The Secretary for Scotland Act, 1885," it is provided that it shall be lawful for His Majesty from time to time, by Order in Council, upon the Representation of the Secretary for Scotland that a copy of an Interlocutor of a Sheriff of a County of Scotland as in the said first-named Act provided has been received by him, in pursuance thereof to order that no new burial ground shall be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland, or (as the case may require) that after a time mentioned in the Order burials within certain limits, or in certain burial grounds or places of burial shall be discontinued wholly, or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council shall thereupon have like force and effect as if the same were embodied in the said first-named Act: provided always, that notice of such Representation and of the time it shall please His Majesty to order the same to be taken into consideration by the Privy Council, shall be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such burial ground is situated ; and that the same shall be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the church of, or on some other conspicuous places within, the parish affected by such Representation, one month before such Representation is so considered.

And whereas the Secretary for Scotland has made a Representation that he has received a copy of an Interlocutor of the Sheriff-Substitute of Lanarkshire at Glasgow, dated the 13th March 1913, and made on a Petition of John Laird and others, being persons assessed for the relief of the poor in the Parish of Shettleston, in the County of Lanark, finding that the Old Parish Churchyard in East Muir Street in the said Parish is in an offensive condition, and that its further use for interments would be contrary to decency (except as in the said Interlocutor mentioned) and that the use thereof for burial ought, with certain exceptions, to be discontinued.

And whereas in the said Representation it is recommended that the said Old Parish Churchyard should be closed as hereinafter directed.

And whereas by an Order in Council of the 7th day of May 1913, notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 16th day of June 1913, and that the said Order in Council or notice thereof should be published in the Edinburgh Gazette, and that copies of the said Order in Council or notice thereof should be fixed on the doors of the church of, or on some other conspicuous places within, the parish affected by such Representation one month before the said 16th day of June 1913.

And whereas notice of the said Representation and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette and has been fixed in the manner required by the said Order in Council.

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, as it is hereby ordered, as follows, viz. :---

That the Old Parish Churchyard in East Muir Street in the Parish of Shettleston, in the County of Lanark, be forthwith closed as a place of sepulture in terms of the said Act, except for the interment therein of the cremated bodies of Thomas Marshall, of 817 Tollcross Road, Glasgow, and Mrs. Watt, of 524 Tollcross Road, Glasgow, unless to such an extent as may upon application be specially authorised by the Corporation of the City of Glasgow under such conditions and restrictions as may appear to them to be necessary in the public interest.

#### CIVIL SERVICE COMMISSION, June 27, 1913.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of His Majesty's Treasury, viz. :--

SPECIAL REGULATIONS RESPECTING OPEN CON-PETITIVE EXAMINATIONS FOR THE SITUATION OF SECOND CLASS CLERES IN THE DUELE METROPOLITAN POLICE COURTS.

## N.B.—These Regulations are liable to alteration from time to time.

I. The limits of age for this situation are 17 and 25, and candidates must be of the prescribed age on the first day of the examination.

In reckoning age for competition the following allowances will be made, viz. :---

(i.) Persons who have served in the Army or Navy may deduct from their actual age any time during which they have served;

(ii.) Persons who may be serving or who may have served in the Militia, the Imperial Yeomanry, the Honourable Artillery Company, or the Volunteers may deduct from their actual age any time spent on actual military service, such time being reckoned by the number of days for which they received Army pay;

(iii.) Persons who have served for two full consecutive years-

(A) In any Civil situation to which they were admitted with the Certificate of the Civil Service Commissioners,

(B) In the Royal Irish Constabulary, or

(C) As Registered Boy Clerks in connection with the Civil Service (if appointed on the results of the competition of September 22nd, 1908, or any previous competition) may deduct from their actual age any time not exceeding five years which they may have spent in such service.

II. The examination will be in the following subjects, viz. :---

#### Obligatory :---

- 1. Reading aloud.
- 2. Handwriting.
- 3. Orthography.
- 4. Arithmetic (including Vulgar and Decimal Fractions).
- 5. English Composition.
- 6. Proceedings before Magistrates.
- 7. Law of Evidence.

#### Optional :---

- 8. Copying imperfect manuscripts.
- 9. Indexing or Docketing.
- 10. Digesting Returns, &c., into Summaries.
- 11. Bookkeeping by Single Entry.
- 12. Any one of the following, viz. :--
  - a. Latin (translation from).
  - b. French (translation from).
  - c. German (translation from).
  - d. Geography and English History.

III. The examinations are open to all naturalborn or naturalised British subjects being of the requisite age, health, and character, with the following restrictions :---

(i.) The following persons are ineligible, viz. :--

Members of the Royal Irish Constabulary of less than five years' service.

(ii.) The following classes of persons are eligible under certain conditions only, that is to say :-- (a) Persons actually serving in the Army.

(b) Persons actually serving in the Navy.

(c) Persons holding situations in the Civil Service.

(d) Members of the Royal Irish Constabulary of more than five years' service.

(e) Apprentices in His Majesty's Dockyards.

(f) Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchequer.

No person actually serving in the Army will be eligible unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued by or under the authority of the Army Council.

No person actually serving in the Navy will be eligible unless he 1 roduces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued by or under the authority of the Lords Commissioners of the Admiralty.

Persons comprised in the classes (c), (d), (e) must obtain the permission of the authorities of their department to attend the examination before the commencement of the competition.

Persons comprised in class (f) will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

IV. Application for permission to attend an examination must be made at such time and in such manner as the Civil Service Commissioners may appoint.

V. A fee of  $\pounds 2$  will be required from each candidate attending an examination.

#### MOTOR CARS.

THE MOTOR CARS REGULATION (COUNTY OF FIFE) (KIRKCALDY DISTRICT) ORDER, 1913, dated 6th June 1913.

In pursuance of the powers vested in me by Section 9, as read with Section 18 of the Motor Car Act, 1903, I, the Right Honourable Thomas M'Kinnon Wood, His Majesty's Secretary for Scotland, on the application of the County Council of the County of Fife, being the local authority of the said County, do hereby make the following regulations :---

- This Order may be cited as "The Motor Cars Regulation (County of Fife) (Kirkcaldy District) Order, 1913," and the Regulations hereby prescribed shall take effect within the limits or places referred to therein on and after the respective dates at which, for the purpose of giving effect thereto, the local authority shall, in terms of Section 10 of the Motor Car Act, 1903, place notices in conspicuous places on or near such limits or places.
- 2. A person shall not drive a motor car at a speed exceeding ten miles per hour within the limits or places specified in the Schedule to this Order.

#### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :---

#### Importation.

1.—(1) The date on which Chapter L (Importation) of the Horses (Importation and Transit) Order of 1912 (hereinafter referred to as the principal Order) shall come into operation is hereby further altered to the first day of October nineteen hundred and thirteen.

(2) The first day of October nineteen hundred and thirteen shall be substituted for the first day of January nineteen hundred and thirteen in the Schedule to the principal Order (Orders Revoked).

#### Food and Water.

2. The provisions of paragraph (ix.) (Food and Water) of Article 13 of the principal Order shall not, until the first day of August nineteen hundred and thirteen, apply to a vessel on which horses, asses, or mules are carried to any port in Great Britain or from any such port to any port in the British Islands.
