Motor Cars.

THE MOTOR CARS REGULATION (BURGH OF GRANGEMOUTH) ORDER, 1913, dated 1st August 1913.

In pursuance of the powers vested in me by Section 9, as read with Section 18 of the Motor Car Act, 1903, I, the Right Honourable Thomas M'Kinnon Wood, His Majesty's Secretary for Scotland, on the application of the Town Council of the Burgh of Grangemouth, being the local authority of the said Burgh, do hereby make the following regulations:—

- 1. This Order may be cited as "The Motor Cars Regulation (Burgh of Grangemouth) Order, 1913," and the Regulations hereby prescribed shall take effect within the limits or places referred to therein on and after the respective dates at which, for the purpose of giving effect thereto, the local authority shall, in terms of Section 10 of the Motor Car Act, 1903, place notices in conspicuous places on or near such limits or places.
- 2. A person shall not drive a motor car at a speed exceeding ten miles per hour within the limits or places specified in the Schedule to this Order.

SCHEDULE.

Limits or Places.

(1) Dalgrain Road, from a point 50 yards west of the entrance to the Engineering Works at Carron Old Wharf, along North and South Bridge Streets, Station Road, and Bo'ness Road to a point 50 yards east of Park Road.

(2) Earls Road, from its junction with Bo'ness

Road to a point 100 yards south-west of the junction.

(3) Lumley Street, from its junction with Bo'ness Road to a point 100 yards south of the junction.

LOCAL GOVERNMENT (SCOTLAND) ACTS.

COUNTY COUNCIL ELECTORAL DIVISIONS OF ARGYLL.

WHEREAS the Secretary for Scotland under the provisions of the Local Government (Scotland) Act, 1889, determined the number of Councillors to be elected for the County of Argyll to be 57, and by their Order dated 3rd November 1891, the Boundary Commissioners for Scotland divided the said County of Argyll into certain Electoral Divisions, including the Electoral Division of Ballachulish:

AND WHEREAS the County Council of the County of Argyll have represented to me that it is desirable to divide the area comprised by the said Electoral Division of Ballachulish into two Electoral Divisions, and accordingly to alter the number of County Councillors:

AND WHEREAS I am of opinion that it is expedient to give effect to the proposal of the said County Council:

Now THEREFORE I, the Right Honourable Thomas M'Kinnon Wood, His Majesty's Secretary for Scotland do, in virtue of the powers conferred on me by Section 51 of the Local Government (Scotland) Act, 1889, order as follows:

1. The number of County Councillors for the County of Argyll shall be increased from 57 to 58.

2. The Ballachulish Electoral Division, as defied by the said Order of the Boundary Commissioners for Scotland, dated 3rd November 1891, from and after this date shall be divided into two County Council Electoral Divisions, having the following names and contents, that is to say:—

Names and Numbers of Electoral Divisions.	Contents of Electoral Divisions.
1. Kinlochleven (No. 12)	That part of the Parish of Lismore and Appin including the Village and District of Kinlochleven which lies to the north of the following line, viz., a line drawn in a south-easterly direction from the mouth of the stream which flows down Gleann-a-chaolais and enters Loch Leven at Caolas-na-Con, up the course of the said stream to a point situated at a distance of one mile due south of the mouth of the stream entering Loch Leven at Camus-na-muie, thence in a straight line in an easterly direction till it strikes the boundary between the Parish and Perthshire at a point marked on the Ordnance Survey Map as being 1592 feet above sea level, thence along the said boundary until it meets the boundary with Inverness-shire at the western end of Lochan-a-chlaidheimh.
2. Ballachulish (No. 12A)	The remainder of the Parish of Lismore and Appin exclusive of the portion included within the Electoral Division of Lismore and Appin.

COAL MINES ACT, 1911.

In pursuance of Part I. of the Second Schedule to the Coal Mines Act, 1911, notice is hereby given that the Secretary of State for the Home Department proposes to make general regulations under the Coal Mines Act, 1911, to apply to all mines under that Act in which ganister is worked. The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of His Majesty's Treasury, viz. :-

SPECIAL REGULATIONS RESPECTING AN OPEN COMPETITIVE EXAMINATION FOR SITUATIONS AS ASSISTANT CLERK (ABSTRACTOR CLASS) IN DEPARTMENTS OF THE CIVIL SERVICE.

(Supplementary to the General Regulations respecting Open Competitive Examinations for Situations in the Civil Service, included in Schedule A of the Order in Council of 10th January 1910.)

- 1. The limits of age for this Examination are 17 and 18, and Candidates must be of the prescribed age on the 1st November 1913. No extension of age is allowed on account of previous public service.
- 2. The Examination will be in the following subjects:-
 - 1. English Composition (including Handwriting and Spelling).
 - 2. Arithmetic.
 - 3. Digesting Returns into Summaries.
 - 4. Précis and Indexing.
 - 5. Book-keeping or Shorthand.

Candidates who fail to obtain such an aggregate of marks as may indicate in the judgment of the Civil Service Commissioners a competent amount of general proficiency will not be regarded as qualified.

- 3. Application for permission to attend the Examination must be made at such time and in such manner as the Commissioners may appoint.
- 4. It will rest with the Civil Service Commissioners to determine the Departments to which the successful Candidates shall be assigned.
- 5. A fee of 10s. will be required from every Candidate attending the Examination.

The Civil Service Commissioners further give notice that an Open Competitive Examination for situations as Assistant Clerk (Abstractor Class) in Departments in the Civil Service will be held in London, under the fore-Insurance Act, 1911, and by the National Insurgoing Regulations, commencing on the 23rd ance (Joint Committee) Regulations, 1912, to October 1913. Not fewer than 20 candidates will be declared successful on the result of this Examination, if so many should be found qualified.
