WHEREAS the Lords of the Committee of the Privy Council on Education in Scotland, by virtue and in pursuance of the powers in them vested under Section 14 of the Education (Scotland) Act, 1908, and of every other power enabling them in that behalf, have made a Scheme amending the Superannuation Scheme for Teachers in Scotland, dated the 1st day of November 1911, and approved by His Majesty in Council on the 14th day of May 1912:

And whereas the provisions of the said Act have been complied with and the said amending Scheme has been laid before both Houses of Parliament in accordance with the directions contained in the said Act:

And whereas neither House of Parliament has presented an Address praying His Majesty to withhold His consent from the said amending Scheme or any part thereof:

Now, therefore, His Majesty, having taken the said amending Scheme (a copy whereof is hereunto annexed) into consideration, is pleased, by and with the advice of His Privy Council, to approve the same, and to order, as it is hereby ordered, that the said amending Scheme do take effect as from the 1st day of April 1913.

EDUCATION (SCOTLAND) ACT, 1908, SECTION 14.

Amendment of the Superannuation Scheme for Teachers.

Whereas by section 14, subsection (4) of the Education (Scotland) Act, 1908, it is enacted that the Scotch Education Department (hereinafter called "the Department") shall prepare

a superannuation scheme applicable to such teachers as shall be prescribed therein, and by subsections (10), (11), and (12) of the said section certain procedure is prescribed with a view to the making of a scheme; and whereas by subsection (13) of the said section it is enacted that a scheme under the said section of the said recited Act may be amended by a subsequent scheme under the like procedure; and whereas by subsection (8) of the said section it is enacted that "the Department and the Managers of "any superannuation fund applicable to teachers "established under any Act or any Provisional "Order confirmed by Act of Parliament may, "notwithstanding the provisions of any such "Act or Order, agree for the carrying on or the "discontinuance, in whole or in part, and subject "to such financial or other adjustment as may "seem necessary, of such superannuation fund, " and for altering, varying, amending, or limiting "the terms, conditions, regulations, and provi-"sions thereof, and any such agreement shall form "part of the scheme or of an amendment thereof" and whereas on the first day of November 1911, the Department, in the exercise of the powers conferred upon them as aforesaid, and after due observance of the prescribed procedure, made a scheme for the superannuation of teachers (hereinafter called "the National Scheme"); and whereas the Department in virtue of subsection (8) of section 14 of the said Act have entered into a minute of agreement dated 26th and 27th September and 4th October 1912, with the Merchant Company Education Board, incorporated by the Order confirmed by the Edinburgh Merchant Company Endowments Order Confirmation Act, 1909 (hereinafter called "the Education Board"), in relation to the Merchant Company Schools Superannuation Fund (hereinafter called "the Merchant Company Fund"); and whereas a draft amending scheme giving effect to the said Minute of Agreement has been printed and published in terms of subsections 10 and 13 of section 14 of the said Act of 1908, and whereas certain amendments have been proposed thereon and have been considered by the Department in virtue of the powers conferred on them by subsections 11 and 13 of section 14 of the said Act of 1908; now therefore, the Department do amend the National Scheme by adding to it the following provisions, that is to say :-

First.—The Merchant Company Fund shall continue to be held, managed, and administered by the Education Board.

Second.—In respect that the Education Board and the teachers in their employment eligible for admission to the National Scheme, other than those teachers who have entered the service subsequent to 1st April 1912, have contributed, or will contribute, to the Merchant Company Fund instead of to the Scottish Teachers' Superannuation Fund (hereinafter called the National Fund) for the year mentioned in this Article, the Education Board shall transfer from the Merchant Company Fund and pay to the National Fund a sum equal to six per centum of the salary for the year from 1st April 1912 to 1st April 1913 of every teacher in the service of the Education Board contributing to the Merchant Company Fund and eligible for the National Scheme, but under deduction l always of a sum equal to the amount of contributions paid by any teachers during the said year who have left the service of the Education Board or have died, and whose contributions have been repaid to them or their representatives.

Third.—The Education Board shall transfer from the Merchant Company Fund and pay to the General Funds of their Endowment a sum equal to the difference between the amount paid to the National Fund under the preceding Article and, under deductions as in the immediately preceding Article, the total contributions paid or to be paid by the Education Board and the teachers into the Merchant Company Fund in respect of the year from 1st April 1912

to 1st April 1913.

Fourth.—In respect that the Education Board have paid or will pay to persons who may be entitled to retiring allowances under Article 21 of the National Scheme, certain superannuation allowances from the Merchant Company Fund and certain retiring allowances from the General Funds of their Endowment in supplement of such superannuation allowances, both for the year from 1st April 1912 to 1st April 1913, the Department shall pay to the Education Board a sum equal to the amount of the relief to which they may be entitled under said Article of the National Scheme, on account of such superannuation and retiring allowances paid by them, and shall also pay to such persons the balance, if any, due to them respectively of the amount of the retiring allowance to which they may be entitled under the National Scheme.

Fifth.—The existing Regulations of the Merchant Company Fund made by the Education Board on 27th January and approved by the Department on 12th March, both in the year 1910, shall, subject to the provisions of this Scheme, remain unaltered in so far as these concern (a) persons on the Roll of annuitants of the Fund at 1st April 1912 who are not admitted to the benefits of the National Scheme; (b) teachers and other employees in the schools of the Education Board not eligible for the National Scheme, and officers and other employees in connection with the administration of the endowments of the Education Board; and (c) persons entitled to special superannuation allowances under section 57 of the said Order of 1909, being certain teachers or former teachers in James Gillespie's School.

Sixth.—No teacher to whom the National Scheme is applicable and who has entered or who shall enter the service of the Education Board after 1st April 1912, shall be eligible to become a contributor to the Merchant Company Fund.

Seventh.—All teachers in the service of the Education Board at 1st April 1912, to whom the National Scheme is applicable, and who have been contributors to the Merchant Company Fund, shall from that date be held, in respect of the transference and payment under Articles second and third thereof, to have ceased to contribute to that Fund, and shall make no further contributions thereto. Similarly, in respect



to such teachers, the Education Board shall be held to have ceased from the last-mentioned date to make grants or contributions to the said Fund and shall make no further contributions thereto.

Eighth .- The Education Board shall within six months from the date on which this Scheme shall come into operation, repay to all teachers referred to in the immediately preceding Article who as at 1st April 1912 had been in their service for less than five years, their (the teachers') contributions to the Merchant Company Fund with the addition of three per cent. compound interest. On this payment being made such teachers shall cease to have any interest whatever in the said Fund.

Ninth.—The Education Board shall grant a superannuation allowance applicable to the period of contribution prior to 1st April 1912, from the Merchant Company Fund to every teacher referred to in Article seventh hereof, not paid out under Article eighth hereof, who shall complete the age of 65 in the case of males and 60 in the case of females in the service of the Education Board. The scale of superannuation allowances shall be fixed by the Education Board in accordance with a scale to be prepared by the Actuary of the Board as aftermentioned. Such superannuation allowance shall supersede and be in lieu of the superannuation allowance provided by the said Order of 1909, and the said Regulations of 1910.

Tenth.—A valuation of the assets and liabilities of the Merchant Company Fund shall be made as at 1st April 1912 by an Actuary appointed by the Education Board. In the valuation, the Actuary shall, subject to the provisions of this scheme, divide the Fund into two portions—the one portion being applicable to the teachers referred to in Article ninth hereof entitled to deferred superannuation allowances, and the other portion applicable to the annuitants and others referred to in Article fifth hereof whose interests in the fund remain unaltered by these presents. The said division shall take place only for the purpose of ascertaining the interests in the said Fund as at 1st April 1912 of the teachers referred to in Article ninth hereof entitled to deferred superannuation allowances, and notwithstanding such division the said fund shall continue as hitherto to be held, managed, and administered as one Fund.

Eleventh.—On completing the foresaid Valuation and Scheme of Apportionment, the Actuary shall immediately thereafter prepare a scale of deferred superannuation allowances for the teachers entitled to the same under Article ninth hereof. The deferred super-annuation allowances shall be based upon the theoretical individual reserves of the portion of the Merchant Company Fund applicable to the teachers referred to in Article ninth hereof, but shall be modified as may be necessary to give a regular and equitable result.

Twel/th.-A copy of this Scheme and of the Valuation, Scheme of Apportionment, and proposed scale of deferred superannuation allowances shall be posted by the Secretary

of the Education Board to every person who is or has been a contributor to the Merchant Company Fund, and who shall at that time have an interest in the said Fund. Within four weeks of the date of such posting any such person may lodge with the Secretary of the Education Board objections in writing to the Valuation, the Scheme of Apportionment, or the scale of deferred superannuation allowances. The Education Board shall consider any objections so lodged, and if there be a majority of the persons referred to in Article ninth hereof or a majority of the persons in Class (b) of Article fifth hereof unfavourable to the said Valuation, Scheme of Apportionment, or scale of deferred superannuation allowances, the points in dispute shall be referred to the President of the Faculty of Actuaries in Edinburgh, whose decision shall be final and binding upon all concerned.

Thirteenth. — The Education Board shall transfer from the Merchant Company Fund and pay to the General Funds of their Endowment a sum equal to one half of the amount of the relief which may be afforded to the Education Board, in each year, under the provisions of Article 21 of the National Scheme; such moiety to be transferred and paid in respect of the contribution by the Education Board and their predecessors from the General Funds of their Endowments to the Merchant Company Fund. The remaining one half of the relief shall be paid to the annuitants in respect of their contributions to that Fund; in proportion to the respective amounts of their annuities therefrom.

Fourteenth.—The Regulations of the Merchant Company Fund shall be altered by the Education Board, with the approval of the Department, so as to give effect to the provisions of this Scheme.

Lastly.-Notwithstanding this Scheme, the section of the said Order of 1909, the marginal note of which is "Provision for "deficiency in Superannuation Fund," subsection (d) of the section of the said Order, the marginal note of which is "Reserve funds," and the section of the said Order the marginal note of which is "Education Board to make Regulations," shall remain in full force and effect and be applicable to the Merchant Company Fund as altered by this Scheme, in the same way as these applied to the said Fund before such alteration was made.

And whereas, further, it is expedient, by reason of the foregoing provisions and for other reasons, to amend certain Articles of the National Scheme, it is hereby provided as follows, that is to sav :-

(1) Article 1.—" The Date of Commencement." The words "except in the case of teachers "who at such date are contributors to any " superannuation fund applicable to teachers, "established under any Act or any Provi-"sional Order confirmed by Act of Parlia-"ment as provided for in subsection 8 of "section 14 of the Education (Scotland) "Act, 1908. In the case of such teachers "' the date of commencement' shall be the "date one year later than the date on which

- (2) Article 7.—Shall be read as if it were in the following words, viz. :-
  - (a) The "prescribed proportion" mentioned in subsection 5 (a) of section 14 of the Education (Scotland) Act, 1908, shall be one-sixtieth of the pensionable salary of the teacher; and the "prescribed reduction" shall be two-fifths of the "prescribed proportion." The "prescribed age" shall be the age of 65, save as hereinafter provided.

(b) The pensionable salary of the teacher in respect of service after the date of commencement shall be the average annual salary throughout the said service.

The pensionable salary of the teacher in respect of service before the date of commencement shall be the average annual salary for the last five years of service preceding the date of retirement.

- (3) Article 9.—The words "annual average salary" shall be read as "average annual salary."
- (4) Article 13.—The words "for the last five years preceding the date of his retirement" shall be read as "for the last five years of service preceding the date of his retirement.

#### WHITEHALL, August 8, 1913.

His Majesty the King has been graciously pleased to award the Edward Medal of the 2nd Class to Thomas Aitken under the following circumstances :-

On the 3rd of October 1912, Mr. George Lowthian, Consulting Engineer to the Tilehurst, Pangbourne and District Water Company Limited, descended a well at the pumping station at Tilehurst to examine a set of pumps while they were working, accompanied by Aitken, the foreman. The engineer was standing on a staging, nearly in the centre of the well, about 80 feet below the surface, when a plank suddenly broke, and he fell about 34 feet. He crashed through an old pump staging, shattering his left foot and ankle, but managed to get hold of an iron bar about 4 feet below the old staging and 6 feet above water. Aitken, who had almost crossed the plank when it broke, caught hold of a beam and crawled round the pump to a ladder. He was in darkness, for the light had fallen with the engineer, but he groped his way down the slippery ladder to the second staging. He obtained a light, and found the engineer clinging to the girder below the staging. He reached him, and, with great difficulty, as the engineer weighed 14

succeeded in dragging him to the top of the girder and thence to a place of safety on a ledge of brickwork. Then, ascending to the surface, he arranged for tackle to be let down into the well, and, going down again, managed to bring the man safely to the top. The engineer's strength was nearly exhausted when Aitken reached him, and he undoubtedly owes his life to Aitken's prompt and courageous action in going to his rescue at great risk to his own life.

Also to Allan Murdoch under the following circumstances:—

On the 10th of May the barge "Arctic," belonging to the Liverpool Grain Storage and Transit Company, was taken alongside the s.s. "Monarch," in the Harrington Dock, Liverpool, to transfer some damaged corn from the ship to the barge. On the 12th of May the captain of the barge and mate went on board and removed several of the hatch covers to put in more grain. The mate, noticing a dead rat lying in the hatch, went down, but collapsed on reaching the bottom. Murdoch, seeing that something was wrong through the conduct of the captain, who ran up and down the deck calling for help, rushed on board and descended the hold, accompanied by William Brown, the mate of another vessel. On reaching the bottom of the ladder, 12 feet long, both Brown and Murdoch were affected by the gas. Murdoch climbed out again, but Brown, in spite of his endeavours, failed to do so. In the meantime other men had arrived on board the boat, and Murdoch, with a life line attached to him, went down again into the hatch. He succeeded in bringing out the mate (Weedell), who was six feet away from the bottom of the ladder. He went down a second time, and managed to attach the rope to Brown, but then himself collapsed, and the two men were drawn out together. Weedell's life was saved, but Brown unfortunately succumbed to the effects of the gas. It is clear that Murdoch ran a very serious risk to his own life in descending twice into the hold, after being overcome by the gas in his first descent, and that his gallant action in all probabilily saved the mate from death.
