BY THE KING.

A PROCLAMATION

EXTENDING TO THE WAR WITH TURKEY THE PROCLAMATIONS AND ORDERS IN COUNCIL NOW IN FORCE RELATING TO THE WAR.

GEORGE R.I.

WHEREAS, owing to hostile acts committed by Turkish forces under German officers, a state of war now exists between Us and the Sultan of Turkey;

AND WHEREAS on the 4th day of August 1914, a state of war came into existence between Us and the German Emperor;

AND WHEREAS We did on the same date and on certain other dates subsequent thereto issue certain Proclamations and Orders in Council connected with such state of war;

AND WHEREAS on the 12th day of August 1914, a state of war came into existence between Us and the Emperor of Austria, King of Hungary;

AND WHEREAS certain of the aforesaid Proclamations and Orders in Council have since been extended so as to cover the state of war between Us and the Emperor of Austria, King of Hungary;

AND WHEREAS it is desirable now to provide for the state of war between Us and the Sultan of Turkey;

AND WHEREAS the Convention relating to the status of enemy merchant vessels at the outbreak of hostilities, signed at The Hague on the 18th October 1907, has not been ratified by the Sultan of Turkey, and therefore We do not think fit to extend to Turkish ships the Order in Council issued on the 4th day of August 1914, with reference to the departure from Our ports of enemy vessels, which at the outbreak of hostitilies were in any such port or which subsequently entered the same:

Now, THEREFORE, We have thought fit, by and with the advice of Our Privy Council, to issue this Our Royal Proclamation declaring, and it is hereby declared, as follows:—

1. The Proclamations and Orders in Council issued with reference to the state of war between Us and the German Emperor, or with reference to the state of war between Us and the German Emperor and the Emperor of Austria, King of Hungary, other than the Order in Council issued on the 4th day of August 1914, with reference to the departure from Our ports of enemy vessels, which at the outbreak of hostilities were in any such port, or which subsequently entered the same, shall, if still in force, apply to the state of war between Us and the Sultan of Turkey as from this 5th day of November 1914.

- 2. The Proclamation issued on the 5th day of August 1914, warning all Our subjects, and all persons resident or being in Our Dominions, from contributing to or participating in, or assisting in the floating of, any loan raised on behalf of the German Government, or from advancing money to or entering into any contract or dealings whatsoever with the said Government, or otherwise aiding, abetting, or assisting the said Government, shall be deemed as from this 5th day of November 1914, to apply to all loans raised on behalf of, or contracts or dealings entered into with, or to aiding, abetting, or assisting the Ottoman Government.
- 3. The words "enemy country" in any of the Proclamations or Orders in Council referred to in Article 1 of this Proclamation shall include the Dominions of His Imperial Majesty the Sultan of Turkey other than Egypt, Cyprus, and any territory in the occupation of Us or Our allies.

Given at Our Court at Buckingham Palace, this Fifth day of November, in the year of our Lord one thousand nine hundred and fourteen, and in the Fifth year of Our Reign.

GOD SAVE THE KING.

At the Court at Buckingham Palace, the 5th day of November 1914.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS, by virtue of the Convention of Defensive Alliance between Her Majesty Queen Victoria and His Imperial Majesty the Sultan, signed on June the 4th, 1878, the Annex to the said Convention signed on July the 1st, 1878, and the Agreement signed on behalf of Her Majesty and His Imperial Majesty the Sultan on August the 14th, 1878, His Imperial Majesty the Sultan assigned the Island of Cyprus to be occupied and administered by England upon the terms and conditions specified in the said Convention, Annex, and Agreement.

AND WHEREAS by reason of the outbreak of war between His Majesty and His Imperial Majesty the Sultan the said Convention, Annex, and Agreement have become annulled and are no longer of any force or effect.

AND WHEREAS it has, for the reasons hereinbefore appearing, seemed expedient to His Majesty that the said Island should be annexed to and should form part of His Majesty's Dominions, in order that proper provision may be made for the Government and protection of the said Island.

Now, THEREFORE, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

(1) From and after the date hereof the said Island shall be annexed to and form part of His Majesty's Dominions, and the said Island is annexed accordingly.

(2) Nothing in this Order shall affect the validity of any Instructions issued by His cil, 1889, Majesty under the Royal Sign Manual and shall not-

Signet to the High Commissioner and Commander-in-Chief of Cyprus, or of any Order in Council affecting Cyprus, or of any Law or Proclamation passed or issued under any such Instructions or Order, or of any act or thing done under any such Instructions, Order, Law or Proclamation, save in so far as any provision of any such Order in Council, Law or Proclamation may be repugnant to the provisions of any Act of Parliament which may, by reason of the annexation hereby declared, become extended to Cyprus, or to any Order or Regulation made under the authority of any such Act or having in Cyprus the force and effect of any such Act.

(3) His Majesty may from time to time revoke, alter, add to or amend this Order.

(4) This Order may be cited as the Cyprus (Annexation) Order in Council, 1914.

And the Right Honourable Lewis Harcourt, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

WHEREAS by treaty, grant, usage, sufferance, or other lawful means, His Majesty the King has power and jurisdiction in Morocco:

Now, therefore, His Majesty, by virtue and in exercise of the powers in this behalf by the Foreign Jurisdiction Act, 1890, or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

- 1.—(1) Where any Regulations relating to sanitary or police matters, or to public health, or to the control of any port, or for any similar purpose, are issued by the authorities in charge of any town or district in Morocco, and such Regulations are binding on the Moorish inhabitants of such town or district, and are, so far as they affect British subjects or Britishprotected persons, approved by the Secretary of State, the Court for Morocco may, subject and according to the provisions of this Order, entertain any complaint made against a British subject or British-protected person for a breach of such Regulations, and may enforce payment of any fine incurred by that subject or person in respect of that breach, in like manner, as nearly as may be, as if that breach were by this Order declared to be an offence against this Order.
- (2) In any such case the fine recovered shall, notwithstanding anything in this Order, be disposed of and applied in manner provided by such Regulations.

2. Article 109 of the Morocco Order in Council, 1889, is hereby repealed, but such appeal

- (a) Affect the past operation of such article or any right, title, obligation, or liability thereunder; or
- (b) Interfere with the institution or prosecution of any legal proceedings thereunder.
- 3. This Order shall be cited as "The Morocco Order in Council, 1914," and shall be read as one with the Morocco Order in Council, 1889.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the

Admiralty, dated the 20th day of October, 1914, in the words following, viz.:—

- "Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:
- "And whereas we consider it desirable that Separation Allowances should be paid during the period of the present War to the wives and in respect of the children of Seamen, Marines, and Reservists borne on the books of Your Majesty's Ships, and to other persons who are in fact dependent upon them:
- "We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction payment of such allowances at rates not exceeding those set forth in the following Schedule, to take effect from the 1st day of October 1914.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.

TRADE BOARDS ACT, 1909.

In accordance with Regulations made under Section 18 of the above Act, by the Board of Trade, and dated 27th April 1910, the Trade Board established under the above Act for certain branches of the Machine-made Lace and Net Finishing Trade, as defined in the Regulations made by the Board of Trade, and dated 16th March 1914, have given notice, as required by Section 4 (3) of the above Act, that they have fixed the following Minimum or Lowest Rates of wages:—

 For the finishing of those Hair Nets, Veilings, and Quillings, which are the product of Plain Net Machines, 2³/₄d. per hour clear of all deductions.*

The above rate applies to workers other than learners. For learners (as defined by the Trade Board) certain lower minimum time rates have been fixed.

 Similar notice has also been given that the Trade Board have fixed General Minimum Piece-Rates for the finishing of Hair Nets (whether they are the product of Plain Net Machines or not), as follows:—

When threading and carding are done at the same time the rate shall be the sum of the respective rates specified above.

In totalling up any weekly reckoning in the aggregate so arrived at, the reckoning shall be to the nearest farthing.

All Piece-Rates are to be paid clear of all deductions.*

On application to the Trade Board, further information will (if in the opinion of the Trade Board the applicant is likely to be affected) begiven as to the minimum rates fixed.

### DISEASES OF ANIMALS ACTS, 1894 to 1911.
