### CENTRAL CHANCERY OF THE ORDERS OF KNIGHTHOOD.

LORD CHAMBERLAIN'S OFFICE,  
 ST. JAMES'S PALACE,

April 10, 1915.

The KING has been graciously pleased to give orders for the following appointment to the Most Honourable Order of the Bath, in recognition of the services of the undermentioned Officer during the chase of the German Cruisers "Goeben" and "Breslau" by H.M.S. "Gloucester" on 6th and 7th August 1914 :—

*To be an Additional Member of the Military Division of the Third Class or Companions.*

Captain William Archibald Howard Kelly,  
 Royal Navy.

The report of the "Gloucester" shows that the "Goeben" could have caught and sunk her at any time had she dared to turn upon her. The "Goeben" was apparently deterred by the "Gloucester's" boldness, which gave the impression of support close at hand. The combination of audacity with restraint, unswerving attention to the principal military object, namely, holding on to the "Goeben" without tempting her too much, and strict conformity to orders, constitute a naval episode which may justly be regarded as a model.

ADMIRALTY, April 10, 1915.

The KING has been graciously pleased to approve of the grant of the Victoria Cross to Commander Henry Peel Ritchie, Royal Navy, for the conspicuous act of bravery specified below :—

For most conspicuous bravery on the 28th November 1914, when in command of the searching and demolition operations at Dar-es-Salaam, East Africa. Though severely wounded several times, his fortitude and resolution enabled him to continue to do his duty, inspiring all by his example, until at his eighth wound he became unconscious. The interval between his first and last severe wound was between twenty and twenty-five minutes.

The KING has been graciously pleased to give orders for the following appointments to the Distinguished Service Order, and for the award of the Distinguished Service Cross to the undermentioned Officers in recognition of their services as mentioned :—

*To be Companions of the Distinguished Service Order.*

For services during the operations in the Shatt-el-Arab, 3rd to 9th December 1914, resulting in the capture of Qurnah—

Commander (now Captain) Wilfrid Nunn,  
Royal Navy.

Commander Nunn displayed great coolness and skill in handling his ship under fire in difficult conditions of unsurveyed waters.

For services rendered in the aerial attack on Dunkirk, 23rd January 1915—

Squadron Commander Richard Bell Davies.  
Flight Lieutenant Richard Edmund Charles Peirse.

These Officers have repeatedly attacked the German submarine station at Ostend and Zeebrugge, being subjected on each occasion to heavy and accurate fire, their machines being frequently hit. In particular, on 23rd January, they each discharged eight bombs in an attack upon submarines alongside the mole at Zeebrugge, flying down to close range. At the outset of this flight Lieutenant Davies was severely wounded by a bullet in the thigh, but nevertheless he accomplished his task, handling his machine for an hour with great skill in spite of pain and loss of blood.

For services in command of Torpedo Boat O43 during the operations on the Suez Canal, 3rd February 1915—

Lieutenant-Commander George Bryan Palmes,  
Royal Navy.

Lieutenant-Commander Palmes disabled a number of the enemy's boats intended to be used for crossing the Canal, and showed coolness and bravery under fire. He was severely wounded.

*To receive the Distinguished Service Cross.*

For services in the action between H.M.S. "Carmania" and the German Armed Merchant Cruiser "Cap Trafalgar," on 14th September 1914, when the latter vessel was sunk—

Chief Gunner Henry Middleton.  
Acting Sub-Lieutenant George Frederick Dickens, R.N.R.  
Midshipman (now Acting Sub-Lieutenant) Douglas Nowell Colson, R.N.R.

For services during the operations at Dar-es-Salaam, on the 28th November 1914, when boats' parties from H.M.S. "Fox" and "Goliath" were attacked unexpectedly at the harbour entrance—

Lieutenant Eric Reid Corson, R.N.  
Lieutenant Herbert Walter Julian Orde, R.N.  
Sub-Lieutenant Clement James Charlewood, R.N.R.

Lieutenant Corson was in H.M.S. "Fox's" steam cutter, and under a close and heavy fire from both sides of the channel climbed forward to relieve a stoker who was mortally wounded. By his exertions he kept the fires going and steam up at the most critical moment.

Lieutenant Orde was in H.M.S. "Helmuth," and, though himself wounded and under exceptionally heavy fire, with dangerous escape of steam, brought his ship safely through the narrow channel.

Sub-Lieutenant Charlewood ably assisted Lieutenant Orde in bringing the "Helmuth" through the channel.

For services in H.M.S. "Hardinge" during the operations on the Suez Canal, 3rd February 1915—

Temporary Lieutenant George Carew, R.N.R.

A shell struck the fore funnel of H.M.S. "Hardinge," and completely shattered one of Lieutenant Carew's legs from the knee down, and broke one arm, besides inflicting other wounds. Notwithstanding this, he continued to advise on the piloting of the ship with coolness and equanimity.

Petty Officer Clark was Coxswain of H.M.S. "Goliath's" steam pinnace. He was wounded, but gallantly returned to the wheel, to which he stood until the boat was out of gunfire.

Leading Seaman Callagher was Coxswain of H.M.S. "Fox's" steam cutter. When twice wounded, and under galling fire, he remained at the tiller, and with the utmost coolness steered his boat through the danger zone.

For services in the Shatt-el-Arab, 3rd to 9th December 1914—

Arthur Jones, Stoker Petty Officer, O.N. 227970.

Petty Officer Jones, after being severely wounded, kept the engines of the launch "Miner" going when water was pouring into the engine room, and undoubtedly by his action saved the "Miner" from disaster.

## BURGH OF KIRKCALDY.

ORDER OF THE LOCAL GOVERNMENT BOARD FOR SCOTLAND, authorising the Local Authority of the Burgh of Kirkcaldy to prepare a Town Planning Scheme in respect of an area of land situated wholly within the said Burgh.

**W**HEREAS the Provost, Magistrates, and Councillors of the Burgh of Kirkcaldy, being the Local Authority within the said Burgh under the Housing, Town Planning, &c., Act, 1909, passed a resolution on the twenty-seventh day of August 1914, applying to Us, the Local Government Board for Scotland, to authorise the Local Authority to prepare a Town Planning Scheme in respect of land situated wholly within the said Burgh, the area of which land is shown by a boundary line coloured pink on a certain map docketed by the Local Authority as follows:—"Kirkcaldy, 27th August 1914.—This is the plan referred to in the resolution of the Town Council of this date in regard to Town Planning," and is more particularly described in the Local Authority's advertisements of their intention to apply to Us for authority to prepare the said Scheme:

**AND** WHEREAS the resolution of the Local Authority, together with the map above referred to, has been transmitted to Us, and We have enquired into the application and into the circumstances connected therewith:

**NOW** THEREFORE WE, the Local Government Board for Scotland, do hereby, under the provisions of subsections (2) and (3) of Section 54 of the Housing, Town Planning, &c., Act, 1909, authorise the Local Authority to prepare a Town Planning Scheme with reference to the Land (including land already built upon) to which the aforesaid application relates.

**AND** WE do further authorise the Local Authority in the preparation of the Scheme as aforesaid to provide therein for the demolition or alteration of any of the buildings on the land included in the area in respect of which a scheme may be prepared as aforesaid, so far as may be necessary for carrying the Scheme into effect.

ORDER OF THE BOARD OF  
AGRICULTURE AND FISHERIES.

SHEEP-DIPPING (ISLAND OF LEWIS)  
ORDER OF 1915.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

*Application of Order.*

1.—(1.) This Order applies to the Area described in the First Schedule hereto (hereinafter referred to as "the Dipping Area").

(2.) Where any farm or holding is situate partly within and partly outside the Dipping Area, the whole farm or holding and the sheep thereon shall for the purposes of this Order be deemed to be in the Area.

(3.) While this Order remains in operation the Dipping Area described in the First Schedule hereto shall not form part of any Dipping Area

to which provisions requiring the general periodical dipping of sheep are applied by any other Order of the Board.

*Mode of Dipping Prescribed.*

2. Where under this Order it is provided that sheep are to be dipped, they shall be dipped by a thorough immersion in a sheep-dip approved by the Board for sheep-scab or purporting to be so approved.

*General Dipping during periods from (a) 15th February to 15th April, and (b) 1st September to 26th November.*

3.—(1.) All sheep in the Dipping Area during any part of a prescribed dipping period shall, subject to the next following Article, be caused to be dipped within the Dipping Area during that period by the owner or person in charge thereof. The first prescribed dipping period shall commence on the fifteenth day of February and terminate on the fifteenth day of April, and the second prescribed dipping period shall commence on the first day of September and terminate on the twenty-sixth day of November.

(2.) In the case of sheep moved into the Dipping Area between the fifth day of April and the sixteenth day of that month, or between the



sixteenth day of November and the twenty-seventh day of that month, it shall be sufficient compliance with this Article if the sheep are dipped within ten days after the movement.

(3.) The provisions of this Article relating to the first prescribed dipping period shall not take effect in the year nineteen hundred and fifteen.

#### *Exemptions from Dipping.*

4. The provisions of the preceding Article shall not, as regards each prescribed dipping period, apply to the following sheep :—

(i.) Sheep slaughtered in the Dipping Area or moved out of the Dipping Area, without contravening Article 16 of this Order, before the expiration of that period ;

(ii.) Sheep which during that period have been dipped under and in accordance with the provisions of an Order of the Board, or of any Regulations made by a Local Authority under any such Order ;

(iii.) Sheep which, in the opinion of the Local Authority, it is impracticable or inexpedient to dip in accordance with the requirements of this Order, on account of their being intended for exhibition or of any other special circumstances, and which are accordingly exempted by an exemption signed by the Clerk of the Local Authority. The exemption may be granted subject to conditions as to subsequent dipping or otherwise. A copy of every exemption shall be sent to the Board. The exemption shall be in the Form A set forth in the Second Schedule hereto, or to the like effect.

#### *Notice to Local Authority of Time and Place of intended Dippings.*

5.—(1.) For the purposes of enabling the Local Authority to be represented at the dipping whenever they think such a course desirable, the owner or person in charge of any sheep required to be dipped under Article 3 shall give such written notice of his intention to dip his sheep as is hereinafter provided :—

(i.) The notice shall be delivered, or sent by post, to such person as the Local Authority of the District may appoint to receive such notices in respect of sheep in their District.

(ii.) The notice shall be sent or delivered at such time as to be received by the appointed person three clear days, at least, before the intended time of dipping, unless a shorter notice is authorised by the Local Authority.

(iii.) The notice shall state the time and place of each intended dipping, and the approximate number of sheep intended to be dipped.

(2.) If from any cause the dipping of the sheep on the date specified in a notice becomes impracticable, no further notice shall be required if the sheep are dipped as soon after such date as is practicable.

#### *Isolation of Sheep after Dipping.*

6. Sheep after having been dipped during either prescribed dipping period, shall during the remainder of the period be kept separate, as far as practicable, from sheep kept on the same premises which have not been so dipped.

#### *Declaration after Prescribed Dipping Periods.*

7. The occupier of a farm or holding in the Dipping Area on which sheep are kept shall personally, or by his agent authorised in that behalf, not later than fourteen days after the expiration of each prescribed dipping period, send a declaration as to the dipping of the sheep, in the Form B set forth in the Second Schedule hereto, or to the like effect, to the person appointed to receive such declarations by the Local Authority.

#### *Notice of Appointment of Persons to receive Notices, &c.*

8. The Local Authority shall appoint persons to receive notices and declarations under the preceding Articles, and shall give adequate notice in their District of appointments so made.

#### *Restriction on Movement of Sheep not Dipped within Prescribed Dipping Periods.*

9. Where any sheep shall not have been dipped as required by this Order an Inspector of the Local Authority may, without prejudice to any proceedings for the offence, serve the owner or person in charge of the sheep and the owner or person in charge of any sheep then in contact with the undipped sheep with a notice, in the Form C set forth in the Second Schedule hereto, or to the like effect, requiring the dipping of the sheep described in the notice and prohibiting their movement from the farm, holding, or other place where they are at the time the notice is served (except with a licence granted by an Inspector of the Local Authority of the District) until all the sheep shall have been dipped, after the service of the notice, in the presence and to the satisfaction of an Inspector of the Local Authority or have been slaughtered, and thereupon it shall be unlawful for the owner or person in charge of the sheep to move the sheep, or permit the sheep to be moved, in contravention of the notice.

#### *Cleansing of Dipping Places.*

10. The place on any farm or premises which has been used for the dipping shall, without unnecessary delay, be thoroughly cleansed by the occupier, and all tufts of wool gathered and disinfected or destroyed.

#### *Samples of Dip may be taken.*

11. Every owner or person in charge of sheep being dipped under this Order shall permit and give every facility to an Inspector of the Local Authority or of the Board, or to a constable, to take samples of dip which is being or has been used for the dipping of sheep.

#### *Power to provide Dipping Places.*

12. The Local Authority may provide and fix up and maintain dipping places, but subject to the approval in writing by the Board of the site of each dipping place ; provided that no dipping place shall be used under this provision if its use would injuriously affect the water in any stream, reservoir, aqueduct, well, pond, or place constructed or used for the supply of water for drinking or other domestic purposes.

*Power for Local Authority to regulate time and place of Dipping in particular cases.*

13. The Local Authority may in any case where they think such procedure desirable serve a notice on the owner or person in charge of any sheep requiring that the sheep shall be dipped at such time and place as is stated in the notice and to the satisfaction of an Inspector of the Local Authority, and the sheep shall thereupon be dipped in accordance with the requirements of such notice. The notice may be in the Form D set forth in the Second Schedule hereto, or to the like effect.

*Powers of Entry and Examination.*

14. An Inspector of the Board, and an Inspector of the Local Authority, subject to the direction of the authority appointing him, may, for the purposes of this Order, enter any premises within the Dipping Area and examine any sheep thereon.

*Restriction on Movement of Sheep into Dipping Area during period from 16th April to 31st August.*

15.—(1.) Sheep shall not be moved into the Dipping Area during the period commencing on the sixteenth day of April and terminating on the thirty-first day of August, unless they are accompanied by a licence authorising such movement granted by an Inspector of the Local Authority of the county of Ross and Cromarty.

(2.) Sheep authorised by a licence so granted to be moved to a slaughterhouse shall on arrival thereat be there detained until they are slaughtered.

(3.) Sheep authorised by a licence so granted to be moved to any premises other than a slaughterhouse shall, on arrival at the premises specified in the licence, be there detained until they have been dipped in the mode prescribed by Article 2 of this Order, except that they may be moved for the purpose of dipping or for the purpose of slaughter or for feeding purposes if such movement is authorised by a licence granted by an Inspector of the Local Authority. The sheep, until they are so dipped, shall not be permitted to come in contact with any sheep kept on the same premises which have already been dipped in accordance with this Order.

*Restriction on Movement of Sheep out of Dipping Area during period 1st September to 26th November.*

16.—(1.) Sheep shall not be moved out of the Dipping Area during the period commencing on the first day of September and terminating on the twenty-sixth day of November, unless they are accompanied by a licence authorising such movement granted by an Inspector of the Local Authority of the county of Ross and Cromarty.

(2.) Unless the Inspector is satisfied

(a) that the sheep are intended for immediate slaughter and that it is impracticable or inexpedient that the sheep should in accordance with the provisions of this Order be dipped before movement for such purpose; or

(b) that the sheep are to be moved direct to a slaughterhouse;

a licence for movement under this Article shall be granted only for sheep in respect of which the

Inspector is satisfied that they have been dipped, in accordance with the provisions of Article 3 of this Order, and have since the dipping been kept separate from other sheep not so dipped.

*Special Provision as to Movement of Sheep from Ireland.*

17. The provisions of the Sheep (Movement from Ireland) Order of 1908 shall apply to the provisions of this Order as if the District referred to in that Order included the Dipping Area to which this Order applies, with the substitution for the declaration referred to in Article 3 of the first-mentioned Order, of the declaration in the Form (B) contained in the Sheep Dipping (Ireland) Order of 1912, or any Order substituted therefor.

*Provisions as to Licences.*

18.—(1) A movement licence under this Order shall be in force for eight days, inclusive of the day of issue, and shall be in the Form E set forth in the Second Schedule hereto or to the like effect.

(2) Where sheep are moved with a licence under this Order, the licence shall forthwith after completion of the movement be delivered up at, or sent by post to, the nearest Police Station in the same District by the person in charge of the sheep at the time of completing the said movement.

*General Provisions as to Movement.*

19. Sheep, while being moved with a licence under this Order, shall as far as practicable be kept separate from all other sheep, and shall be moved by the nearest available route and without unnecessary delay to the place of destination specified in the licence, and not elsewhere.

*Production of Licences; Names and Addresses.*

20.—(1) Any person in charge of a sheep being moved, where under this Order a licence is necessary, shall, on demand of a Justice, or of a constable, or of an Inspector or other officer of the Board or of a Local Authority, produce and show to him the licence, if any, authorising the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.

(2) Any person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or other officer.

*Local Authority to enforce Order.*

21. The provisions of this Order shall be executed and enforced by the Local Authority.

*Offences.*

22.—(1) If a sheep is not dipped as required by this Order, or by any notice served, or the conditions of any exemption granted, under this Order, the owner and person in charge of the sheep at the expiration of the period within which its dipping is required by this Order, or the notice or conditions, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(2) If any person fails to give any notice or send any declaration required by this Order, or falsely makes any declaration, for the purposes of this Order, or offers or utters any such declaration knowing the same to be falsely made, he shall be deemed guilty of an offence against the Act of 1894.

(3) If a sheep is not isolated as required by this Order, the owner of the sheep, and the person in charge thereof, and the occupier of the place where the sheep is kept, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(4) If a sheep is moved in contravention of this Order, the owner of the sheep, and the person in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the sheep, and the consignee or other person receiving or keeping it knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the sheep is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(5) If a person in charge of a sheep being moved, where under this Order a licence is necessary, on demand made under this Order, fails to give his true name and address, or gives a false name or address, he shall be deemed guilty of an offence against the Act of 1894.

(6) If any person fails to deliver up or send a licence as required by this Order, he shall be deemed guilty of an offence against the Act of 1894.

*Interpretation.*

23. In this Order, unless the context otherwise requires—

- “ Sheep ” includes lambs ;
- “ Inspector ” includes Veterinary Inspector and any person appointed by a Local Authority to be their Inspector for the purposes of this Order ;
- “ Person ” includes a corporate body ;
- “ Owner ” includes a joint owner ;
- “ The Board ” means the Board of Agriculture and Fisheries ;
- “ The Act of 1894 ” means the Diseases of Animals Act, 1894.

*Short Title.*

24. This Order may be cited as the SHEEP DIPPING (ISLAND OF LEWIS) ORDER OF 1915.

CAUTION WHEN APPROACHING  
BRITISH PORTS.

## PART I.

*Closing of Ports.*

*Former Notices.*—Nos. 1 and 101 of 1915; hereby cancelled.

(1) My Lords Commissioners of the Admiralty, having taken into consideration the fact that it may be necessary to forbid all entrance to certain ports of the Empire, this is to give Notice that on approaching the shores of the United Kingdom, or any of the ports or localities of the British Empire, referred to in Part III. of this Notice, a sharp look-out should be kept for the signals described in the following paragraph, and for the vessels mentioned in paragraph (5), Part II., of this Notice, and the distinguishing and other signals made by them. In the event of such signals being displayed, the port or locality should be approached with great caution, as it may be apprehended that obstructions may exist.

(2) If entrance to a port is prohibited, three *red* vertical lights by night, or three *red* vertical balls by day, will be exhibited in some conspicuous position, in or near to its approach, which signals will also be shown by the vessels indicated in paragraph (5), Part II., of this Notice.

If these signals are displayed, vessels must either proceed to the position marked "Examination Anchorage" on the Admiralty charts and anchor there, or keep the sea.

(3) At all the ports or localities at home or abroad referred to in Part III. of this Notice, search-lights are occasionally exhibited for exercise.

Instructions have been given to avoid directing moveable search-lights during practice on to vessels under way, but mariners are warned that great care should be taken to keep a sharp look-out for the signals indicated in paragraph (2) above, when search-lights are observed to be working.

## PART II.

*Examination Service.*

(4) In certain circumstances it is also necessary to take special measures to examine vessels desiring to enter the ports or localities at home or abroad, referred to in Part III. of this Notice.

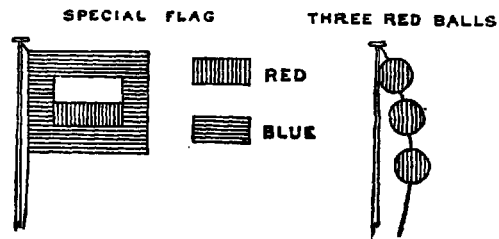
(5) In such case, vessels carrying the distinguishing flags or lights mentioned in paragraph (7) will be charged with the duty of examining ships which desire to enter the ports and of allotting positions in which they shall anchor. If Government vessels, or vessels belonging to the local port authority, are found patrolling in the offing, merchant vessels are advised to communicate with such vessels with a view to obtaining information as to the course on which they should approach the Examination Anchorage. Such communication will not be necessary in cases where the pilot on board has already received this information from the local authorities.

(6) As the institution of the Examination Service at any port will never be publicly advertised, especial care should be taken in approaching the ports, by day or night, to keep a sharp look-out for any vessel carrying the flags or lights mentioned in paragraph (7), and to be ready to "bring to" at once when hailed by her or warned by the firing of a gun or sound rocket.

In entering by night any of the ports mentioned in Part III., serious delay and risk will be avoided if four efficient all round lamps, two *red* and two *white*, are kept available for use.

(7) By day the distinguishing flags of the Examination Steamer will be a special flag (white and red horizontal surrounded by a blue border) and a blue ensign.

Also, three red vertical balls if the port is closed.



By night the steamer will carry :—

(a) Three *red* vertical lights if the port is closed.

(b) Three *white* vertical lights if the port is open.

The above lights will be carried in addition to the ordinary navigation lights, and will show an unbroken light around the horizon.

(8) Masters are warned that, when approaching a British port where the Examination Service is in force, they must have the distinguishing signal of their vessel ready to hoist immediately the Examination Steamer makes the signal.

(9) Masters are warned that, before attempting to enter any of these ports when the Examination Service is in force, they must in their own interests strictly obey all instructions given to them by the Examination Steamer. In the absence of any instructions from the Examination Steamer they must proceed to the position marked "Examination Anchorage" on the Admiralty Charts and anchor there, or keep the sea.

Whilst at anchor in the Examination Anchorage, Masters are warned that they must not lower any boats (except to avoid accident), communicate with the shore, work cables, move the ship, or allow anyone to leave the ship, without permission from the Examination Steamer.

(10) In case of fog, Masters are enjoined to use the utmost care, and the Examination Anchorage itself should be approached with caution.

(11) Merchant vessels when approaching ports are especially cautioned against making use of private signals of any description, either by day or night: the use of them will render a vessel liable to be fired on.

(12) The pilots attached to the ports will be acquainted with the regulations to be followed.

PART IV.

*Sweeping Operations.*

H.M. Vessels are constantly engaged in sweeping operations off ports in the United Kingdom.

Whilst so engaged, they work in pairs connected by a wire hawser, and are consequently hampered to a very considerable extent in their manœuvring powers.

With a view to indicating the nature of the work on which these vessels are engaged, they will show the following signals :—

A black ball at the foremast head and a similar ball at the yardarm, or where it can best be seen, on that side on which it is dangerous for vessels to pass.

For the public safety, all other vessels, whether steamers or sailing craft, must keep out of the way of vessels flying this signal, and should especially remember that it is dangerous to *pass between* the vessels of a pair.

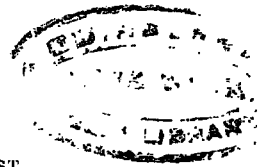
