Notice is hereby given that the Lords Commissioners of His Majesty's Treasury have, in pursuance of the powers conferred upon them by section 2 of the Rules Publication Act, 1893, and by section 83 of the National Insurance Act, 1911, and of every other power enabling them in that behalf, issued, under date the 15th instant, Provisional Regulations providing for the exercise and performance by the National Health Insurance Joint Committee alone of certain of the powers and duties of the several bodies of Commissioners appointed for the purposes of Part I of the latter Act as provided in subsection (2) of the above quoted Section.
