### PRESENT,

The KING's Most Excellent Majesty in Council.

THEREAS by "The Burial Grounds (Scotland) Act, 1855," as amended by "The Secretary for Scotland Act, 1885," it is provided that it shall be lawful for His Majesty, from time to time, by Order in Council, upon the Representation of the Secretary for Scotland that a copy of an Interlocutor of a Sheriff of a County of Scotland as in the said first-named Act provided has been received by him, in pursuance thereof to order that no new burial ground shall be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland, or (as the case may require) that after a time mentioned in the Order burials within certain limits, or in certain burial grounds or places of burial, shall be discontinued wholly, or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council shall thereupon have like force and effect as if the same were embodied in the said first-named Act: Provided always that notice of such Representation, and of the time it shall please His Majesty to order the same to be taken into

consideration by the Privy Council, shall be transmitted to the Crown Agent in Edinburgh, and the Sheriff Clerk of the County in which such burial ground is situated; and that the same shall be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the Church of, or on some other conspicuous places within, the Parish affected by such Representation, one month before such Representation is so considered:

And whereas the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a Representation that he has received a copy of an Interlocutor of the Sheriff-Substitute of Stirling, Dumbarton, and Clackmannan, at Falkirk, dated the 3rd March 1915, and made on a Petition of the Parish Council of the Parish of Falkirk, finding that the Old Burial Ground at Chapel Yard, in the Village of Bonnybridge, in the Parish of Falkirk, and County of Stirling, is dangerous to health, and offensive and contrary to decency:

And whereas in the said Representation it is recommended that the said Old Burial Ground should be closed forthwith in terms of the said first above-named Act as a place of sepulture:

And whereas by an Order in Council of the 23rd day of March 1915, notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 4th day of May 1915, and that the said Order in Council or notice thereof should be published in the Edinburgh Gazette, and that copies of the said Order in Council or notice thereof should be fixed on the doors of the Church of, or on some other conspicuous places within, the Parish affected by such Representation one month before the said 4th day of May 1915:

And whereas notice of the said Representation, and of the time when it pleased His Majesty to order the same to be taken into consideration by the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed in the manner required by the said Order in Council:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows, viz. :-

That the Old Burial Ground at Chapel Yard, in the Village of Bonnybridge, in the Parish of Falkirk, and County of Stirling, be closed forthwith, in terms of the said first above-named Act, as a place of sepulture.

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas under Section 3 of the Naval Forces Act, 1903, it is provided that any Volunteer Officer, or man, when training affoat or called out for actual service, shall be deemed to be serving in Your Majesty's Naval or Marine Force within the meaning of the Naval and Marine Pay and Pensions Act, 1865

"And whereas under the regulations for the government of Your Majesty's Naval Service the Field Allowance granted to Officers and men employed in military operations on shore are not payable when quarters are provided at the public expense:

"And whereas we are of opinion that in the case of Officers and men attached to the Armoured Car Aeroplane Support, when employed in military operations abroad, the application of the above restriction will not be practicable:

"We beg leave humbly to recommend that

Your Order in Council, to authorise the continuous payment of Field Allowance, in the circumstances stated, to Officers and men of the Armoured Car Aeroplane Support borne on Ship's Books, except in cases where the nightly rate of subsistence allowance is paid.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in

this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

#### WAR OFFICE, May 8, 1915.

His Majesty the KING has been graciously pleased to approve of the appointment of the undermentioned Officers to be Companions of the Distinguished Service Order, in recognition of their gallantry and devotion to duty whilst serving with the Expeditionary Force:—

Captain Lionel Peter Collins, 1st Battalion, 4th Gurkha Rifles.

For conspicuous gallantry throughout the Campaign, especially on 12th March 1915, when he took the initiative with his Company in the attack at Bois de Biez and captured a German trench, took 100 prisoners, killing or wounding a considerable number of the remainder of the occupants.

Major Thomas Wilkinson Cuthbert, 4th (Ross Highland) Battalion, Seaforth Highlanders (Rossshire Buffs, The Duke of Albany's), Territorial Force.

For conspicuous gallantry during the operations around Neuve Chapelle. After his Colonel had been wounded he commanded the Battalion with great ability, although himself wounded in the head.

Captain Arthur Kenelm Digby, 94th Battery, Royal Field Artillery.

For conspicuous ability and gallantry during the Campaign. He has been at the observing station on almost every occasion when his Battery was in action, and by his coolness and resource greatly contributed to the success attained. He was severely wounded at Neuve Chapelle on 10th March 1915.

Lieutenant Lanoe George Hawker, Royal Engineers and Royal Flying Corps.

For conspicuous gallantry on 19th April 1915, when he succeeded in dropping bombs on the German airship shed at Gontrode from a height of only 200 feet, under circumstances of the greatest risk.

Lieutenant Hawker displayed remarkable ingenuity in utilising an occupied German captive balloon to shield him from fire whilst manœuvring to drop the bombs.

Major Charles George Woodburn Hunter, Royal Engineers (Field Engineer, Meerut Division).

For conspicuous ability and gallantry on many occasions, especially from 10th to 14th March 1915, at Neuve Chapelle. He was in command of two Companies, and succeeded in establishing a strong breastwork line under very difficult circumstances whilst exposed to heavy shell and rifle fire.

Captain John Thornton Lodwick, 2nd Battalion, 3rd Queen Alexandra's Own Gurkha Rifles.

For conspicuous ability and gallantry as Brigade Machine-gun Officer from 10th to 13th March 1915, at Neuve Chapelle. He reconnoitred the captured positions from end to end, and brought 20 machine-guns into position which caused an immense number of casualities to the enemy when they attacked on 12th March.

Captain Francis Henry Romilly, 2nd Battalion, The Leicestershire Regiment.

For conspicuous gallantry, enterprise, and great daring at Neuve Chapelle on 10th March 1915. He led a small party with bombs against the German dug-outs, and captured about 100 yards of their trenches, the occupants being all either killed or wounded by himself and his men.

Captain Claud Jameson Torrie, 30th Punjabis, Commanding No. 35 Signal Company.

For marked ability during the campaign, especially at Neuve Chapelle during the operations from 10th to 14th March 1915, when the successful work of the Division was to a very great extent dependent on the efficiency of the communications established and maintained by him under very heavy fire.

Major Donald Munro Watt, 2nd Battalion, 2nd King Edward's Own Gurkha Rifles (The Sirmoor Rifles).

For conspicuous gallantry on 10th March 1915, when he led his Company with great ability in the attack on Bois de Biez. On the next day he continued to lead his Company after being wounded till he could go no farther.

Captain Henry William Cairns Wicks, 1st Battalion, Seaforth Highlanders (Ross-shire Buffs, The Duke of Albany's).

For marked ability in the presence of the enemy on many occasions. He was wounded on 10th March 1915, at Neuve Chapelle while directing his Company in the attack on the trenches.

His Majesty the KING has been graciously pleased to confer the Military Cross on the undermentioned Officers, in recognition of their gallantry and devotion to duty whilst serving with the Expeditionary Force:—

Lieutenant FitzA. Drayson, The Border Regiment, attached 32nd Signal Company.

He rendered invaluable service at Neuve Chapelle on 11th and 12th March 1915, as Brigade Signal Officer. He kept up communications under heavy fire with untiring energy, in circumstances of the greatest difficulty.

Lieutenant B. A. H. Gage, 4th Brigade, Royal Field Artillery.

For consistently good service rendered during the campaign, especially in the forward observation posts at Neuve Chapelle, where he established telephone communications from 10th to 12th March 1915, under heavy fire.

Lieutenant A. H. Mankelow, 1st Battalion, 39th Garhwal Rifles.

For conspicuous gallantry at Neuve Chapelle. He showed great determination and ability throughout the operations, handling his machine-guns against the enemy on the 12th March with great effect.

Captain H. A. Moore, 1-3rd (City of Loudon) Battalion, The London Regiment, Royal Fusiliers (T.F.).

For conspicuous ability and gallantry in the handling of two Companies of his Battalion, during the assault on the German trenches from the Port Arthur position near Neuve Chapelle on 10th March 1915.

Lieutenant R. G. H. Murray, 1st Battalion, 9th Gurkha Rifles.

For conspicuous gallantry and marked ability on 10th and 11th March 1915. When the 9th Gurkha Rifles were occupying an advanced position on the river Layes, the enemy made most strenuous efforts to get round the Battalion's flank; but Lieutenant Murray met all their attempts with effective machine-gun fire, thus materially contributing towards their defeat.

Captain F. P. Nosworthy, Royal Engineers (20th Company, 3rd Sappers and Miners).

For conspicuous ability and gallantry during the campaign, especially at Neuve Chapelle, from 10th to 12th March 1915, when he showed marked coolness and initiative under heavy close-range fire whilst constructing barricades.

He was severely wounded at Neuve Chapelle on 28th October 1914.

Lieutenant S. H. Steven, 1-4th (City of Dundee) Battalion, Royal Highlanders (T.F.)

For conspicuous gallantry on 10th March 1915, at Neuve Chapelle, when he commanded the leading platoon of his Battalion in the attack, and gained his objective notwithstanding the heavy enfilading fire to which his men were exposed.

Jemadar Pancham Sing Mahar, 2nd Battalion, 39th Garhwal Rifles.

For conspicuous gallantry on 10th March 1915, during the attack at Neuve Chapelle, where he showed great dash in command of a party which advanced over the open and captured many prisoners and a machine-gun.

UNEMPLOYMENT INSURANCE (COURTS OF REFEREES) EMERGENCY REGU-LATIONS, 1915.

The Board of Trade in pursuance of Section 91 of the National Insurance Act, 1911, hereby make the following Regulations:—

- 1. These Regulations may be cited as the Unemployment Insurance (Courts of Referees) Emergency Regulations, 1915, and shall come into force on the date hereof.
- 2. Notwithstanding the limitation prescribed by Regulation 20 (iv) of the Unemployment Insurance Regulations, 1912, the term of office of the members of the first panels of Courts of

Referees constituted under Part II. of the National Insurance Act, 1911, shall continue for the duration of the present war and such period not exceeding one year thereafter as the Board of Trade may direct.

### NATIONAL INSURANCE ACT, 1911. (1 & 2 Geo. V., Ch. 55).

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Insurance Commissioners (England), after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by Section 65 of the National Insurance Act, 1911, to make regulations providing—

- (a) that contributions paid by or in respect of every seaman, marine, or soldier, who is or becomes a member of the Navy and Army Insurance Fund, shall, as from the date of his discharge from service, be paid into the Fund; and
- (b) that every seaman, marine, or soldier who is or becomes a member of the Navy and Army Insurance Fund, shall be, and shall be deemed always to have been, entitled to benefits out of the Funds as from the date of his discharge from service.

### UNITED KINGDOM.

Pilotage Stations established at certain Ports on account of Defensive Minefields.

Former Notice.—No. 360 of 1915; hereby cancelled.

With reference to the extension of the system of Mine defence, notice is hereby given that Pilotage is now compulsory at the following ports for all vessels (including fishing vessels) which have a draught of over eight feet, and that it is highly dangerous for any vessel to enter or leave such ports without a pilot. Fishing and other small vessels having a draught of

over eight feet are to assemble at the Pilotage stations and will be conducted into and out of port in groups.

(1) FIRTH OF FORTH. All incoming vessels are only permitted to enter the Firth of Forth during daylight hours; they are to pass between the Isle of May and Anstruther-Wester, thence they must steer a direct course for Kinghorn Ness. On approaching Inchkeith, the Pilot vessel in the North channel is to be closed, and a pilot embarked.

Vessels are warned that they should on no account pass to the southward of a line joining the north point of the Isle of May and Kinghorn Ness, until in the longtitude of 3° W., when course may be shaped for the centre of North channel.

Outward bound vessels should steer to pass the longitude of 3° W. in latitude 56° 06′ 30″ N., then shape course to pass between Anstruther-Wester and the Isle of May.

No merchant vessel is permitted to be at an anchorage, during the hours of official night, West of a line drawn from Barnes Ness to North Carr rock, and East of Inchkeith.

The above orders apply to vessels proceeding to any port in the Firth of Forth, whether to the eastward of Inchkeith or not.

(2) MORAY FIRTH. All vessels bound to Cromarty or Inverness must call for a pilot at Wick or Burghead.

Outgoing vessels are to discharge their pilots at one or the other of these places.

It is dangerous for any vessel to be under way to the south-westward of a line joining Findhorn and Tarbetness without a pilot.

(3) SCAPA FLOW. All entrances are dangerous and entry is absolutely prohibited by any of them except as provided in succeeding paragraphs.

Examination services have been established in the entrances of Hoxa and Hoy sounds: vessels wishing to enter must communicate with the Examination vessel and follow the instructions received from her very carefully.

No vessel is permitted to approach the entrance to Hoxa sound within a radius of 5 miles under any circumstances whatever, except when actually bound to Scapa Flow. Vessels bound to Kirkwall should proceed direct to that port.

The only vessels permitted to enter Hoy sound from the westward are those bound for Stromness: vessels cannot enter Scapa Flow from Stromness.

Vessels are not permitted to enter Hoxa or Hoy sounds by night.

Passage through Cantick sound is entirely prohibited.

This Notice is a repetition of Notice No. 360 of 1915, with additions to paragraph (3) relating to Scapa Flow.
