Copy of a Letter from Lieutenant Robert Tomlinfon, Commander of his Majesty's gun-brig the Dexterous, to William Marsden, Esq. dated in Gibraltar Bay, the 12th September 1805.

I have the honour to acquaint you, for their Lordships information, that cruizing pursuant to orders from Sir William Bolton, Bart. on the 11th inst. about one A. M. the Rock of Gibraltar bearing about NNW. two leagues, I fell in with and captured the gun-boat, No. 4, Lieut. Nicholas Magorga, commander, carrying one long twenty-four pounder, one carronade, and thirty-four men; we likewife took feven merchant veftour men; we likewise took seven merchant vessels of the convoy, which are all arrived safe in this roadstead: they were from Malaga bound to Algeziras. It is with great pleasure that I have to report to their Lordships the zeal and activity with which every officer and man did his duty on this occasion; and when their Lordships are informed that these vessels were taken in the face of eight of the enemy's armed vessels in the face of eight of the enemy's armed veffels who had charge of the convoy, and who carried near three hundred men, I most humbly hope my conduct will meet their Lordships approbation.

PARDONING DESERTERS FROM HIS MAJESTY'S REGULAR FORCES.

Deferters ferving in other Corps (Militia and Army of Referve, excepted) are to continue therein upon declaring themselves to their respective Commanding Officers, who are to report the circumstanciate the Secretary at War and the Adjutant-General, and they shall not be liable, at any future time, to be claimed by the Regiments in which they formerly served: But this clause is not to extend to Deferters inlifted by the Corps raising Recruits for general service; which Deferters

are only to be entitled to their pardon, on declaring themselves to be such, and will be transferred to such Regiments as his Majety may please to command.

The Magistrate to whom any Deserter from his Majety's Regular Forces may surrender himself, is authorized and required to certify the Day on which such Deserter surrendered himself; which Certificate is to continue in force until the arrival of the Deserter at the Head Quarters of the nearest Military Post, provided he proceed at the Rate of Ten Miles a Day, unless prevented by Sickness, to be certified by some Medical Pracsitioner on the back of the Magistrate's Certificate, or to be otherwise proved to the satisfaction of the Officer commanding at such Military Posts.
