Regimental No.	Rank.	Name.	Corps.	Action for which commended.
19497	Serjeant ...	Trott, G. ...	108th Heavy Battery, Royal Garrison Artillery	For gallant conduct at Regensburg Camp, Ypres, on 11th May 1915, when he assisted in the rescue of a mortally wounded Officer under heavy shell fire. He has rendered excellent service throughout the Campaign.
9265	Private ...	Tudor, W. J. ...	4th Battalion, Liverpool Regiment	For gallant conduct on the 22nd May 1915, at Ferme de Bois, when he rescued, in broad daylight, a wounded Officer, and also a severely wounded man.
45820	Gunner ...	Tuppen, W. ...	33rd Brigade, Royal Field Artillery	For great gallantry and devotion to duty on the 9th-10th May 1915, during the operations near Rouges Bancs. All the telephone wires being cut, he maintained communication with flag and electric torch, and, although his signals always drew fire, he continued signalling throughout the operations.
16860	Sapper ...	Varrall, C. J. ...	59th Field Company, Royal Engineers	For conspicuous gallantry on the 8th May 1915, at Ypres, when he assisted an Officer to lay a charge against a German barricade. This barricade was loopholed, and they were actually between our own and the German barricade, when ours was blown up as a signal for the assaulting party.
1301	Private ...	Vincent, G. E. ...	18th County of London Battalion, The London Regiment (London Irish Rifles), T.F.	For conspicuous gallantry on the 25th May 1915, at Givenchy. When the communication between the Keep and Battalion Headquarters had been severed, he went out, during a lull in the bombardment, and proceeded to carry out repairs. The bombardment recommenced at once, but he remained out about half an hour and completed the work.
8695	Lance-Serjeant	Vincent, M. ...	4th Battalion, Liverpool Regiment	For gallant conduct and ability on the 27th April and 1st May 1915, when he commanded a platoon with marked resource. On the latter date he carried a severely wounded signaller, under a heavy fire, to a place of safety, and he has invariably showed great courage and devotion to duty.
10695	Private ...	Wade, A. H. ...	2nd Battalion, Scots Guards	For conspicuous gallantry on the 16th May 1915, at Festubert. After his comrade had been killed, Private Wade brought forward alone a trench mortar across ground on which hostile machine guns were trained.
9215	Acting Corporal	Walker, G. W. ...	1st Battalion, Leinster Regiment	For gallantry and ability at Le Touquet on the night of 31st May 1915, when he obtained valuable information in a reconnaissance of the ground between our own and the German trenches.
6592	Lance-Corporal	Waller, R. ...	2nd Battalion, Norfolk Regiment	For conspicuous gallantry and ability at Shaiba (Turkey in Asia), on the night of 12th April 1915, when left in independent command of his machine gun after his Officer had been wounded. He handled it with great skill, and assisted largely in keeping off the attack when it was heaviest; though wounded himself he continued to direct the working of the gun throughout the night.
1592	Private ...	Walters, N. H. ...	24th County of London Battalion, The London Regiment (The Queen's), T.F.	For conspicuous gallantry on the 25th and 26th May 1915, at Givenchy. Private Walters went out to establish communication with a captured trench, when the fire was so heavy that it necessitated his making four separate attempts; the last with a lamp which he had managed to obtain. Later he volunteered to make a fresh attempt, but, it being considered impossible, he was ordered to desist.
