EXEMPTION FROM DUTY ON DIVIDENDS.

HIS Majesty's Commissioners for the Affairs of Taxes, hereby give Notice, that all persons claiming EXEMPTIONS FROM THE DUTY, in respect of the DIVIDENDS arising from Annuities, Dividends or Shares of Annuities, out of any public Revenue, whether in the Books of the Bank of England or of other public Companies, corporate or not corporate, belonging to any Friendly Societies, or to any Corporative Fraternity, or Society of Persons, established for charitable purposes only, are required to make their Claims to Exemption before the Commissioners, for the special purposes of the acts; and that all such Claims must be made in writing, and delivered at the Office for Taxes, in Somerset Place, directed to the Secretary for the Affairs of Taxes.
