WHEREAS by an Order in Council dated the twenty-eighth day of November nineteen hundred and fourteen His Majesty was pleased to make Regulations (called the "Defence of the Realm (Consolidation) Regulations, 1914") under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the realm:

And whereas the said Act has been amended by the Defence of the Realm (Amendment) Act, 1915, the Defence of the Realm (Amendment) (No. 2) Act, 1915, and the Munitions of War Act, 1915:

And whereas the said Regulations have been amended by various subsequent Orders in Council:

And whereas it is expedient futher to amend the said Regulations in manner hereinafter

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following amendments be made in the said Regulations:

1. After Regulation 12a the following Regulation shall be inserted:—

"12B. In any area in which an order made under Regulation 11 or Regulation 12 requiring lights to be extinguished or obscured is in force the ringing and chiming of bells and the striking of clocks audible in any street or other open space shall be prohibited between the hours between which lights are so required to be extinguished or obscured, except in cases where special permission is obtained from the competent military authority, and if any person having control of any bells or clock allows the bells to be rung or chimed or the clock to strike in contravention of the provisions of this Regulation he shall be guilty of a summary offence against these Regulations."

2. In Regulation 19, at the end of the definition "naval or military work" contained in that Regulation there shall be added the words "or plant therein."

3. After Regulation 25 the following Regulations shall be inserted:—

"25A. No person shall without lawful authority display or make any signal, visual or otherwise, of any nature liable to be mistaken for any signal authorised to be used in

the case of an attack by the enemy, or communicate any information likely to cause any such authorised signal to be displayed or made; and if any person acts in contravention of this provision he shall be guilty of an

offence against these regulations."

"25B. The competent military authority may issue orders specifying the action to be taken, in accordance with any preconcerted scheme, by persons and authorities in the event of notice being given to them, in a preconcerted form or manner, in connection with an anticipated attack by hostile aircraft, and if any person affected by any such order fails to comply therewith he shall be guilty of an offence against these regulations."

4. In paragraph (g) of Regulation 45, after the words "government department" in both places where those words occur there shall be inserted the words "or the government of any of His Majesty's dominions or any foreign

government."

5. The following Regulation shall be inserted

It shall be lawful for any person duly authorised by the local registration authority under the National Registration Act, 1915, for any area or by the chief officer of police for any district, or for any police constable, to visit any house and to require the production to him of the certificates of registration of all male persons living in the house who are or who ought to have been registered under the National Registration Act, 1915, and to inspect and take copies of the certificates produced to him, and if any such person fails, without reasonable excuse, to produce such a certificate he shall be guilty of a summary offence against these Regulations."

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 23rd day of March 1916, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas by Your Majesty's Order in

Council bearing date the 16th day of July 1914 sanction was given to various rates of pay and allowances for Officers and Men of the Royal Naval Air Service:

"And whereas we are of opinion that Officers and Men, whether belonging to the Royal Naval Air Service or not, who are employed on acceptance duties, and are required to carry out trials on new and repaired Machines, should receive some additional remuneration in consideration of the risks involved:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to authorise the continuous payment of an allowance at the following rates to Officers or Men when employed on the above-mentioned duties: Subject, however, to the proviso that where Officers, Warrant Officers, and Men belonging to the Royal Naval Air Service are entitled to higher rates of Flying Pay, they are to continue to receive such rates in lieu of the allowances.

Commissioned Officers, . 5s a day. Warrant Officers, . 3s a day. Men . . . 2s. a day.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

And whereas by Order in Council dated the 21st day of December 1908 His late Majesty was pleased to alter the Scale and Rules set out in the said Second Schedule to the said Act in manner following, that is to say:—

"1. Each of the Dues authorised to be levied by the said Scale shall, for a period of three years from the date of coming into operation of this Order, be subject to a reduction of $17\frac{1}{2}$ per cent. beyond the reduction of $12\frac{1}{2}$ per cent. provided for by the said Order in Council of the 10th day of August 1903, and the said Dues as so reduced by the said Order in Council of the 10th day of August 1903, and by this Order, shall be levied and the said Rules construed accordingly.

The KING has been graciously pleased to approve of the grant of the Victoria Cross to the undermentioned Officer in recognition of his most conspicuous bravery and devotion to duty:—

Sub-Lieutenant Arthur Waldene St. Clair Tisdall, R.N.V.R. (killed in action).

During the landing from the s.s. River Clyde at V Beach in the Gallipoli Peninsula on the 25th April 1915, Sub-Lieutenant Tisdall, hearing wounded men on the beach calling for assistance, jumped into the water and, pushing a boat in front of him, went to their rescue. He was, however, obliged to obtain help, and took with him on two trips Leading Seaman Malia and on other trips Chief Petty Officer Perring and Lead-

ing Seamen Curtiss and Parkinson. In all Sub-Lieutenant Tisdall made four or five trips between the ship and the shore, and was thus responsible for rescuing several wounded men under heavy and accurate fire.

Owing to the fact that Sub-Lieutenant Tisdall and the platoon under his orders were on detached service at the time, and that this Officer was killed in action on the 6th May, it has only now been possible to obtain complete information as to the individuals who took part in this gallant act. Of these, Leading Seaman Fred Curtiss, O.N. Dev. 1899, has been missing since the 4th June 1915.

His Majesty the KING has been graciously pleased to award the Victoria Cross to the under-mentioned Officers, Non-Commissioned Officers, and Men :-

Captain Arthur Forbes Gordon Kilby, late Battalion, The 2nd South Staffordshire Regiment.

For most conspicuous bravery. Captain Kilby was specially selected, at his own request, and on account of the gallantry which he had previously displayed on many occasions, to attack with his company a strong enemy redoubt.

The company charged along the narrow tow-path, headed by Captain Kilby, who, though wounded at the outset, continued to lead his men right up to the enemy wire under a devastating machine-gun fire and a shower of bombs. Here he was shot down, but, although his foot had been blown off, he continued to cheer on his men and to use a rifle.

Captain Kilby has been missing since the date of the performance of this great act of valour, and his death has now to be presumed.

Eric Archibald Temporary Lieutenant M'Nair, 9th (Service) Battalion, The Royal Sussex Regiment.

For most conspicuous bravery. When the enemy exploded a mine, Lieutenant M'Nair and many men of two platoons were hoisted into the air, and many men were buried. But, though much shaken, he at once organised a party with a machine-gun to man the near edge of the crater and opened rapid fire on a large party of the enemy, who were advancing. The enemy were driven back, leaving many dead.

Lieutenant M'Nair then ran back for reinforcements, and sent to another unit for bombs, ammunition, and tools to replace those buried.

The communication trench being blocked, he went across the open under heavy fire and led up the reinforcements the same way. His prompt and plucky action and example undoubtedly saved the situation.

No. 3/10133 Serjeant Arthur Frederick Saunders, 9th (Service) Battalion, The Suffolk Regiment.

For most conspicuous bravery. When his officer had been wounded in the attack he took charge of two machine-guns and a few men, and, although severely wounded in the thigh, closely followed the last four charges of another battalion, and rendered every possible support. Later, when the remains of the battalion which he had been supporting had been forced to retire he stuck to one of his guns, continued to give clear orders, and by continuous firing did his best to cover the retirement.

No. 6707 Lance-Corporal (Acting Corporal) William Richard Cotter, 6th Battalion, East Kent Regiment.

For most conspicuous bravery and devotion to duty. When his right leg had been blown off at the knee, and he had also been wounded in both arms, he made his way unaided for fifty yards to a crater, steadied the men who were holding it, controlled their fire, issued orders, and altered the dispositions of his men to meet a fresh counterattack by the enemy.

For two hours he held his position, and only allowed his wounds to be roughly dressed when the attack had quieted down.

He could not be moved back for fourteen hours, and during all this time had a cheery word for all who passed him. There is no doubt that his magnificent courage helped greatly to save a critical situation.

No. 8655 Private Henry Kenny, 1st Battalion, Loyal North Lancashire Regiment.

Kenny went out on six different occasions on one day under a very heavy shell, rifle, and machine-gun fire, and each time succeeded in carrying to a place of safety a wounded man who had been lying in the open.

He was himself wounded in the neck whilst handing the last man over the parapet.

No. 5938 Private William Young, 8th (Service) Battalion, East Lancashire Regiment.

For most conspicuous bravery. On seeing that his Serjeant had been wounded he left his trench to attend to him under very heavy The wounded Non-Commissioned Officer requested Private Young to get under cover, but he refused, and was almost immediately very seriously wounded by having both jaws shattered.

Notwithstanding his terrible injuries, Private Young continued endeavouring to effect the rescue upon which he had set his mind, and eventually succeeded with the aid of another soldier.

He then went unaided to the dressing station, where it was discovered that he had also been wounded by a rifle bullet in the chest.

The great fortitude, determination, courage, and devotion to duty displayed by this soldier could hardly be surpassed.

DEFENCE OF THE REALM (CONSOLI-DATION) REGULATIONS, 1914-16.

PROHIBITION OF THE LIFTING OF HAY AND STRAW IN GREAT BRITAIN.
