At the Council Chamber, Whitehall, the 14th day of April 1916.

By the Lords of His Majesty's Most Honourable Privy Council.

**W**HEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas by a Proclamation, dated the 28th day of July 1915, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited :

And whereas by subsequent Orders of Council the said Proclamation was amended and added to in certain particulars :

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect :—

That the Proclamation dated the 28th day of July 1915, as amended and added to by subsequent Orders of Council, should be further amended by making the following amendments in and additions to the same :—

- (1) That the exportation of the following goods should be prohibited to all destinations :—
  - Pig iron of all descriptions ;
  - Railway material, the following :—
    - Steel rails ;
    - Steel sleepers ;
    - Steel springs ;
    - Steel wheels and axles ;
  - Shipbuilding material, the following :—
    - Boiler tubes ;
    - Condenser tubes ;
    - Steel plates and sectional materials for shipbuilding ;
  - Soap containing more than one per cent. of glycerine ;
  - Steel in bars, angles, rods and shapes or sections ;
  - Steel blooms, billets and slabs ;

Steel bridge, boiler and other plates not under  $\frac{1}{4}$ -inch thick ;

Steel girders, beams, joists and pillars ;

Steel ingots ;

Steel tubes of all descriptions ;

Steel wire, except barbed and galvanised wire (the exportation of which remains prohibited to all destinations abroad other than British Possessions and Protectorates).

- (2) That the exportation of the following goods should be prohibited to all destinations abroad other than British Possessions and Protectorates :—

Aluminium Sulphate and aluminiferous ;

Files ;

Lacs, not including lac dye ;

Soap, soft, containing one per cent. and less of glycerine.

- (3) That the exportation of the following goods should be prohibited to all foreign countries in Europe and on the Mediterranean and Black Seas, other than France, Russia (except through Baltic ports), Italy, Spain and Portugal :—

Asphalt and solid or liquid bitumen ;

Fishing gear, except tackle for fishing by rod and line ;

Petroleum and its products not already specifically prohibited ;

Soap, hard, containing one per cent. and less of glycerine.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, the Director of the War Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

**W**HEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 4th day of April 1916, in the words following, viz. :—

“Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council :

“And whereas Your Majesty was graciously pleased, by Your Orders in Council bearing date the 10th November 1915 and 15th February 1916 respectively, to approve the grant of a Climate Allowance for service in the Cameroons, and the Gulf of Aden :

“And whereas the discomforts inseparable from service ashore at Bathurst (West Africa), and Aden, are similar to those experienced on board Your Majesty's Ships employed in the afore-mentioned areas :

“We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the payment of an Allowance at the same rates, and for similar periods, to the Naval Ranks and Ratings serving at Your Majesty's Naval Establishments at Bathurst and Aden.

“The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.”

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

**W**HEREAS His Majesty was pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by a Proclamation dated the 29th day of February 1916, to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the said Proclamation :

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State, such List as so varied or added to being in the said Proclamation referred to as the “Statutory List” :

And whereas the List contained in the said Proclamation was amended by Orders of Council dated respectively the 16th and 24th March, and 7th April 1916 :

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect :—

That the List of persons and bodies of persons, incorporated or unincorporated, with whom trading is prohibited by the Proclamation dated the 29th day of February 1916, as amended by the Orders of Council of the 16th and 24th March, and 7th April 1916, should be further amended by the variation and addition of the names set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

**EXPLOSIVES IN COAL MINES.**

The Secretary of State for the Home Department hereby gives notice that on 14th April 1916 he made an Order in pursuance of Section 61 of the Coal Mines Act, 1911, entitled "The Explosives in Coal Mines Order of the 14th April 1916," the effect of which is to add the Explosives "Dynobel No. 3" and "Dynobel No. 4" to the list of permitted explosives.

The Governments of Their Majesties the King of Great Britain and Ireland and the King of the Belgians are agreed during the present war to recognise the exclusive right of jurisdiction of the tribunals of their respective armies in the field in regard to persons belonging to those armies, irrespective of the nationality of the accused or of the territory in which the armies are operating.

With regard to any infringement of the law, committed conjointly or in collusion on Belgian territory by persons belonging to these two armies, the British principals and their accomplices will be referred to British military jurisdiction, and the Belgian principals and their accomplices to Belgian military jurisdiction.

In the case of infringements committed conjointly or in collusion on British territory by persons belonging to these two armies, the principals and their accomplices will be referred to British military jurisdiction, except in the case of Belgians who have been arrested under Belgian authority.

The two Governments also agree to recognise, during the present war, the exclusive right of jurisdiction, on British territory, of the British tribunals respecting all persons not belonging to the Belgian army committing acts prejudicial to the said army; and the exclusive right of jurisdiction on Belgian territory of the Belgian tribunals respecting persons not belonging to the British army committing acts prejudicial to the said army.

## DEFENCE OF THE REALM (LIQUOR CONTROL).

## ORDER OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) FOR THE SCOTLAND, NORTH WESTERN, AREA.

*Any person contravening the provisions of this Order or of the Liquor Control Regulations is liable to imprisonment for six months with hard labour and a fine of £100.*

We, the Central Control Board (Liquor Traffic) in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm hereby make the following Order:—

## LIMITS OF AREA.

1. The area to which this Order applies is the Scotland, North Western, Area, being the area comprising so much of the Counties of Inverness and Ross and Cromarty (including all Burghs within the geographical limits thereof) as is not comprised within the Scotland, Northern Area, as defined and specified in the Schedule to an Order in Council, dated the 14th day of September 1915, and all arms of the sea and waters between the Islands forming part of the said Counties and the Mainland.

## HOURS DURING WHICH EXCISEABLE LIQUOR (OTHER THAN SPIRITS) MAY BE SOLD.

2. The days and hours on and during which exciseable liquor (other than spirits) may be sold or supplied in any licensed premises or club for consumption on or off the premises shall be restricted and be as follows:—

*On Week Days.*

The hours between 12 noon and 2.30 p.m. and between 6 p.m. and 8 p.m.

Except on the days and between the hours aforesaid no person shall

- (a) Either by himself or by any servant or agent sell or supply to any person in any licensed premises or club, or (except as hereinafter expressly provided) dispatch therefrom any such exciseable liquor to be consumed either on or off the premises; or
- (b) Consume in or take from any such premises or club any such exciseable liquor; or
- (c) Permit any person to consume in or take from any such premises or club any such exciseable liquor.

## SALE OF SPIRITS PROHIBITED.

3. No person shall either by himself or by any servant or agent sell or supply to any person in any licensed premises or club or dispatch therefrom any spirits to be consumed either on or off the premises, or purchase or consume in or take from any such premises or club or permit any person to consume in or take from any such premises or club any spirits.

## HOURS OF OPENING FOR THE SUPPLY OF FOOD AND NON-EXCISEABLE LIQUOR.

4. (a) Notwithstanding any provisions of this Order or of the law relating to licensing or the sale of exciseable liquors, licensed premises may be kept open for the supply of com-

modities other than exciseable liquor at any time during which they may be kept open for that purpose under the Licensing (Scotland) Acts, 1903 to 1913; and

- (b) Licensed premises may be opened for that purpose at the hour of 5.30 in the morning.

## SAVING PROVISIONS.

5. (a) The sale or supply of exciseable liquor (including spirits), on an order stating why such liquor is required and signed by an officer of police, procurator fiscal, or medical official, or, in cases where spirits are immediately required for medicinal purposes by any duly qualified medical practitioner, police constable, magistrate, or minister of religion, shall not be deemed to be in contravention of the foregoing provisions, provided that such order be transmitted to the procurator fiscal in the manner with the note and within the time required by Section 55 of the Licensing (Scotland) Act, 1903, and the provisions of the said section shall apply to any such order.

(b) Nothing in the foregoing provisions of this Order shall be deemed to prohibit where the same is otherwise lawful:

- (i) The consumption of exciseable liquor (other than spirits), by any person in any licensed premises or club where he is residing; or
- (ii) The consumption of exciseable liquor (other than spirits), at a meal by any person in any licensed premises or club at any time within half an hour after the conclusion of the afternoon and evening hours during which the sale or supply of such exciseable liquor is permitted by this Order: Provided that the liquor was sold or supplied and served during such hours and at the same time as the meal and for consumption at the meal; or
- (iii) The dispatch from licensed premises for delivery at a place more than five miles distant of exciseable liquor (other than spirits), in the forenoon of any day on which the sale of the same is permitted by Article 2 of this Order.

## TREATING PROHIBITED.

6. No person shall either by himself or by any servant or agent sell or supply any exciseable liquor to any person in any licensed premises or in any club for consumption on the premises unless the same is ordered and paid for by the person so supplied; nor shall any person order or pay for or lend or advance money to pay for any exciseable liquor wherewith any other person has been or is to be supplied for consumption on the premises; nor shall any person

consume in any licensed premises or club any exciseable liquor which any other person has ordered or paid for or agreed to pay for or lent or advanced money to pay for.

Provided always that if such exciseable liquor is supplied or served for consumption at a meal supplied at the same time and is consumed at such meal the provisions of this article shall not be deemed to be contravened if the person who pays for such meal also pays for such exciseable liquor.

For the purposes of this Article consumption on the premises includes consumption of exciseable liquor in or on any highway, open ground, or railway station adjoining or near to the licensed premises or club in which the liquor was sold or supplied; and any person consuming exciseable liquor in or on any such highway, open ground, or railway station shall be deemed to consume the liquor in such licensed premises or club as the case may be.

#### CREDIT PROHIBITED.

7. No person shall—

(1) (a) Either by himself or by any servant or agent sell or supply in any licensed premises or club or dispatch therefrom any exciseable liquor to be consumed either on or off the premises; or

(b) Consume any exciseable liquor in or take it from such premises or club, unless it is paid for before or at the time when it is supplied or dispatched or taken away.

Provided always that if the liquor is sold or supplied for consumption at a meal supplied at the same time and is consumed at such meal this article shall not be deemed to be contravened if the price of the liquor is paid together with the price of such meal and before the person partaking thereof quits the premises:

(2) Introduce or cause to be introduced into the area any exciseable liquor unless it is paid for before it is so introduced.

#### LONG PULL PROHIBITED.

8. No person shall either by himself or by any servant or agent sell or supply to any person in any licensed premises or club as the measure of exciseable liquor for which he asks an amount exceeding that measure.

#### PROVISIONS AS TO PASSENGER STEAMERS.

9. The foregoing provisions of this Order relating to the sale or supply of exciseable liquor in licensed premises shall apply to all passenger steamers in which exciseable liquor is sold or supplied while actually within the area.

#### CANVASSING PROHIBITED.

10. No person shall either by himself or by any servant or agent

(a) Solicit or canvass for orders for, or collect or receive payment for, exciseable liquor except at the licensed premises, or send or cause to be sent or leave or cause to be left to or at any premises, or to or with any person, any order form for exciseable liquor;

(b) Cause or permit any payment for exciseable liquor to be made on his behalf by any person in the service or employment of the vendor of the liquor, or, being a person in such service or employment make any such payment as the agent or on behalf of the purchaser of the liquor.

#### EXPLANATORY PROVISIONS.

11. (a) Nothing in this Order authorises any licensed premises to be kept open for the sale of exciseable liquor except during the hours permitted under the general provisions of the Licensing Acts.

(b) The prohibition under this Order of the sale and consumption of exciseable liquor except on and during certain days and hours and otherwise is not subject to the exceptions provided for in the Licensing Acts with respect to travellers and the supply of exciseable liquor at railway stations or to any other provisions in those Acts enabling exciseable liquor to be supplied during closing hours in special cases.

(c) The expression "licensed premises" includes any premises or place where the sale of exciseable liquor is carried on under a licence.

(d) This Order does not affect the sale or dispatch of exciseable liquor to a trader or the purposes of his trade, or to a registered club for the purposes of the club.

(e) This Order does not affect the sale or supply of exciseable liquor to or in any canteen where the sale of exciseable liquor is carried on under the authority of a Secretary of State or of the Admiralty.

#### EXHIBITION OF ORDER.

12. The secretary of every club to which this Order applies and every holder of a licence for the sale of exciseable liquor shall keep permanently affixed in some conspicuous place in the club or in each public room in the licensed premises a copy of this Order and any notice required by the Board to be affixed.

#### COMMENCEMENT OF ORDER.

13. This Order shall come into force on the twenty-fourth day of April 1916.

RENFREWSHIRE (CONTROL OF DOGS)  
ORDER OF 1916.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, the Dogs Act, 1906, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

*Power to make Regulations.*

1.—(1) The Local Authority of any District specified in the Schedule to this Order may, in accordance with the provisions of this Order, make Regulations, with a view to the prevention of worrying of cattle (including sheep), for requiring that dogs or any class of dogs shall, during all or any of the hours between sunset and sunrise, be kept by the owners thereof under control in manner prescribed by the Regulations.

(2) The Regulations may apply to the whole or any part of the District, and may exempt any class of dogs either generally or under prescribed conditions.

*Confirmation of Regulations.*

2.—(1) Regulations made under this Order shall not take effect unless and until they have been submitted to and confirmed by the Board of Agriculture and Fisheries.

(2) Unless the Board otherwise direct, the following provisions shall apply—

- (i.) Notice of intention to apply for confirmation of any Regulation shall be given in one or more of the local newspapers circulating within the District in two successive issues two weeks at least before the making of the application.
- (ii.) For two weeks at least before an appli-

cation, a copy of the Regulations proposed to be confirmed shall be kept at the office of the Local Authority of the District, and be open during office hours thereat to the inspection of ratepayers of the District without fee or reward.

(iii.) The Clerk of the Local Authority shall, on the application of any such ratepayer, furnish him with a copy of the proposed Regulations on payment of sixpence.

(3) A copy of any Regulations made by a Local Authority under this Order, signed and certified by the Clerk of the Local Authority to be a true copy and to have been duly confirmed, shall be evidence, until the contrary is proved, in all legal proceedings, of the due making, confirmation, and existence of the Regulations without further or other proof.

*Seizure of Dogs where Regulations are Contravened.*

3. Any dog in respect of which an offence is being committed against a Regulation made under this Order may be seized and treated as a stray dog under the powers conferred by section three of the Dogs Act, 1906.

*Extension of Definition in Diseases of Animals Act, 1894.*

4. Dogs shall be animals for the purposes of the following sections of the Diseases of Animals Act, 1894 (namely) :—

Section forty-three (*police*);

Section forty-four (*General administrative provisions*);

and also for the purposes of all other sections of the said Act containing provisions relative to or consequent on the provisions of those sections and this Order, including such sections as relate to offences and legal proceedings.

*Local Authority to enforce Order.*

5. The provisions of this Order shall be executed and enforced by the Local Authority.

*Short Title.*

6. This Order may be cited as the RENFREWSHIRE (CONTROL OF DOGS) ORDER OF 1916.
