SPECIAL ACTS (EXTENSION OF TIME) ACT, 1915.

KIRKCALDY DISTRICT WATER ORDER, 1913.

WHEREAS by the Special Acts (Extension of Time) Act, 1915, it is provided *inter alia* that where the time within which a power may be exercised under any Special Act is limited, an application may be made by the person by whom such power may be exercised to the appropriate Government Department for an Order extending that time, and that the Department, if satisfied that the time should be extended, may make an Order accordingly: and it is further provided that such an Order shall have full effect, notwithstanding that the time to which it relates has expired, if the application upon which the Order is made was made before the time expired.

And whereas under the Kirkcaldy District Water Order 1913 the County Council of the County of Fife (hereinafter called the County Council) were empowered compulsorily to acquire certain lands for the works authorised by that Order and the works to be constructed by the Kirkcaldy District Committee of the County Council authorised by the Wemyss and District Water Order 1910, and by section 34 of the aforesaid Order of 1913, the time within which the said power of compulsory purchase might be exercised is limited to a period which expired on the 3rd day of August 1916.

And whereas on the 14th day of July 1916

the County Council and their Kirkcaldy District Committee applied to the Secretary for Scotland in terms of the Special Acts (Extension of Time) Act 1915 for an Order extending the said time.

And whereas I am satisfied that the time in respect of which the application is made should be extended:

Now therefore, in pursuance of the powers vested in me by the last mentioned Act, I, the Right Honourable Harold John Tennant, His Majesty's Secretary for Scotland, hereby order as follows:—

The time limited by section 34 of the Kirkcaldy District Water Order 1913 within which the power of the County Council for the compulsory purchase of lands referred to in that section may be exercised is hereby extended for a period of one year, that is to say, until the 3rd day of August 1917.

This Order may be cited as the Kirkcaldy District Water (Extension of Time) Order, 1916.

FISHERY BOARD FOR SCOTLAND.

BYELAW (No. 29) MADE BY THE FISHERY BOARD FOR SCOTLAND, ALTERING BYELAW (No. 17) MADE BY THE BOARD UNDER THE SEA FISHERIES (SCOTLAND) AMENDMENT ACT, 1885. (48 & 49 Vict., c. 70.)

I. Notwithstanding Byelaw No. 17, made by the Fishery Board for Scotland on 21st October 1898, and confirmed by the Secretary for Scotland on the 7th December 1898, it shall be lawful to use a seine net, or a flounder net with a bag, in the capture of white fish during the months of July, August, September, October, and November in each year in the waters lying within three miles of low water mark between a straight line drawn north-west (magnetic) from Gullane Ness and a straight line joining Portobello Pier and Inchkeith Light and the waters to the south of a straight line drawn from Inchkeith Light through the Mickery Stone to a point one mile due north (magnetic) of Cramond Island, provided

- (1) that in the working of the net only one boat shall be employed;
- (2) that the net shall be hauled in as soon as its ends have been brought together and shall not be otherwise dragged or trailed along the bottom of the sea;
- (3) that the size of each mesh of the wings of the net so employed shall be such that a square gauge of $2\frac{1}{2}$ inches measured across each side of the square or 10 inches measured round the four sides will pass

without pressure when the net is wet and that the size of each mesh of any bag attached to the net shall be such that a square gauge of 2 inches measured across each side of the square or 8 inches round the four sides will so pass;

- (4) that the boat from which the net is used shall not exceed 40 feet over all and shall not be propelled otherwise than by sails or oars or by a motor engine; and
- (5) that no otter boards shall be used.

II. Except in so far as it is altered by this Byelaw, Byelaw No. 17 shall remain in force.

III. This Byelaw shall come into force from and after the date of its confirmation by the Secretary for Scotland.

FISHERY BOARD FOR SCOTLAND.

BYELAW (No. 30) MADE BY THE FISHERY BOARD FOR SCOTLAND, ALTERING BYELAW (No. 17) MADE BY THE BOARD UNDER THE SEA FISHERIES (SCOTLAND) AMENDMENT ACT, 1885 (48 & 49 Vict. c. 70).

I. Notwithstanding Byelaw No. 17, made by the Fishery Board for Scotland on 21st October 1898, and confirmed by the Secretary for Scotland on the 7th December 1898, it shall be lawful to use a seine net, or a flounder net with a bag, in the capture of white fish during the months of July, August, September, October, and November in each year in the waters lying within three miles of low-water mark between a straight line drawn due east (true) from Girdleness Lighthouse and a straight line drawn due east (true) from Belhelvie, provided

- (1) that in the working of the net only one boat shall be employed;
- (2) that the net shall be hauled in as soon as its ends have been brought together and shall not be otherwise dragged or trailed along the bottom of the sea;
- (3) that the size of each mesh of the wings of the net so employed shall be such that a square gauge of $2\frac{1}{4}$ inches measured across each side of the square or 10 inches measured round the four sides will pass without pressure when the net is wet and that the size of each mesh of any bag attached to the net shall be such that a

square gauge of 2 inches measured across each side of the square or 8 inches round the four sides will so pass;

- (4) that the boat from which the net is used shall not exceed 40 feet over all and shall not be propelled otherwise than by sails or oars or by a motor engine; and
- (5) that no otter boards shall be used.

II. Except in so far as it is altered by this Byelaw, Byelaw No. 17 shall remain in force.

III. This Byelaw shall come into force from and after the date of its confirmation by the Secretary for Scotland.

MOTOR CARS.

THE MOTOR CARS REGULATION (BURGH OF STRANRAER) ORDER, 1916. Dated 21st September 1916.

In pursuance of the powers vested in me by Section 9, as read with Section 18 of the Motor Car Act, 1903, I, the Right Honourable Harold John Tennant, His Majesty's Secretary for Scotland, on the application of the Town Council of the Burgh of Stranraer, being the local authority of the said Burgh, do hereby make the following regulations:—

1. This Order may be cited as "The Motor Cars Regulation (Burgh of Stranraer) Order, 1916," and the regulations hereby prescribed shall take effect within the limits or places referred to therein on and after the respective dates at which, for the purpose of giving effect thereto, the local authority shall, in terms of Section 10 of the Motor Car Act, 1903, place notices in conspicuous places on or near such limits or places.
2. A person shall not drive a motor car at a speed exceeding ten miles per hour within the limits or places specified in the Schedule to this Order.

SCHEDULE.

Limits or Places.

Sheuchan Street—From a point west of Sheuchan Mill where the road from Kirkcolm joins the shore road along Agnew Crescent, Market Street, Harbour Street, and Cairnryan Road to Lochryan Road.

Leswalt Road—From a point 50 yards north-west of the school along High Street, George Street, and Charlotte Street to its junction with Cairnryan Road.

Sun Street—From its junction with High Street along Bridge Street, Hanover Street, and London Road to Lochryan Road.

St. John Street—From its junction with Charlotte Street along Dalrymple Street to the south boundary of the Poorhouse.

Church Street—From its junction with George Street along Lewis Street to the south boundary of the Convent.

Lochryan Road—From its junction with Cairnryan Road to its junction with London Road.

Stair Drive—From its junction with Cairnryan Road along Station Street to the Station.

Bellevilla Road—From its junction with Cairnryan Road to its junction with Hanover Street.

Castle Street—From its junction with Charlotte Street to its junction with Bridge Street.

Greenvale Street—From its junction with Lewis Street along Trade Street to its junction with Dalrymple Street.

Academy Street—From its junction with Lewis Street along Edinburgh Road to the Station.
