# A PROCLAMATION

Under the Munitions of War Acts, 1915 and 1916.

GEORGE R.I.

THEREAS by section three of the Munitions of War Act, 1915, as amended by the Munitions of War (Amendment) Act, 1916, it is provided that the differences to which Part 1 of the first-mentioned Act applies are differences as to rates of wages, hours of work, or otherwise as to terms or conditions of or affecting munitions work, and also any differences as to rates of wages, hours of work, or otherwise as to terms or conditions of or affecting employment on any other work of any description, if that Part of that Act is applied to such a difference by His Majesty by Proclamation, on the ground that in the opinion of His Majesty the existence or continuance of the difference is directly or indirectly prejudicial to the manufacture, transport, or supply of Munitions of War; and it is also provided that the said Part of the said Act may be so applied to such a difference at any time, whether a lock-out or strike is in existence in connection with the difference to which it is applied or not: Provided that if in the case of any industry the Minister of Munitions is satisfied that effective means exist to secure the settlement without stoppage of any difference arising on work other than on munitions work, no Proclamation shall be made under the said section with respect to any such difference:

And whereas a difference within the meaning of the said section exists between employers and persons employed on the work of card room and blowing room operatives in the Lancashire Cotton Mills as to rates of wages, hours of work, and otherwise as to terms and conditions of or affecting employment on the work carried on by such operatives:

And whereas the Board of Trade have investigated the matter, and the Minister of Munitions having considered the results of the investigation made by the Board of Trade and their representations to him, is not satisfied that effective means exist to secure the settlement of the said difference without stoppage, being a difference arising on work other than munitions work:

And whereas in Our opinion the existence or continuance of the said difference is directly and indirectly prejudicial to the manufacture, transport, and supply of Munitions of War:

Now, therefore, We, by and with the advice of Our Privy Council, are pleased to proclaim, direct and ordain, that Part I. of the Munitions of War Act, 1915, shall apply to the said difference.

Given at Our Court at Buckingham Palace, this fifth day of December, in the year of our Lord One thousand nine hundred and sixteen, and in the Seventh year of Our Reign.

# A PROCLAMATION

FOR PROHIBITING THE IMPORTATION OF CERTAIN ARTICLES INTO THE UNITED KINGDOM.

GEORGE R.I.

WHEREAS by Section forty-three of the Customs Consolidation Act, 1876, it is provided that the importation of arms, ammunition, gunpowder, or any other goods may be prohibited by Proclamation:

And whereas it is expedient that the importation into the United Kingdom of certain goods should be prohibited as hereinafter provided:

Now, therefore, We, by and with the advice of Our Privy Council, in pursuance of the said Act and of all other powers enabling Us in that behalf, do hereby proclaim, direct and ordain, as

As from and after the date hereof, subject as hereinafter provided, the importation into the United Kingdom of the following goods is hereby prohibited, viz. :-

Gold, manufactured or unmanufactured, including gold coin and articles consisting

partly of or containing gold;
All manufactures of silver other than silver watches and silver watch cases;

Jewellery of any description.

Provided always, and it is hereby declared, that this prohibition shall not apply to-

(a) Any such goods which are imported under licence given by or on behalf of the Board of Trade, and subject to the provisions and conditions of such licence; or

(b) Gold consigned for delivery at, and sale

to, the Bank of England.

The Prohibition of Import (No. 11) Proclamation, 1916, is hereby revoked.

This Proclamation may be cited as the Prohibition of Import (No. 12) Proclamation, 1916.

Given at Our Court at Buckingham Palace, this Fifth day of December, in the year of our Lord One thousand nine hundred and sixteen, and in the Seventh year of Our Reign.

#### PRESENT:

The KING's Most Excellent Majesty in Council.

THEREAS by an Order in Council, dated the twenty-eighth day of November nineteen hundred and fourteen, His Majesty was pleased to make regulations (called the "Defence of the Realm (Consolidation) Regulations, 1914"), under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the realm:

And whereas the said Act has been amended by the Defence of the Realm (Amendment) Act, 1915, the Defence of the Realm (Amendment) (No. 2) Act, 1915, and the Munitions of War Act, 1915:

And whereas the said regulations have been amended by various subsequent Orders in Council:

And whereas it is expedient further to amend the said regulations in manner hereinafter appearing:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following amendments be made in the said regulations :-

- 1. After regulation 2k the following regulation shall be inserted :-
- "2L.—(1) Where the Board of Agriculture and Fisheries are of opinion that, with a view to maintaining the food supply of the country, it is expedient that they should exercise the powers given to them under this regulation as respects any land, the Board may enter on the
  - (a) without any consent, if the land is for the time being unoccupied, or was unoccupied on the twenty-ninth day of November nineteen hundred and sixteen, or if the land is common land, and
  - (b) in any other case, with the consent of the occupier and the person in receipt of the rent of the land,

and cultivate the land, or arrange for its cultivation by any person either under a contract of

tenancy or otherwise.
"(2) The Board may after entry on any land do or authorise to be done all things which they consider necessary or desirable for the purpose of the cultivation of the land or for adapting the land to cultivation, including fencing, and may also during their occupation of the land or on the termination thereof remove any such

fencing or work of adaptation.

(3) Any person who cultivates land under any such arrangement shall, on the determination by or on behalf of the Board, of the arrangement, if the determination takes effect before the first day of January nineteen hundred and eighteen, receive from the Board such compensation as may have been agreed under the terms of the arrangement, or, in default of any such agreement, as the Board may consider just and reasonable, and shall not be entitled to any other compensation."

"(4) On the determination of the occupation of any land by the Board under this regulation, compensation shall be paid by the Board to any person injuriously affected by any de-terioration of the land caused by the exercise of the powers under this regulation, the amount of that compensation to be determined, in default of agreement, by a single arbitrator under and in accordance with the provisions of the Second Schedule to the Agricultural

Holdings Act, 1908. "(5) The Board may with respect to any land authorise any local authority to exercise on behalf of the Board any of the powers of

the Board under this regulation.

"(6) In this regulation the expressions occupied' and 'unoccupied' refer to such occupation as involves liability to payment of poor rates, and the expression common land' includes any land subject to be enclosed under the Inclosure Acts, 1845 to 1882, and any town or village green and any other land subject to any right of common.

- "(7) This regulation (except the last preceding subsection) shall apply to Scotland with the substitution of the Board of Agriculture for Scotland for the Board of Agriculture and Fisheries, of arbiter for arbitrator, and of the Agricultural Holdings (Scotland) Act, 1908, for the Agricultural Holdings Act, 1908; and as regards Scotland 'unoccupied land' shall mean land in respect of which no person was entered as tenant or occupier in the valuation roll for the year ending on the fifteenth day May nineteen hundred and seventeen.
- 2. At end of Regulation 9c the following proviso shall be inserted :-
- "Provided that it shall be lawful for His Majesty, in lieu of appointing such other day to be a Bank Holiday or public holiday by Proclamation to direct that all or any classes of employees who have been deprived in consequence of any Proclamation issued under the said Act or this regulation of a holiday to which they were by statute or agreement entitled or which they have been accustomed to receive shall, subject to any exceptions and conditions that may be contained in the Proclamation, be given an equivalent holiday on such day or within such period as may be specified in the Proclamation, and any employer failing to comply with the provisions of any such Proclamation shall be guilty of a summary offence against these regulations.'
- 3. The following regulation shall be substituted for Regulation 30E:-
- "30E. A person shall not melt down, break up, or use otherwise than as currency, any gold coin which is for the time being current in the United Kingdom or in any British possession or foreign country; and if any person acts in contravention of this regulation he shall be guilty of a summary offence against these

regulations.

"If any person contravenes or fails to comply wth any directions in an order made under this regulation he shall be guilty of a summary offence against these regulations."

4. In regulation 39, after the words "specified in the order" there shall be inserted the words "for enabling the competent naval or military authority to direct that in the case of any particular vessel pilotage is compulsory.'

In the same regulation, after the words "payment of pilots" there shall be inserted the words "Where under this regulation "pilotage is compulsory in respect of any "vessel it shall be obligatory for the vessel to "obtain the services either of a pilot authorised "for the purpose by the Admiralty, or, within "the limits of any specially defined pilotage district, of a pilot licensed by the pilotage authority of the district, or, without such "limits, of a pilot holding a deep sea licence or " certificate."

- 5. The following regulation shall be substituted for Regulation 40B. :-
- "40B.-(1) If any person sells, gives, procures, or supplies, or offers to sell, give, procure, or supply, cocaine to or for any person, other than an authorised person, in the United Kingdom, he shall be guilty of a summary offence against these regulations unless he proves that the following conditions have been complied with :-

- accordance with a written prescription of a duly qualified medical practitioner and dispensed by a person legally authorised to dispense such prescription:
- (b) the prescription must be dated and signed by the medical practitioner with his full. name and address and qualifications, and marked with the words 'Not to be repeated,' and must specify the total amount of cocaine to be supplied on the prescription, except that, where the medicine to be supplied on the prescription is a proprietary medicine, it shall be sufficient to state the amount of the medicine to be supplied:
- (c) cocaine shall not be supplied more than once on the same prescription except in pursuance of fresh directions duly endorsed on the prescription by the medical practitioner by whom it was originally issued, and signed with his name in full, and dated:
- (d) the name of the person, firm, or body corporate, dispensing the prescription, the address of the premises at which and the date on which it is dispensed must be marked on the prescription;
- (e) the ingredients of the prescriptions so dispensed, with the name and address of the person to whom it is sold or delivered, shall be entered in a book specially set apart for this sole purpose and kept on the premises where the prescription is dispensed, which book shall be open to inspection by any person authorised for the purpose by a Secretary of State.

"(2) If any medical practitioner gives a prescription for the supply of cocaine otherwise than in accordance with the foregoing provisions he shall be guilty of a summary offence against these regulations.

"(3) If any person manufactures or carries on any process in the manufacture of cocaine, without a licence from a Secretary of State, or otherwise than in accordance with any conditions attached to the licence, he shall be guilty of a summary offence against these regulations.

(4) If any person, other than an authorised person or a person licensed to import or to manufacture cocaine, has in his possession any cocaine, he shall be guilty of a summary offence against these regulations unless he proves that the cocaine was supplied on and in accordance with such a prescription as aforesaid.

"(5) If any person sells any article into the composition of which cocaine enters, in a package or bottle which has not plainly marked on it the amount and percentage of cocaine in the article, he shall be guilty of a summary offence against these regulations.

"(6) If any person sells, gives, procures, or supplies, or offers to sell, give, procure, or supply, opium to or for any person, other than an authorised person, in the United Kingdom, or if any person, not being an authorised person or a person licensed to import opium, has any opium in his possession, he shall be guilty of a summary offence against these

regulations.

"(7) If any person prepares opium for (a) the cocaine must be supplied on and in smoking, or deals in or has in his possession any opium so prepared, he shall be guilty of a | summary offence against these regulations.

- "(8) Every person who deals in cocaine or opium shall keep a record, in such form as may be prescribed by a Secretary of State, of all dealings in cocaine or opium effected by him (including sales to persons outside the United Kingdom), and if he fails to do so he shall be guilty of a summary offence against these regulations; every such record shall be open to inspection by any person authorised for the purpose by a Secretary of State.
- "(9) If any person holding a general or special permit from a Secretary of State to purchase or to be in possession of any drug to which this regulation applies fails to comply with any of the conditions subject to which the permit is granted, he shall be guilty of a summary offence against these regulations.
- "(10) If any authorised person is convicted of any offence under this regulation or under any proclamation regulating the import or export of cocaine or opium a Secretary of State may direct that he shall cease to be an authorised person for the purposes of this regulation.

"(11) For the purposes of this regulation-

The expression 'authorised person' means a duly qualified medical practitioner, a registered dentist, a registered veterinary surgeon, a person, firm, or body corporate carrying on the retail business of a chemist and druggist under and in accordance with the provisions of the Pharmacy Act, 1868, as amended by the Poisons and Pharmacy Act, 1908, a person carrying on such business in Ireland under and in accordance with the provisions of the Pharmacy Act (Ireland) 1875, as amended by the Pharmacy Act (Ireland) (1875) Amendment Act, 1890, a licentiate of the Apothecaries' Hall in Ireland, or a person holding a general or special permit from a Secretary of State to purchase or to be in possession of the drug in question;

The expression 'cocaine' includes all preparations, salts, derivatives, or admix-tures prepared therefrom or therewith and containing 0.1 per cent. (one part in a thousand) or more of the drug, or any solid or liquid extract of the coca leaf containing 0.1 per cent. or more of the drug;

The expression 'opium' means raw opium or powdered or granulated opium;

Cocaine or opium in the order or disposition of any person shall be deemed to be in his possession.'

6. After regulation 45B, the following regulation shall be inserted:

"45c. The Army Council may require any person who holds, or in respect of whom an application has been made for, a certificate of exemption from military service under the Military Service Acts, 1916, or otherwise, or any person who having held such a certificate is not for the time being liable to be called up for service with the colours, to present himself for medical examination, if such person has not already been examined by a medical board, and, in accordance with the instructions of the 10th day of November 1915, the said area

the Army Council for the time being in force, placed in a medical category.

If any person fails to comply with any requirement under this regulation, he shall be guilty of a summary offence against these regulations."

- 7. After Regulation 53A the following regulation shall be inserted :-
- "53B. For the purpose of testing the accuracy of any information given in pursuance of the Munitions of War Acts, 1915 and 1916, to the Minister of Munitions by the owner of any establishment with respect to persons employed in the establishment or of obtaining information in any case where such information is not given as and when so required in pursuance of those Acts, or for the purpose of testing the accuracy of any record, register, list, statement, particulars, or information required to be kept, made, or given in pursuance of Regulation 41A, it shall be lawful for the competent naval or military authority or any person duly authorised by him to enter any premises belonging to or in the occupation of the person giving, or who has failed to give, the information, and to carry out such inspections and examinations (including the inspection and examination of books) on the premises as he may consider necessary for any of the purposes aforesaid.

"If any person obstructs or impedes any person in the exercise of any of his powers under this regulation, or refuses to answer or gives a false answer to any question or refuses or fails to produce any books or documente required for the purposes of this regulation, that person shall be guilty of a summary offence against these regulations."

And whereas by an Order in Council, dated

was extended in manner therein provided, and the | CENTRAL CHANCERY OF THE ORDERS said Regulations and any Regulations amending the same were thereby applied to an area known as the North-East Coast Area and defined in the Schedule to the said last-mentioned Order:

And whereas it appears to His Majesty to be expedient that the said North-East Coast areas should be extended, and that the Petty Sessional Division of Morpeth Ward, in the County of Northumberland, and the Parishes of Roxby, Borrowby, Hinderwell, Ellerby, Mickleby, Ug-thorpe, and Newton Mulgrave, in the Petty Sessional Division of Whitby Strand, in the North Riding of the County of York, should be added thereto:

And whereas it appears to His Majesty that it is expedient for the purpose of the successful prosecution of the present War that the sale and supply of intoxicating liquor in the area thereby constituted and defined and specified in the Schedule hereto should be controlled by the State on the grounds that war material is being made, loaded, unloaded, and dealt with in transit therein, and that men belonging to His Majesty's Military Forces are assembled therein:

The Defence of the Realm (Liquor Control) Regulations, 1915, and any Regulations amending the same, shall be, and are hereby, applied to the area defined and specified in the Schudule hereto.

The Minister of Munitions further orders that any particulars so furnished shall be verified by the signature of the person required to furnish the same, or where such person is a firm or company by the signature of a Partner, Director or other responsible Officer.

In recognition of the skill and gallantry which they displayed on the morning of the 28th November 1916, in pursuing out to sea and attacking at close range a Zeppelin, which had been engaged in a raid on England. Both officers were exposed to machine-gun fire throughout their attacks.

In pursuance of Regulation 10s of the Defence of the Realm (Consolidation) Regulations, 1914, I hereby make the following Order amending the Order of the 28th October 1916, hereinafter referred to as the principal Order:—

- (1) The principal Order shall not apply during the period from the 18th December 1916 to the 5th January 1917, both days inclusive.
- (2) For the purposes of the principal Order and this Order on and after the 5th January 1917, the term refreshments shall not be deemed to include sweets, chocolate, or other sugar confectionery or ice cream.
- (3) In the case of canteens attached to and situated within or in the immediate vicinity of any works, if persons are employed at such works after the closing hour, and the canteen is kept open only for the use of such persons, meals or refreshments may, notwithstanding anything in the principal Order, be sold after the closing hour for consumption anywhere within the works' premises.
- (4) In the case of railways (a) meals or refreshments (b) periodicals and books may be sold after the closing hour on the railway premises to persons about to travel by rail.
- (5) The principal Order shall not apply to any bazaar or sale of work for charitable or other purposes from which no private profit is derived.
  - (6) This Order shall apply throughout Scotland.

# DEFENCE OF THE REALM (LIQUOR CONTROL).

ORDER OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) SUPPLEMENTAL TO THE ORDER MADE ON THE 30TH DAY OF NOVEMBER 1916, FOR THE ORKNEY AND SHETLAND AREA WITH REFERENCE TO MEDICATED WINES AND NEW EXCISE LICENCES.

Any person contravening any provision of this Order or of the Liquor Control Regulations is liable to imprisonment for six months with hard labour and a fine of £100.

WE, the Central Control Board (Liquor Traffic), in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm, hereby make the following Order supplemental to the Order made on the thirtieth day of November 1916, for the Orkney and Shetland Area.

Conditions as to the Sale of Medicated Wines.

- 1. On and after the eighteenth day of December 1916, no person shall either by himself or by any servant or agent sell or supply to any person in any licensed premises for consumption off the premises or dispatch therefrom any exciseable liquor in the form of or prepared as (a) medicated wine or (b) any mixture or preparation which contains any drug or medicament or is sold or advertised for sale as containing or purporting to contain medicinal properties except in a bottle or other vessel bearing a label correctly stating in clear and legible words or figures the amount of proof spirit contained in such medicated wine or mixture or preparation. Provided always that nothing herein shall be deemed to affect the sale
  - (a) Any medicine mixture or preparation appearing in the British Pharmacopeia or the British Pharmaceutical Codex; or
  - (b) Any medicine mixture or preparation which is made up for a customer on the signed prescription of a medical practitioner; or
  - (c) Medicated or methylated spirits or spirits made up in medicine and sold by medical practitioners or chemists or druggists.
- 2. (a) The expression "licensed premises" in the foregoing Article includes any premises or place where the sale of intoxicating liquor for consumption off the premises is carried on under a licence.
- (b) The foregoing Article does not affect the sale or dispatch of exciseable liquor to a trader for the purposes of his trade.

Restrictions on the Sale of Exciseable Liquor under new Excise Licences.

3. No person shall, except with the written authority of the Central Control Board (Liquor Traffic) and in accordance with the terms and conditions subject to which such authority may be granted, either by himself or by any servant or agent, sell or supply in any premises any exciseable liquor under an excise licence granted in respect of such premises on or after the eighteenth day of December 1916, unless an excise licence authorising such sale was in force in respect of such premises on the seventeenth day of December 1916.

Provided always that nothing in this Article shall be deemed to affect the sale of exciseable liquor under—

- (a) An excise licence granted on the authority of a Certificate as defined in Part VII of the Licensing (Scotland) Act, 1903; or
- (b) An excise licence granted to any person holding a canteen under the authority of a Secretary of State or of the Admiralty; or
- (c) A manufacturer's licence.

ADMIRALTY NOTICE TO MARINERS.

No. 1349 of the year 1916.

SCOTLAND NORTH-EAST COAST, ORKNEY AND SHETLAND ISLES.

Former Notices.—Nos. 245, 898, 969, 1092 and 1215 of 1916.

Notice is hereby given that, under the Defence of the Realm (Consolidation) Regulations, 1914, the following Regulations have been made by the Lords Commissioners of the Admiralty, and are now in force:—

(1) Pentland and Moray Firths—Restriction of Traffic; Pilotage Regulations.

The following regulations have been made with a view to safeguarding the interests of shipping in the Pentland and Moray Firths:—

#### I.—RESTRICTION OF TRAFFIC.

- No vessel, either British, Allied or Neutral, is to be in the area indicated in red on the accompanying portion of Admiralty Chart No. 2, from half an hour after sunset to half an hour before sunrise, unless at anchor. No vessel, however, is to anchor:—
  - (a) Anywhere along the coast between Tarbet ness and North Sutor, except within one mile radius of Balintore;
  - (b) Anywhere off the south shore of the Moray Firth between the meridians of Port Gordon and Burghead, except within three-quarters of a mile of the low water mark;
  - (c) Outside a distance of one mile of the coast in any other portion of the area indicated in red.
- 2. Vessels proceeding to ports in the Moray
  Firth should therefore endeavour to enter
  the firth in time to reach their destinations
  not later than half an hour after sunset.
  Should they not reach their destinations
  by that time they are to anchor, weather
  permitting, subject to the restrictions given
  in clause I.
- Any vessel contravening the foregoing regulations will run the gravest risk of being sunk.

Caution.—Neutral or Allied vessels are particularly warned that the passage through the Pentland Firth presents very grave risks to a Westbound vessel, and are strongly advised not to take it.

# II.-PILOTAGE REGULATIONS.

Pilotage is compulsory at the undermentioned ports for all vessels (including fishing vessels) which have a draught of over eight feet, and it is highly dangerous for any vessel to enter or leave such ports without a pilot. Fishing and other small vessels having a draught of over eight feet are to assemble at the Pilotage stations, and will be conducted into and out of port in groups.

1. All vessels bound to Cromarty or Inverness must call for a pilot at Wick or Burghead.

Outgoing vessels are to discharge their pilots at one or the other of these places.

2. It is dangerous for any vessel to be under way to the south-westward of a line joining Tarbet ness and Findhorn without a pilot.

3. No vessels of any description other than H.M. Ships and Auxiliaries are to be under way between sunset and sunrise in the waters contained between a line drawn from Tarbet ness to Findhorn, and a line drawn from Fort George to Chanonry point.

# (2) ORKNEY ISLES, SCAPA FLOW—TRAFFIC REGULATIONS.

1. All entrances are dangerous and entry is absolutely prohibited by any of them except as

provided in succeeding paragraphs.

2. Examination services have been established in the entrances to Hoxa and Hoy sounds; vessels directed to enter must communicate with the Examination vessel and follow the instructions received from her very carefully.

3. No vessel is permitted to approach the entrance to Hoxa sound within a radius of 5 miles under any circumstances whatever, except when actually ordered to Scapa Flow. Vessels ordered to Kirkwall should proceed direct to that port.

4. The only vessels permitted to enter Hoy sound from the westward are those ordered to Stromness.

5. Vessels are not permitted to enter Hoxa or Hoy sounds by night or in thick weather.

6. Passage through Cantick sound is entirely prohibited.

# (3) SHETLAND ISLES—TRAFFIC OF NEUTRAL VESSELS PROHIBITED.

No vessels other than those of British Nationality or those of the Allied Nations, except vessels calling for the purpose of Examination, shall enter any ports or harbours in, or anchor off any part of, the coasts of the Shetland Isles until further notice.

# Note.

This Notice is a re-publication of Notices Nos. 245 and 1215 of 1916, and former Notices.

#### CAUTION.

This Admiralty Notice to Mariners is issued under the provisions of the Defence of the Realm (Consolidation) Regulations, 1914, and failure to comply strictly with the directions contained in it will constitute an offence against those Regulations.

Any person found guilty of such an offence is liable to severe penalties both of imprisonment and fine.

Any person aiding or abetting the commission of such an offence is himself guilty of an offence against the Regulations.

Attention is also drawn to the fact that any infringement of the directions contained in this Admiralty Notice to Mariners is liable to result in the detention of the ship or vessel.
