PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 17th day of January 1917, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, and other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas we have had under consideration Chapter LII of the Regulations for the Government of Your Majesty's Naval Service, wherein are laid down the Scales of Pensions and Gratuities which may be awarded for wounds and injuries received 'in action' or 'not in action':

"And whereas we are of opinion that Quartermasters, Royal Marines, should be eligible for Disability and Wounds Pensions, under the Regulations for Commissioned Officers:

"And whereas we are of opinion that, having regard to the circumstances of the present Hostilities, it is desirable to fix minimum Pensions and Gratuities for Commissioned Warrant and Warrant Officers of the Navy, Coast Guard, Marines and Reserves, wounded or injured during the period of the War, as has already been done in the case of Commissioned and Subordinate Officers:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the following Regulations.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.

" REGULATIONS.

"Commissioned Warrant Officers and Warrant Officers on the Permanent, Supplementary, or Temporary Lists, of the Navy, Coast Guard, Marines, and Reserves, who, during the present War, have lost, or may lose, an eye or a limb, or the use of an eye or a limb, or have received, or may receive, an injury equivalent, or nearly equivalent thereto, to be eligible, at the discretion of the Admiralty, for a minimum award for each limb or eye, or reach injury equivalent or nearly equivalent thereto, as follows:—

I.-IN ACTION.

COMMISSIONED WARRANT OFFICERS.

(a) A Gratuity of £250 for the first year and,

(b) A Pension of £100 a year, commencing 12 months after the date of the loss or injury.

(c) No Officer who loses the sight of both eyes as the result of injuries received in action to be awarded less than £225 a year in all.

WARRANT OFFICERS.

(a) A Gratuity of £200 for the first year, and

(b) A Pension of £75 a year commencing 12 months after the date of the loss or injury.

(c) No Officer who loses the sight of both eyes as the result of injuries received in action to be awarded less than £175 a year in all.

II.—OTHERWISE THAN IN ACTION.

Commissioned Warrant Officers and Warrant Officers to receive Pensions of £75 and £50 a year respectively, commencing from the date of the loss or injury.

The above Rates of Pensions to apply to Noncombatant Officers, according to relative rank, to Marine Warrant Officers, Class I, and to Coast Guard Officers: Divisional Chief Officers of Coast Guard, and Chief Officers, Permanent Cruiser Service, ranking for this purpose as Commissioned Warrant Officers, and Chief Officers of Stations and late in charge of Batteries, together with Senior Mates and Second Mates of the Permanent Cruiser Service, ranking as Warrant Officers.

The awards to be governed by similar rules to those laid down for Commissioned and Subordinate Officers in the Order in Council of the 29th February 1916.

Men granted Acting Warrant Rank and Officers with Acting Rank on the Permanent, Temporary, or Reserve Lists to be dealt with as if they were confirmed in the Acting Rank.

QUARTERMASTERS, R.M., DISABILITY PENSIONS, &c.

If on the Permanent List—as laid down in the Army Regulations (vide Section A (3) of Order in Council, 29th February 1916).

If on the Reserve or Temporary List—on the scale laid down in Section B of Order in Council, 29th February 1916.

Wounds, &c., Pensions, &c.

Whether on the Permanent, Reserve, or Temporary List—on the scale laid down in Order in Council, 29th February 1916."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

The KING has been graciously pleased to confer the Decoration of the Albert Medal of the Second Class upon Mr. Joseph Conolly, Third Engineer of the steamship "Vanellus," of Cork.

The following is an account of the services in respect of which the Decoration has been conferred:—

On the 1st October 1916, the steamship "Vanellus," of Cork, struck a mine in Havre

Roads, and the vessel, which was laden with

petrol, immediately burst into flames.

Owing to the rapidity with which the flames spread it was impossible to clear away the boats, and most of the crew jumped overboard. Three lives were lost by the casualty.

Although the engine-room telegraph was broken by the explosion Mr. Conolly remained at his post in the engine-room until every one else had left the ship. He kept the engines working astern, and thus made it possible for a lifeboat to be lowered on the port side, and by this means a number of lives were saved.

Before finally leaving the ship he again went

below and stopped the engines.

Mr. Conolly was badly burnt in rendering the services.

MINUTE OF APPOINTMENT PAPER BOX TRADE BOARD (GREAT BRITAIN).

THE term of office of the Trade Board for the making of Boxes or parts thereof made wholly or partially of paper, cardboard, chip or similar material in Great Britain, established on 22nd August 1913, in accordance with the Regulations made by the Board of Trade for that trade dated 27th April 1910, having expired as provided in paragraph 6 of the said Regulations; in pursuance of the powers conferred upon me by the Trade Boards Act, 1909, and the New Ministries and Secretaries Act, 1916, I hereby establish a new Trade Board for the said trade, constituted in accordance with the Regulations dated 18th October 1916, made by the Board of Trade in substitution for those dated 27th April 1910.

* Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
