At the Council Chamber, Whitehall, the 2nd day of February 1917.

By the Lords of His Majesty's Most Honourable Privy Council.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom, from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation :

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State, such List as so varied or added to being in the last mentioned Proclamation referred to as the "Statutory List" :

And whereas the List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council :

And whereas there was this day read at the

Board a recommendation from the Secretary of State for Foreign Affairs to the following effect :—

That the "Statutory List" of persons and bodies of persons, incorporated or unincorporated, with whom trading is prohibited, should be further amended by the variation and addition of the names set forth in the Schedule hereto.

Now, therefore, their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

NOTE (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having any dealings with any of the persons or firms mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3. A List consolidating all previous Lists was published on the 22nd December 1916 (The Consolidating List No. 15a), which, together with Lists No. 16 and 17 of the 5th and 19th January 1917 respectively, and the List herewith annexed, contains all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

NOTE (2).—Where a person or firm mentioned in the List has more than one address in the same country, all dealings in that country with such person or firm are prohibited, even in cases where one only of the addresses is specifically mentioned.

*NOTE (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November 1915 with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

NOTE (4).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes without the necessity of referring the matter abroad. The Department is, however, prepared on application to enquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is

required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making enquiries would specify the particular trade or trades for which substitutes are required.

NOTE (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's representatives in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The Lists for all countries in Central or South America are also telegraphed to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade.

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the 10th day of May 1916, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited:

And whereas by subsequent Orders of Council the said Proclamation was amended and added to in certain particulars:

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect:—

That the Proclamation, dated the 10th day of May 1916, as amended and added to by subsequent Orders of Council should be further amended by making the following amendments in and additions to the Schedule to the same:—

(1) No person shall as from the date hereof until further notice purchase, sell, or, except for the purpose of carrying out a contract in writing existing prior to such date for the sale or purchase of lead, enter into any transaction or negotiation in relation to the sale or purchase of lead situated outside the United Kingdom except under and in accordance with the terms of a licence issued under the authority of the Minister of Munitions.

(2) No person shall as from the date hereof until further notice purchase or take delivery of any lead situated in the United Kingdom except under and in accordance with the terms of a licence issued under the authority of the Minister of Munitions, or sell, supply or deliver any such lead to any person other than the holder of such a licence and in accordance with the terms thereof; provided that no such licence shall be required in the case of any sale, purchase or delivery of such lead.

(a) For the purpose of a contract or order for the time being in existence certified to be within Classes "A" or "B" of Circular L.33 as to Control of Output issued by the Minister of Munitions on the 31st day of March 1916, where the price paid upon such sale or purchase does not in the case of virgin pig lead exceed £29 per ton net and in the case of remelted lead, or old or scrap lead, exceed £26 per ton net.

(b) For the purpose of necessary repairs or renewals involving the use of not exceeding 1 cwt. of such lead.

(3) No person shall as from the date hereof until further notice use any lead for the purpose of any manufacture or work except:—

(a) For the purpose of a contract or order for the time being in existence certified to be within Classes "A" or "B" of Circular L.33 as to Control of Output issued by the Minister of Munitions on the 31st day of March 1916.

(b) For the purpose of necessary repairs or renewals involving the use of not exceeding 1 cwt. of lead.

(c) For the purpose of type casting from lead already in the form of type or purchased for that purpose at the date hereof.

(d) Under and in accordance with the terms of a Licence issued under the authority of the Minister of Munitions.

(4) All persons shall within ten days from the first day of February 1917, and within seven days from the first day of each succeeding month send in to the Director of Materials (A.M.2.(E)), Hotel Victoria, Northumberland Avenue, London, S.W., Monthly Returns of:—

(a) All lead held by them in stock or otherwise under their control on the last day of the preceding month.

(b) All lead purchased or sold by them for future delivery and not yet delivered on such last day together with the names of the sellers to or purchasers from them.

(c) All lead delivered to them during the preceding month.

(d) All contracts or orders existing on the last day of or entered into during the preceding month requiring for their execution the use of lead for any purpose specifying the amounts of lead required weekly for the purposes of such contracts or orders and distinguishing between the amounts required for Classes "A" and "B" respectively of Circular L.33, and the amounts required for other purposes.

Notwithstanding the above no return is required from any person whose total stock of lead in hand and on order for future delivery to him has not at any time during the preceding month exceeded 1 cwt.

(5) For the purpose of this Order the expression lead shall mean pig lead, whether virgin or remelted, sheet lead, lead pipe, and old and scrap lead or any of them.

(6) All applications for licences to purchase or use lead shall be made to:—

and marked "Lead Licence."

NOTE.—Licences to purchase and take delivery of lead situated in the United Kingdom will usually be granted by the Minister of Munitions under the above Order for necessary repairs and renewals in the ordinary course of trade, and will also be granted for any other purposes which may be approved by the Minister of Munitions, including manufacture for the purposes of Export Trade.

Every applicant for a licence must state the amount of metal required by him per month and the use to which it will be put.

Any person acting in contravention of or failing to comply with the above Order will be guilty of an offence under the Defence of the Realm Regulations and be liable to penalties of fine and imprisonment.

The KING has been graciously pleased to approve of the posthumous grant of the Victoria Cross to the undermentioned officers in recognition of their conspicuous gallantry in an attempt to re-provision the force besieged in Kut-el-Amara:—

Lieutenant Humphry Osbaldeston Brooke Firman, R.N.

Lieutenant-Commander Charles Henry Cowley, R.N.V.R.

The General Officer Commanding, Indian Expeditionary Force "D," reported on this attempt in the following words:—

"At 8 p.m. on April 24th, 1916, with a crew from the Royal Navy under Lieutenant Firman, R.N., assisted by Lieutenant-Commander Cowley, R.N.V.R., the 'Julnar,' carrying 270 tons of supplies, left Falahiyah in an attempt to reach Kut.

"Her departure was covered by all Artillery and machine gun fire that could be brought to bear, in the hope of distracting the enemy's attention. She was, however, discovered and shelled on her passage up the river. At 1 a.m. on the 25th General Townshend reported that she had not arrived, and that at midnight a burst of heavy firing had been heard at Magasis, some 8½ miles from Kut by river, which had suddenly ceased. There could be but little doubt that the enterprise had failed, and the next day the Air Service reported the 'Julnar' in the hands of the Turks at Magasis.

"The leaders of this brave attempt, Lieutenant H. O. B. Firman, R.N., and his assistant—Lieutenant-Commander C. H. Cowley, R.N.V.R.—the latter of whom throughout the campaign in Mesopotamia performed magnificent service in command of the 'Mejdieh'—have been reported by the Turks to have been killed; the remainder of the gallant crew, including five wounded, are prisoners of war.

"Knowing well the chances against them, all the gallant officers and men who manned the 'Julnar' for the occasion were volunteers. I trust that the services in this connection of Lieutenant H. O. B. Firman, R.N., and Lieutenant-Commander C. H. Cowley, R.N.V.R., his assistant, both of whom were unfortunately killed, may be recognised by the posthumous grant of some suitable honour."

ARMY COUNCIL ORDER.

HIDES.

In pursuance of the powers conferred upon them by the Defence of the Realm (Consolida-

tion) Regulations, 1914, the Army Council hereby regulate and restrict the purchase, sale, delivery of or payment for or other dealing in any Hides of the descriptions specified in Schedule "A" hereto annexed as follows, that is to say :

1. No person, unless holding a special permit from the Director of Army Contracts for the purpose, shall purchase, sell, deliver, pay for, or enter into any transaction or negotiation in relation to the purchase, sale, delivery of or payment for, any Hides of the descriptions aforesaid at a price exceeding by more than one per cent. the price at which the said Hides were sold by or on behalf of the Importer thereof into the United Kingdom.

2. The following persons, unless holding a special permit from the Director of Army Contracts for the purpose, shall not purchase, sell, deliver, pay for, or enter into any transaction or negotiation in relation to the purchase, sale, delivery of or payment for, any Hides of the descriptions aforesaid, that is to say :

(a) Any person deemed by the Director of Army Contracts to be a Hide Broker carrying on business in accordance with the custom and usage prevailing in the London market.

(b) Any person who has infringed any provision or condition of this or of any other paragraph of this Order or of any permit issued thereunder.

3. In addition to all other restrictions imposed by this Order, no Tanner shall purchase any Hides of the descriptions aforesaid without giving to the seller a guarantee in the form set out in Schedule "B" hereto annexed, and no person shall sell or deliver such Hides to a Tanner without the receipt of such guarantee.

4. It shall be the duty of all parties to any of the transactions herein specified to require or disclose, as the case may be, all such information as may be necessary for or required by such parties as aforesaid or by the Director of Army Contracts for the purpose of satisfying them or him that the provisions of this Order have not been contravened.

5. Permits hereunder may be issued by or on behalf of the Director of Army Contracts whereby any further and other restrictions or conditions may be imposed in respect of any of the transactions herein specified.

6. All persons engaged in any of the transactions herein specified shall cause books to be kept in which shall be entered forthwith the name, address and trade or occupation of the persons with whom any such transactions have been carried on, and full details as to the nature of such transactions. All such persons shall furnish to the Director of Army Contracts such particulars as to their business or to any such transactions as may be required on his account.

7. Nothing in this Order shall apply to persons engaged solely in the shipment, forwarding, carriage, storage or insurance of Hides.
