At the Council Chamber, Whitehall, the 23rd day of March 1917.

By the Lords of His Majesty's Most Honourable Privy Council.

HEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State, such List as so varied or added to being in the last mentioned Proclamation referred to as the "Statutory List":

And whereas the List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of

State for Foreign Affairs to the following effect:—

That the "Statutory List" of persons and bodies of persons, incorporated or unincorporated, with whom trading is prohibited, should be further varied in respect of the name set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.
