THE SWAN LAND & CATTLE COMPANY
LIMITED.

A PETITION has been presented to the Lords of Council and Session (Second Division,—Mr. Antonio, Clerk) by the Swan Land and Cattle

Company Limited, incorporated under the Companies Acts, 1862 to 1880, and having its Registered Office at No. 24 Charlotte Square, Edinburgh, setting forth *inter alia* a Scheme of Arrangement between the Company and the Ordinary and the Preference Shareholders, under which it is proposed that in substitution for the preference shares of the Company of the nominal amount of £100,000 fully paid, there should be paid to the holders of these shares a sum in cash equal to one-half of the nominal amount of said shares, and that there should be issued to said Preference Shareholders debenture stock for an amount equal to the remaining one-half of the amount of their said shares, with interest on said cash payment and on the debenture stock at the rate of 6% per annum from 31st December 1916, and that the said preference shares and all claims to dividend thereon should be cancelled; and praying their Lordships *inter alia* to direct separate Meetings of the Members of the Company, of the Preference Shareholders, and of the Ordinary Shareholders to be held for the purpose of taking into consideration, and, if so advised, agreeing to the scheme; to fix the date with reference to which the list of Creditors of the Company within the meaning of Section 49 of the Companies (Consolidation) Act, 1908, shall be made up; to appoint the Company to lodge in process a list of such Creditors entitled to object to the said proposed reduction; to fix the date on or before which the Creditors of the Company not entered on such list so to be made up are to claim to be so entered or are to be excluded from the right of objecting to the said proposed reduction; to appoint advertisement of the Petition and of the dates so fixed to be made once in each of the Edinburgh Gazette and Scotsman newspapers; to settle the list of Creditors entitled to object to the said proposed reduction; to dispense with the consents of Creditors whose debts have not been discharged or secured, and who have not consented to the said proposed reduction upon the Company securing payment of their debts or claims in terms of the said Act; to find that the consents of all other Creditors entitled to object to the said proposed reduction have been obtained, or that the debts and claims have been discharged or secured; to pronounce, subject to the passing and confirming of the after-mentioned Special Resolution relative to the said proposed reduction of share capital, orders sanctioning the arrangement as set forth in the said scheme (a copy of which is annexed to the Petition),
