HEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 12th day of November 1917, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas by Order in Council bearing date the 14th day of May 1912, sanction was given for the payment, at our discretion, of an allowance of threepence a day to any Seaman employed on clerical duties with the Gunnery Lieutenant in any of Your Majesty's Ships or Naval Establishments:

"And whereas in certain cases it is now found necessary to employ Seamen on clerical duties connected with the Torpedo Returns and Reports rendered by Your Majesty's Ships and Naval Establishments:

"And whereas we are of opinion that the extra work entailed should be recognised by the grant of an allowance similar to that payable

to Seamen employed on clerical duties with Gunnery Lieutenants:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction, as from the 21st day of May 1917, the payment, at our discretion, of an allowance of threepence a day to any Seaman employed on clerical duties with the Torpedo Lieutenant or Mate (T) in any of Your Majesty's Ships or Naval Establishments.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being, or having been, an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas we consider that the opportunity of attaining Commissioned Warrant Rank should be extended to the Ship's Cook Class, and that the number of appointments to the Warrant Rank of Instructor-in-Cookery which is available for this Class should be increased, and

the pay of that Rank improved:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council, to approve of the following proposals, with effect as from the 20th day of October 1917 :-

"1. The number of Instructors-in-Cookery to be increased to 10, and the pay of this rank to be raised to the following rates:-

On promotion, 7s. a day. After 5 years, 8s. a day. After 10 years, 9s. a day.

"2. The Commissioned Warrant Rank of Commissioned Instructor-in-Cookery to be established, and the establishment of these officers to be 3, with rates of pay as follows :-

On promotion, 10s. 0d. a day. After 2 years, 10s. 6d. a day. After 4 years, 11s. 0d. a day. After 6 years, 11s. 6d. a day. After 8 years, 12s. 0d. a day.

"3. Pensions for Commissioned Instructorsin-Cookery, Pensions for hurts and wounds, Widows' Pensions and Compassionate Allowances for Children, to be granted at the rates and under the conditions applicable to Chief Artificer Engineers.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these

proposals."

"Where His Majesty is satisfied that the law in force in any part of His Majesty's Dominions outside the United Kingdom makes due provision for the publication of banns or for the giving of notice in respect of marriages between British subjects intended to be solemnized or contracted in the United Kingdom, and for the recognition of certificates for marriage issued by Superintendent Registrars in England, and of certificates for marriage issued by Registrars, and certificates of proclamation of banns, in Scotland, and of certificates for marriage issued by Registrars in Ireland, as sufficient notice in respect of Marriages between British Sub-jects intended to be solemnized or contracted in that part of His Majesty's Dominions, His Majesty may, by Order in Council, declare that this Section shall apply to that part of His Dominions, and in such case:-

"(a) Where a marriage is intended to be solemnized or contracted in the United Kingdom between a British Subject resident in England, Scotland, or Ireland, and a British Subject resident in that part of His Majesty's Dominions, a certificate of notice of marriage issued in accordance with such law shall in England have the same effect as a certificate for marriage issued by a Superintendent Registrar, and in Scotland and Ireland have the same effect as a certificate for marriage issued by a Registrar in Scotland and Ireland respectively; and

"(b) Where a marriage is intended to be solemnized or contracted in that part of His Majesty's Dominions between a British Subject resident in that part and a British Subject resident in England, Scotland, or Ireland, a certificate for marriage may be issued in England by a Superintendent Registrar, or in Scotland or Ireland by a Registrar, in the like manner as if the marriage was to be solemnized or contracted under circumstances requiring the issue of such a certificate, and as if both such British Subjects were resident in England, Scotland, or Ireland, as the case may be:"

And whereas His Majesty is satisfied that due provision is made in respect of all the matters referred to in the hereinbefore-recited Section of the said Act by the law in force in the parts of His Majesty's Dominions outside the United Kingdom hereinafter mentioned:

Now, therefore, His Majesty, by virtue and in exercise of the powers by the above-recited Act in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:-

Section 1 of the Marriage of British Subjects (Facilities) Act, 1915, shall apply to the parts of His Majesty's Dominions outside the United Kingdom hereunder mentioned:—

> The Bahama Islands. The Island of Barbados. Basutoland. The City and Garrison of Gibraltar. The Island of Grenada.

SPECIAL ACTS (EXTENSION OF TIME)
ACT, 1915.

GLASGOW (TRAMWAYS, BRIDGES, &c.) ACT, 1914.

HEREAS by the Special Acts (Extension of Time) Act, 1915, it is provided interalia that where the time within which a power may be exercised under any Special Act is limited, an application may be made by the person by whom such power may be exercised to the appropriate Government Department for an Order extending that time, and that the Department, if satisfied that the time should be extended, may make an Order accordingly, and it is further provided that no time shall be extended under any such Order for more than a year, without prejudice, however, to the making of any further Order.

And whereas on the 20th day of December 1916, upon the application of the Corporation of the City of Glasgow (hereinafter called "the Corporation"), the Secretary for Scotland made an Order (hereinafter called "the Order of 1916") under the said Special Acts (Extension of Time) Act, 1915, extending for one year, that is to say, until the 7th day of August 1918, the time within which the Corporation may exercise the powers for the compulsory purchase of lands conferred upon them by the provisions of Part V. of the Glasgow (Tramways, Bridges, &c.) Act, 1914 (hereinafter called "the Act of 1914"), so far as regards certain Tramways, Street Works and Bridges: and the time within which the construction of certain of the tramways authorised by the Act of 1914 may be commenced.

And whereas the Corporation have applied to the Secretary for Scotland for an Order further extending the said time:

And whereas I am satisfied that the said time should be so extended.

Now therefore in pursuance of the powers vested in me by the said Special Acts (Extension of Time) Act, 1915, I, the Right Honourable Robert Munro, His Majesty's Secretary for Scotland, hereby order as follows:—

1. The time within which the powers of the Corporation for the compulsory purchase of lands under the provisions of Part V. of the Act of 1914 may be exercised, as extended by the Order of 1916, is hereby extended for a period of one year, that is to say, until the 7th day of August 1919 so far as regards the following Tramways, Street Works and Bridges authorised by that Act:—

Tramways Nos. 1 to 15 inclusive, and 17 to 28 inclusive described in Section 6 of the Act of 1914.

Street Works Nos. 1 to 13 inclusive described in Section 11 of the Act of 1914.

Bridges Nos. 1 and 3 described in Section 23 of the Act of 1914.

- 2. The time within which the construction of such of the tramways authorised by the Act of 1914 as will be situate in burghs and districts beyond the city in the counties of Lanark, Renfrew and Dunbarton may be commenced, as extended by the Order of 1916, is hereby extended for a period of one year, that is to say, until the 7th day of August 1919.
- 3. This Order may be cited as the Glasgow (Tramways, Bridges, &c.) Act 1914 (Extension of Time) Order, 1917.

ORDER OF THE BOARD OF TRADE UNDER REGULA-TION 15A OF THE DEFENCE OF THE REALM (CON-SOLIDATION) REGULATIONS, 1914, WITH RESPECT TO INFORMATION AS TO MOTOR SPIRIT.

In pursuance of their powers under Regulation 15A of the Defence of the Realm (Consolidation) Regulations, 1914, the Board of Trade hereby require every person who uses or keeps motor spirit and is for the time being a licensed dealer in motor spirit to supply to the Board, when required by any person authorised by the Board for the purpose, information as to the quantity of motor spirit supplied by him in the form set out in the Schedule to this Order.

If any person fails to comply with this Order or knowingly gives any false information, he is guilty of a summary offence against the Defence of the Realm (Consolidation) Regulations, 1914.

ORDER OF THE BOARD OF TRADE, DATED 13TH JULY 1917; WITH RESPECT TO INFORMATION AS TO MOTOR SPIRIT.

In pursuance of their powers under Regulations 15A and 2G of the Defence of the Realm (Consolidation) Regulations, 1914, the last-mentioned of which Regulations is hereby applied to motor spirit, the Board of Trade do hereby order and require every person who uses or keeps motor spirit and is for the time being a licensed dealer in motor spirit to supply to the Board particulars as to purchases, sales, deliveries, appropriations and stock in hand of motor spirit in such form and at such intervals as may be required.

Unless otherwise ordered the information hereby required shall be sent to the Petrol Control Department of the Board.

If any person fails to comply with this Order or knowingly gives any false information, he is guilty of a summary offence against the Defence of the Realm (Consolidation) Regulations, 1914.

The KING has been graciously pleased to confer the Decoration of the Albert Medal on:—

Surgeon Probationer Robert Sydney Steele Smith, R.N.V.R.

The following is the account of the services in respect of which the Decoration has been conferred:—

Surgeon Probationer Robert Sydney Steele Smith, R.N.V.R., was Medical Officer of one of H.M. ships which was torpedoed by an enemy submarine.

When the enemy torpedo struck the ship Surgeon Probationer Smith was in the wardroom aft with the 1st Lieutenant. The explosion wrecked the wardroom and rendered the 1st Lieutenant unconscious. All other exit being blocked, Surgeon Probationer Smith piled the wrecked furniture under the skylight, and got the 1st Lieutenant through this on deck. He then attended to a Petty Officer who was lying on deck with a broken arm and leg, adjusted and blew up his life-belt, and after doing the same for the 1st Lieutenant got him overboard, as the ship was then foundering.

The 1st Lieutenant was by then partially conscious, but was again stunned owing to an explosion when the vessel foundered, and when he was picked up by the boat he was apparently dead. Surgeon Probationer Smith applied artificial respiration until the 1st Lieutenant showed signs of life; he afterwards attended to the injured in the boat so far as the circumstances allowed, until they were picked up forty-three hours later.

ARMY COUNCIL ORDER.

LAPS OR WASTE (WORSTED AND HOSIERY).

In pursuance of the powers conferred upon them by the Defence of the Realm Regulations, notice is hereby given that it is the intention of the Army Council to take possession, on the 30th day of November 1917, of all Laps or Waste as defined by the Sale of Waste (Worsted and Hosiery) Order, 1917, that may be in possession, custody or control of any person not being a manufacturer of woollen goods, provided that nothing herein contained shall apply to any Laps or Waste of the description aforesaid that shall have been sold to any manufacturer of the description aforesaid prior to the said date.

If after this notice any person having control of any such material without the consent of the Army Council after the 30th day of November 1917, sells, removes, or secretes it, or deals with it in any way contrary to any condition imposed in any licence, permit or order that may have been granted in respect thereof, he shall be guilty of an offence against the said Regulations.

THE HORSE HIDES (LEATHER CONTROL) ORDER, 1917.

In pursuance of the powers conferred upon them by the Defence of the Realm Regulations, the Army Council hereby order as follows:-

1. Notice is given that it is the intention of the Army Council to take possession of all leather to be produced after the date hereof from Raw Hides taken from horses slaughtered in the United Kingdom or the Isle of Man or imported in the wet salted state into the United Kingdom.

If after this notice any person having control of any such leather, without the consent of the Army Council sells, removes or secretes it or deals with it in any way contrary to any conditions imposed in any licence, permit or Order that may have been granted in respect thereto, he shall be guilty of an offence against the said Regulations.

2. This Order may be cited as the Horse Hides (Leather Control) Order, 1917.



CORN PRODUCTION ACT, 1917, AND RULES PUBLICATION ACT, 1893.

Provisional Regulations made by the Board of Agriculture and Fisheries under Section 12 of the First Schedule to the Corn Production Act, 1917, with respect to the establishment and constitution of District Wages Committees and the delegation of powers to Sub-committees.

In pursuance of the provisions of Section 12 of the first Schedule to the Corn Production Act, 1917, and of Section 2 of the Rules Publication Act, 1893, the Board of Agriculture and Fisheries hereby certify that on account of urgency the following regulations with respect to the establishment and constitution of District Wages Committees and the delegation of powers to subcommittees should come into immediate operation, and accordingly make the following regulations to come into operation forthwith as provisional regulations:—

- 1. District Wages Committees shall as soon as practicable be established by the Agricultural Wages Board for the whole of England and Wales, and each such Committee shall act for such area as the Wages Board shall determine, and shall consist of:—
- (a) Representatives of local employers and workmen engaged in agriculture in equal proportions, who are hereinafter referred to as "representative members";
- (b) Additional members (hereinafter called "appointed members") up to a number not exceeding one-fourth of the total number of members of the Committee.

At least one member of each District Wages Committee shall be a woman.

- 2. Any appointed member of the Wages Board shall have the right to attend any meeting of a District Wages Committee and take part in the proceedings, but without the power to vote unless he is an appointed member of the Committee.
- 3. When the Wages Board have determined the area for which a District Wages Committee is to be established they shall furnish a statement thereof to the Board of Agriculture and

Fisheries together with a statement of the number of representative and appointed members respectively of which they propose that the Committee shall consist.

- 4. The Board of Agriculture and Fisheries, after consideration of the statements so furnished by the Wages Board and any suggestions made to them as to persons suitable for nomination to act on the Committee, shall determine the number of representative members and appointed members of which the District Wages Committee shall consist and nominate the persons to act as such members, the nomination of representatives of workmen being made after consultation with the Minister of Labour.
- 5. The Chairman and Deputy-Chairman of each District Wages Committee shall be chosen from among the appointed members of the Committee by the Board of Agriculture and Fisheries.

6. The Secretary of each District Wages Committee shall be appointed from time to time by the Board of Agriculture and Fisheries.

- 7. The Wages Board may, if they think it necessary or desirable in order to secure proper representation of any class of employers or workmen on a District Wages Committee, after giving the Committee an opportunity to be heard, nominate persons to act as additional representatives of local employers and workmen engaged in agriculture in equal proportions to serve for such period, not exceeding two years, as they may determine. The total number of such additional representative members on any Committee shall not exceed four.
- 8. Any member representing employers or workmen who by reason of change of occupation-or otherwise shall in the opinion of the Wages Board cease to represent employers or workmen respectively shall, if so required by the Wages Board, vacate his seat.
- 9. Any representative member who, in the opinion of the Wages Board, fails without reasonable cause to attend one half of the total number of meetings in a calendar year shall vacate his seat.
- 10. The Board of Agriculture and Fisheries may in any case where in their opinion there is good and sufficient cause terminate the appoint-

ment of any member of a District Wages | Committee.

- 11. Subject to the provisions of these regulations the term of office of a member of a District Wages Committee shall be two years, provided that :-
 - (a) Any member may retire by notice in writing to the Secretary of the Committee.
 - (b) A member appointed to fill a casual vacancy shall act only for the unexpired portion of the term of office of his predecessor;
 - (c) A member whose term of office expires shall continue to act as a member until a successor is appointed.
- 12. Any person vacating his seat on a District Wages Committee shall be eligible to be reappointed as a member of the Committee.
- 13. A vacancy among representative members on a District Wages Committee shall be filled by nomination by the Wages Board of a representative of employers engaged in agriculture or a representative of workmen engaged in agriculture as the case may be.

A vacancy among appointed members on a District Wages Committee shall be filled by nomination by the Board of Agriculture and Fisheries after considering suggestions made by

the Wages Board.

- 14. Every member of a District Wages Committee shall have one vote. If, at any meeting of a Committee the number of members present representing employers and workmen respectively is unequal, it shall be open to the side which is in the majority to arrange that one or more of their members shall refrain from voting so as to preserve equality. Failing such an arrangement the Chairman of the meeting may, if he thinks it desirable, adjourn the voting on any question to a subsequent meeting of the Committee.
- 15. In order to constitute a meeting of a District Wages Conmittee, the Chairman or Deputy Chairman, or some other appointed member of the committee selected in writing by the Chairman to preside at such meeting, must be present, and the members present must be at least one-third of the whole number of members of the Committee.
- 16. When a District Wages Committee is authorised by the Wages Board to delegate any powers to a sub-committee, a sub-committee appointed by the District Wages Committee for such purpose shall consist of one or more representatives of employers and one or more representatives of workmen on the Wages Committee in equal proportions, together with such one or more of the appointed members of the Wages Committee as may be selected by the Wages Committee. The term of office of a member of a sub-committee shall be such period, not exceeding one year, as the Wages Committee may determine.
- 17. Any appointed member of the Wages Board shall have the right to attend any meeting of a sub-committee of a District Wages Committee and take part in the proceedings, but without the power to vote, unless he is a member of the sub-committee.
- 18. Where a District Wages Committee delegate any of their powers to a sub-committee the District Wages Committee may direct that the exercise of the powers by the sub-committee shall

from the decision of the sub-committee or otherwise as the District Wages Committee may think desirable and except and in so far as the District Wages Committee with the consent of the Wages Board shall otherwise direct the following condition shall apply, that is to say, any decision by the sub-committee shall be reported as soon as may be to the District Wages Committee, who may vary or annul the decision but not so as to affect or prejudice anything done or suffered under or by reason of the decision of the subcommittee before it is varied or annulled.

19. The proceedings of a District Wages Committee or sub-committee shall not be invalidated by any vacancy in their number or by any defect

in the appointment of any member.

The expressions "agriculture" "workmen" in these Regulations shall have the meanings given in Section 17 (1) of the Corn Production Act, 1917.

21. Any question upon the construction or interpretation of these Regulations shall in the event of dispute be referred to the Board of Agriculture and Fisheries for decision.

22. These Regulations may be cited as the District Wages Committee Provisional Regula tions, 1917.
