The King's Most Excellent Majesty in Council.

This day the Right Hon. Sir John Newport, Bart. Chancellor of the Exchequer for that part of the United Kingdom called Ireland, was, by his Majesty's command, sworn of his Majesty's Most Honourable Privy Council, and took his place at the Board accordingly.
