**PUBLIC HEALTH (TUBERCULOSIS)
REGULATIONS (SCOTLAND), 1918.**

To all Local Authorities in Scotland, and to all others whom it may concern.

WHEREAS by the Public Health (Tuberculosis) Regulations (Scotland), 1914 (hereinafter referred to as "the Regulations of 1914"), We, the Local Government Board for Scotland, made Regulations dealing with the notification of Tuberculosis:

And whereas by the Public Health (Tuberculosis) Regulations (Scotland), 1916 (hereinafter referred to as "the Regulations of 1916"), We made Regulations to provide for the transmission to the Army Council by every Medical Officer of Health of the name and other particulars of every male person between the ages of sixteen and forty-five years thereafter entered in the Register kept by the Medical Officer of Health in pursuance of subdivision (3) of Article XI. of the Regulations of 1914:

Now therefore, in the exercise of the statutory powers conferred upon Us, We do by this Our Order alter the Regulations of 1916, and do make the following Regulations, that is to say:—

Article I. Expressions in these Regulations, unless the contrary intention appears, have the same meaning as the like expressions have in the Regulations of 1914.

Article II. (a) Every Medical Officer of Health in lieu of transmitting to the Army Council the notification prescribed by subdivision (b) of Article II. of the Regulations of 1916, shall from and after the date of this Order send to the Commissioner of Medical Services, Scottish Region, Royal (Dick) College, Summerhall,

Edinburgh, a notification containing the name and other particulars specified in the Regulations of 1916 of every male person between the ages of sixteen and fifty-one years hereafter entered in the Register kept by the Medical Officer of Health in pursuance of subdivision (3) of Article XI. of the Regulations of 1914 within a week after the entry is made therein.

(b) Every Medical Officer of Health shall send forthwith to the Commissioner of Medical Services, Scottish Region, a list containing the names and other particulars specified in the Regulations of 1916 of all male persons appearing in the said Register at the date of this Order and who were between the ages of forty-five and fifty-one at 18th April 1918.

Article III. The provisions of Regulations III. and IV. of the Regulations of 1916 shall apply to the notifications prescribed by Article II. of this Order in the like manner as they apply to the notifications prescribed by Article II. of the Regulations of 1916.

Article IV. This Order may be cited as "The Public Health (Tuberculosis) Regulations (Scotland), 1918," and shall be in force during the continuance of the present war.
