At the Council Chamber, Whitehall, the 12th day of July 1918.

By the Lords of His Majesty's Most Honourable Privy Council. No. 59.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May 1916, and amended on the 16th day of January 1918, entitled "The Trading with the Enemy (Statutory List) Proclamation," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State :

And whereas the Statutory List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the

Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered,

That the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern them selves accordingly.

Note (1). — All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidated List, No. 56A) consolidating all previous Lists, up to and including that of the 31st May 1918, together with List No. 57 of 14th June 1918, List No. 58 of 28th June 1918, and the List herewith annexed, contain all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

NOTE (2).—Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specifically mentioned.

NOTE (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

Note (4).-In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required. General inquiries for new connections abroad should be addressed to The Comptroller-General, Department of Overseas Trade (Development and Intelligence), 73 Basinghall Street, London, E.C. 2.

Note (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

NOTE (6).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under the names commencing with descriptive terms such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

His Majesty the KING has been graciously pleased to approve of the award of the Victoria Cross to the undermentioned Officers and Non-Commissioned Officer :---

Capt. (T. Lt.-Col.) Charles Edward Hudson, D.S.O., M.C., Notts & Derby R.

For most conspicuous bravery and devotion to duty when his battalion was holding the right front sector during an attack on the British front.

The shelling had been very heavy on the right, the trench destroyed, and considerable casualties had occurred, and all the officers on the spot were killed or wounded. This enabled the enemy to penetrate our front line.

The enemy pushed their advance as far as the support line which was the key to our right flank. The situation demanded immediate action. Lt.-Col. Hudson, recognising its gravity, at once collected various headquarter details, such as orderlies, servants, runners, etc., and, together with some Allies, personally led them up the hill.

Driving the enemy down the hill towards our front line, he again led a party of about five up the trench, where there were about 200 enemy, in order to attack them from the flank. He then with two men got out of the trench and rushed the position, shouting to the enemy to surrender, some of whom did. He was then severely wounded by a bomb which exploded on his foot. Although in great pain, he gave directions for the counter-attack to be continued, and this was done successfully, about 100 prisoners and six machine-guns being taken.

Without doubt the high courage and determination displayed by Lt.-Col. Hudson saved a serious situation, and had it not been for his quick determination in organising the counter-attack a large number of the enemy would have dribbed through, and counterattack on a larger scale would have been necessary to restore the situation.

Reverend Theodore Bayley Hardy, D.S.O., M.C., T./C.F., 4th Class, A. Chapl. Dept., attd. Linc. R.

For most conspicuous bravery and devotion to duty on many occasions. Although over fifty years of age, he has, by his fearlessness, devotion to men of his battalion, and quiet, unobtrusive manner, won the respect and admiration of the whole division. His marvellous energy and endurance would be remarkable even in a very much younger man, and his valour and devotion are exemplified in the following incidents :--

An infantry patrol had gone out to attack a previously located enemy post in the ruins of a village, the Reverend Theodore Bayley Hardy (C.F.) being then at company headquarters. Hearing firing, he followed the patrol, and about four hundred yards beyond our front line of posts found an officer of the patrol dangerously wounded. He remained with the officer until he was able to get assistance to bring him in. During this time there was a great deal of firing, and an enemy patrol penetrated between the spot at which the officer was lying and our front line and captured three of our men.

On a second occasion, when an enemy shell exploded in the middle of one of our posts, the Reverend T. B. Hardy at once made his way to the spot, despite the shell and trench mortar fire which was going on at the time, and set to work to extricate the buried men. He succeeded in getting out one man who had been completely buried. He then set to work to extricate a second man, who was found to be dead.

During the whole of the time that he was digging out the men this chaplain was in great danger, not only from shell fire, but also because of the dangerous condition of the wall of the building which had been hit by the shell which buried the men.

On a third occasion he displayed the greatest devotion to duty when our infantry, after a successful attack, were gradually forced back to their starting trench.

After it was believed that all our men had withdrawn from the wood, Chaplain Hardy came out of it, and on reaching an advanced post asked the men to help him to get in a wounded man. Accompanied by a serjeant, he made his way to the spot where the man lay, within ten yards of a pill-box which had been captured in the morning, but was subsequently recaptured and occupied by the enemy. The wounded man was too weak to stand, but between them the chaplain and the serjeant eventually succeeded in getting him to our lines.

Throughout the day the enemy's artillery, machine-gun, and trench mortar fire was continuous, and caused many casualties.

Notwithstanding, this very gallant chaplain was seen moving quietly amongst the men and tending the wounded, absolutely regardless of his personal safety.

Lt. Clifford William King Sadlier, A.I.F.

For conspicuous bravery during a counterattack by his battalion on strong enemy positions.

Lt. Sadlier's platoon, which was on the left of the battalion, had an advance through a wood where a strong enemy machine-gun post caused casualties and prevented the platoon from advancing. Although himself wounded, he at once collected his bombing section, led them against the machine guns, and succeeded in killing the crews and capturing two of the guns.

By this time Lt. Sadlier's party were all casualties, and he alone attacked a third enemy machine gun with his revolver, killing the crew of four and taking the gun. In doing so, he was again wounded.

The very gallant conduct of this officer was the means of clearing the flank, and allowing the battalion to move forward, thereby saving a most critical situation. His coolness and utter disregard of danger inspired all.

No. 1946 Sit. William Ruthven, A.I.F.

For most conspicuous bravery and initiative in action. During the advance Sjt. Ruthven's company suffered numerous casualties, and his company commander was severely wounded. He thereupon assumed command of this portion of the assault, took charge of the company headquarters, and rallied the section in his vicinity.

As the leading wave approached its objective it was subjected to heavy fire from an enemy machine-gun at close range. Without hesitation he at once sprang out, threw a bomb which landed beside the post, and rushed the position, bayoneting one of the crew and capturing the gun. He then encountered some of the enemy coming out of a shelter. He wounded two, captured six others in the same position, and handed them over to an escort from the leading wave, which had now reached the objective.

Sjt. Ruthven then reorganised the men in his vicinity and established a post in the second objective.

Observing enemy movement in a sunken road near by, he, without hesitation and armed only with a revolver, went over the open alone and rushed the position, shooting two enemy who refused to come out of their dug-outs.

He then single-handed mopped up this post and captured the whole of the garrison, amounting in all to thirty-two, and kept them until assistance arrived to escort them back to our lines.

During the remainder of the day this gallant non-commissioned officer set a splendid example of leadership, moving up and down his position under fire, supervising consolidation and encouraging his men.

Throughout the whole operation he showed the most magnificent courage and determination, inspiring everyone by his fine fighting spirit, his remarkable courage, and his dashing action.

THE DEFENCE OF THE REALM REGULATIONS.

The Board of Trade, deeming it expedient to exercise the powers conferred upon them by Regulations 2F and 2JJ of the Defence of the Realm Regulations, for the purpose of maintaining and regulating the supply of Gold Thread hereby order as follows:—

1. From and after the date of this Order no person shall without the licence of the Board of Trade place any gold lace, gold embroidery, or gold thread on any garment, hat, or cap which is not a part of the uniform of one of His Majesty's Services or of the dress of an officer in the Mercantile Marine.

2. No person shall without the licence aforesaid use or wear any gold lace, gold embroidery, or gold thread on any garment, hat, or cap which is not a part of the uniform of one of His Majesty's Services or of the dress of an officer in the Mercantile Marine, unless such lace, embroidery, or thread was in his possession at the date of this Order.

3. No person shall without the licence aforesaid buy or sell any gold lace, gold embroidery, or gold thread except for use on such uniform or dress as aforesaid.

4. Infringements of this Order are summary offences against the Defence of the Realm Regulations.

5. This Order may be eited as the Gold Thread Order, 1918.

12th July 1918. THE STATUTES OF THE DISTIN-GUISHED SERVICE ORDER.

(REVISED EDITION.)

GEORGE R.I.

GEORGE THE FIFTH, by the Grace of God, of the United Kingdom of Great Britain and Ireland, and of the British Dominions beyond the Seas, King, Defender of the Faith, Emperor of India, to all to whom these presents shall come, greeting;

Whereas Her late Majesty Our Beloved Grandmother Queen Victoria by a Warrant dated the 6th day of September 1886 did institute and create a new Naval and Military Order of Distinction designated the Distinguished Service Order for the purpose of rewarding individual instances of meritorious or distinguished service in war;

And Whereas the said Royal Warrant was subsequently amended by Royal Warrants dated 24th July 1902, 2nd July 1903, 15th October 1903 and 23rd August 1916;

And Whereas it is Our Royal Will and Pleasure that the Officers of Our recently constituted Air Force shall be eligible for appointment to Our said Distinguished Service Order;

And Whereas We deem it expedient that all amendments to the Statutes of Our said Order heretofore promulgated, or now to be promulgated, shall be incorporated in a Royal Warrant under Our Sign Manual;

Now Therefore We do hereby declare that the rules and ordinances heretofore in force for the government of Our said Order shall be abrogated, cancelled and annulled, and We are graciously pleased to make, ordain and establish the following rules and ordinances in substitution for the same, which shall henceforth be inviolably observed and kept;

Firstly: It is ordained that this Order shall henceforth be styled and designated the "Distinguished Service Order."

Sceondly: It is ordained that the Order shall consist of the Sovereign, and of such Members or Companions as We, Our Heirs or Successors shall appoint.

Thirdly: It is ordained that We, our Heirs and Successors, Kings and Queens Regnant of the United Kingdom of Great Britain and Ireland, Emperors and Empresses of India, are and for ever shall be Sovereigns of this Order.

Fourthly: It is ordained that no person shall be eligible for this distinction who doth not actually hold, at the time of his nomination a Commission in Our Navy, in Our Land Forces or Marines, in Our Air Force or in Our Indian or Colonial Naval or Military Forces, or a Commission in one of the Departments of Our Navy, Army or Air Force, the holder of which is entitled to Honorary or relative Navy, Army or Air Force rank, nor shall any person be nominated unless his services shall have been marked by the especial mention of his name, by the Admiral or Senior Naval Officer Commanding a Squadron or detached Naval Force, or by the Commanderin-Chief of the Forces in the Field, in despatches for meritorious or distinguished service in the Field, or before the enemy.

Fifthly: It is ordained that Foreign Officers who have been associated in Naval, Military or Aerial operations with Our Forces shall be eligible to be Honorary Members of this Order.

Sixthly: It is ordained that when We, Our Heirs and Successors shall be pleased to appoint any person to be a Member of this Order, such appointment shall be made by Warrant under Our Sign Manual, and countersigned by one of Our Principal Secretaries of State.

Seventhly: It is ordained that anyone who, after having performed services for which this Order is awarded, subsequently performs an approved act of gallantry which, if he had not received the Order, would have entitled him to it, shall be awarded a Bar to be attached to the riband by which the Badge is suspended, and for every additional such act an additional Bar may be added.

Eighthly: It is ordained that an Officer shall be appointed to this Order, that is to say, a Secretary and Registrar.

Ninthly: It is ordained that the Secretary and Registrar of this Order shall be appointed by Us, Our Heirs and Successors, and shall have the custody of the archives of the Order. He shall attend to the service of the Order and shall execute such directions as he may receive from our Principal Secretary of State for War.

Tenthly: It is ordained that this Order shall rank next to and immediately after Our Order of the British Empire, and that the Companions thereof shall in all places and assemblies whatsoever have place and precedency next to and immediately after the Commanders of Our said Order of the BritishEmpire and shall rank among themselves according to the date of their respective nominations.

Eleventhly: It is ordained that the Badge of the Order shall consist of a gold cross, enamelled white, edged gold, having on one side thereof in the centre, within a wreath a laurel enamelled green, the Imperial Crown in gold upon a red enamelled ground, and on the reverse, within a similar wreath and on a similar red ground, the Royal Cypher, and shall be suspended from the left breast by a red riband, edged blue, of one inch in width.

Twelfthly: It is ordained that the names of those whom We may be pleased to admit to Membership of this Order shall be published in the London Gazette, and a registry thereof kept in the Office of Our Secretary of State for War.

Thirteenthly: In order to make such addi-tional provision as shall effectively preserve pure this honourable distinction, it is ordained that if any person admitted to Membership of this Order shall be convicted of treason, cowardice, felony, or of any infamous crime, or if he be accused of any such offence and doth not after a reasonable time surrender himself to be tried for the same, his name shall be erased, by an Order under the Royal Sign Manual, from the register of Members of the said Order. And it is hereby declared that We, Our Heirs and Successors, shall be the sole judge of the conduct which may require the erasure from the register of the name of the offending person, and that it shall at all times be competent for Us, Our Heirs and Successors, to restore the name if such restoration should be justified by the circumstances of the case.

Lastly: We reserve to Ourselves, Our Heirs and Successors full power of annulling, altering, abrogating, augmenting, interpreting or dispensing with these Regulations or any part

thereof by a notification under the Sign Manual | of the Sovereign of the Order.

ARMY COUNCIL ORDER.

THE FORMALDEHYDE (DEALINGS) ORDER, 1918.

In pursuance of the powers conferred upon them by the Defence of the Realm Regulations, the Army Council hereby order as follows :-1. No person shall purchase, sell or make,

or take delivery of or payment for any Formaldehyde (40 per cent. solution) at any price other than £150 per barrel delivered free on rail; provided that upon any sale of any quantity exceeding ten gallons and not exceeding one barrel an addition of 7d. per lb. may be made; and provided that upon any sale of any quantity exceeding five gallons and not exceeding ten gallons an addition of $7\frac{1}{2}d$. per lb. may be made ; and provided that upon any sale of any quantity not exceeding five gallons an addition of 8d. per lb. may be made; and provided further that upon any sale of any quantity less than one barrel additional charges may be added to the sale price in respect of carriage and containers, such charges to be limited to any expenses actually incurred by the vendor, subject to an addition of 1d. per container in the case of containers holding less than one-half gallon.

.2. This Order may be cited as the Formaldehyde (Dealings) Order, 1918.
