REPRESENTATION OF THE PEOPLE ACT, 1918.

ORDER BY THE SECRETARY FOR SCOTLAND, dated 12th October 1918, determining the situation of the places of Election in the Scottish Parliamentary Constituencies (other than the University Constituency) in pursuance of Section 43 (16) of the Representation of the People Act, 1918.

WHEREAS by Subsection (16) of Section 43 of the above Act it is provided that, in the case of parliamentary elections (other than an election for a university constituency), the place of election shall be a convenient room situated in such place as the Secretary for Scotland may by order from time to time determine:

Now THEREFORE, I, the undersigned, His Majesty's Secretary for Scotland, do hereby determine, in pursuance of my powers in that behalf, that the places of election in Scotland for the purposes of the provision above recited shall be situated, for each constituency, as respectively set out in the Schedule to this Order.

This Order may be cited as the Places of Election (Scotland) Order, 1918.

ORDER.

SECOND-HAND BOILERS.

The Ministry of Munitions, in exercise of the powers conferred upon him by the Defence of the Realm Regulations, and all other powers thereunto enabling him, hereby orders as follows:—

(1) No person shall as from the date hereof until further notice, except under and in accordance with the terms of a permit issued under the authority of the Ministry of Munitions, purchase, sell, or otherwise deal in any Second-hand Steam Pressure Boiler of any type not being a Boiler for use in any locomotive, motor car or vehicle, or on a ship or other vessel.

(2) This Order may be cited as the Boilers (Control) Order, 1918.

Applications for Permits may be obtained upon application to the Controller, Department of Engineering, Charing Cross Embankment Buildings, W.C. 2.

A permit to deal generally as a Second-hand Boiler Merchant may be granted to approved persons, and all applications for such a permit should be made to the Controller, Department of Engineering, Charing Cross Embankment Buildings, W.C. 2.

Nothing in the above Order shall be deemed to authorise any dealing in any Boiler for which a Permit is required under the Railway Material (Second-hand) Order, 1916.

ORDER.

CLINICAL THERMOMETERS.

The Minister of Munitions, in exercise of the powers conferred upon him by the Defence of the Realm Regulations and all other powers thereunto enabling him, hereby orders as follows:—

1. On and after the 21st day of October 1918 no person shall sell, offer for sale, supply or deliver, any clinical thermometer which has not been tested, approved and marked, in accordance with the under-mentioned rules, or any other rules made from time to time by the Controller of Glassware Supply on behalf of the Minister of Munitions and for the time being in operation.

2. This Order may be cited as the Clinical Thermometer Order, 1918.

3. All applications with reference to the above Order should be made to the Controller of Glassware Supply, Ministry of Munitions of War, 22/23 Hertford Street, W. 1.

Rules made by the Controller of Glassware Supply on behalf of the Minister of Munitions in consultation with the Local Government Board and the Department of Scientific and Industrial Research.

(1) Before any clinical thermometer is sold, offered for sale, supplied or delivered, the same shall be forwarded carriage paid to the Director of the National Physical Laboratory, Teddington, for testing and approval.

(2) For a period of one month after the date of the Order, no thermometer showing at any point in its registration of temperature an error of more than 4° F. will be approved. On the expiry of this period, no thermometer shall show an error exceeding 2° F. over the range up to 106° F. Above this temperature, the error shall not exceed 3° F. For thermometers graduated in degrees other than fahrenheit, corresponding tolerances will be allowed. A thermometer will not be approved if it is not self-registering with a constriction, which must be such as to retain the index column and also allow of the mercury being reset.

(3) Approved thermometers will be marked with the National Physical Laboratory trade mark and the year of test thus:— **NP** 18.

The charge for testing the thermometers will be 3d. (three pence) per instrument, payable in advance to the Director of the Laboratory, this charge to cover return carriage upon the instruments to any place in the United Kingdom and also insurance against loss or damage in transit both ways and during test at the Laboratory. All thermometers submitted for testing to the Director must be clearly engraved with a distinctive number. Thermometers not already so engraved will be engraved at the Laboratory at a charge of 1d. (one penny) per instrument, payable in advance to the Director.

NOTE.—The National Physical Laboratory is prepared to issue a certificate setting out details of the results of the prescribed tests in regard to any thermometer which is approved in accordance with the above rules, on payment of an additional fee, particulars of which may be obtained from the Director of the Laboratory.

Cheques, &c., should be made payable to the Secretary, Department of Scientific and Industrial Research, and should be forwarded to the Laboratory. Cheques, &c., should be crossed "Bank of England a/c His Majesty's Paymaster-General."

CORN PRODUCTION ACT, 1917.

ORDER, dated 9th October 1918, made by the Board of Agriculture for Scotland under the Regulations made by them, dated 23rd April 1918, with respect to the Tenure of Office and Procedure of District Wages Committees.

In exercise of the powers conferred on them by the Second Schedule to the Corn Production Act, 1917, and in pursuance of paragraph 1 of the above-mentioned Regulations, the Board of Agriculture for Scotland hereby order as follows:—

The period during which a District Agricultural Wages Committee, as at present constituted, shall hold office shall be extended for a further

period of six months, beginning on 1st January 1919 and ending on 30th June 1919.

THE DISTRICT AGRICULTURAL WAGES COMMITTEE FOR THE BORDER COUNTIES DISTRICT.

(Being District No. 7.)

NOTICE of an ORDER FIXING MINIMUM RATES OF WAGES FOR AGRICULTURAL WORKMEN in the Area comprising the Counties of Roxburgh, Berwick, and Selkirk.

The District Agricultural Wages Committee for the Counties of Roxburgh, Berwick, and Selkirk, duly certified by the Board of Agriculture for Scotland under the Second Schedule to the Corn Production Act, 1917, hereby, in terms of Section 5 (4) of said Act and relative Regulation by the Board of Agriculture for Scotland, give notice to the persons affected that they HAVE FIXED a Minimum Rate of Wages payable for timework by workmen in Agriculture of the class within the Area, and subject to the conditions or exceptions (if any), all as set forth in the Schedule hereto.

SCHEDULE.

- (1) The Weekly Wages payable in respect of an able-bodied ploughman, whether married or single, shall be not less than at the rate of 35s. per week.
- (2) Perquisites, *i.e.* "benefits or advantages" in the sense of the Act, are to be reckoned as part payment of the said 35s. in lieu of cash payment. These "benefits and advantages" will be defined and valued by a subsequent Order.
- (3) The above minimum rate shall apply to all able-bodied skilled ploughmen of 18 years of age and upwards, who are wholly or partly employed in agriculture on farms in the above-mentioned areas during such time as they are so employed.
- (4) For the purpose of the above minimum rate, a ploughman shall be regarded as skilled only in the event of his having worked on a farm continuously (1) for three years before having reached the age of 18, or (2) for two years after having reached the age of 18.
- (5) The hours of employment to which the above minimum rate of wages shall be held to apply are those customary to the District in which the workman is employed.

THE DISTRICT AGRICULTURAL WAGES COMMITTEE FOR DUMFRIES AND GALLOWAY.

NOTICE of an ORDER FIXING MINIMUM RATES OF WAGES FOR AGRICULTURAL WORKMEN in the Area comprising the Counties of Dumfries, Kirkcudbright, and Wigtown.

The District Agricultural Wages Committee for Dumfries and Galloway, duly certified by the Board of Agriculture for Scotland under the Second Schedule to the Corn Production Act, 1917, hereby, in terms of Section 5 (4) of said Act and relative Regulation by the Board of Agriculture for Scotland, give notice to the persons affected that they have fixed minimum rates of wages payable for time-work by workmen in Agriculture of the classes within the area, and subject to the conditions or exceptions (if any), all as set forth in the Schedule hereto.

SCHEDULE.

1. The weekly wages payable in respect of all—
 - (a) Male agricultural workers over 18 years of age shall not be less than at the rate of 33s. per week.
 - (b) Ploughmen married or single over 18 years of age shall not be less than at the rate of 38s. per week.
 - (c) Boys from 16 to 18 years of age shall not be less than at the rate of 24s. per week.
 - (d) Casual workers who are women over the age of 17 years and with at least one year's experience in agricultural work shall not be less than at the rate of 4d. per hour.
 - (e) Boys from 14 to 16 years of age shall not be less than at the rate of 3d. per hour.
2. The day and week shall be the ordinary number of hours per day and per week respectively at present worked in the area.
3. The area comprises the Counties of Dumfries, Kirkcudbright, and Wigtown.
4. The foregoing Minimum Rates shall not apply to "Agricultural Students" or disabled Soldiers or Sailors being trained in Forestry.

Charles Davie Millar, Leading Seaman, O.N. 218811, in recognition of his gallantry in the following circumstances:—

On the 29th June 1918 an outbreak of fire occurred on board Motor Launch No. 483 whilst refuelling alongside the jetty at Pembroke Dock, the fire being caused by the ignition of an overflow of petrol from the hose.

Leading Seaman Millar; H.M.S. "P.C. 51," who was walking up and down the fore-castle of his ship, on seeing the flames break out on the upper deck of the motor launch, immediately slid over the bows of his craft on to the motor launch, rushed aft, and removed the primers of the depth charges. He then forced his way through the flames and kicked the hose overboard, getting his clothes ignited as he did so. Having extinguished his burning clothing by jumping overboard, he climbed in-board again and assisted in getting the motor launch in tow.

This man displayed initiative and disregard of danger, and by his prompt action he probably averted a serious accident. Had the depth charges detonated, very great damage would have been done and lives undoubtedly lost.
