### FOREIGN SERVICE LEAVE.

(1) Commissioned Officers below the rank of Flag Officer, and Warrant Officers, after service on Foreign Stations, to be allowed leave with the full pay of their respective ranks for the following periods, according to the length of their total continuous service abroad :—

(a) Seven days' full pay leave for each completed period of six months' Foreign Service;

(b) leave for periods of service of less than six months to be reckoned at one day for each complete month's service.

### HOME LEAVE.

(2) Officers, holding appointments on the Home Stations, may be absent on leave for a period not exceeding forty-two days in the course of the year, but the right to such leave ceases with the appointment :

"And whereas we are of opinion that the period of leave allowed for Foreign Service should be increased, and the grant of such leave should be extended to Flag Officers and that unexpended home leave should not be entirely forfeited on the termination of an appointment: "We beg leave humbly to recommend that

(a) 21 days' full pay leave for each completed period of six months' service;

(b) 3 days' full pay leave for each com-

pleted month for periods of service of less than 6 months.

#### PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Order in Council dated the 10th January 1910, and known generally as the Civil Service (Consolidating) Order in Council, 1910, as amended by an Order in Council dated the 22nd March 1918, provision has been made for testing according to fixed rules the qualifications of persons who may seek or be proposed for appointment, either permanently or temporarily, to situations or employment in any of His Majesty's Civil Establishments, and for regulating the conduct of His Majesty's said Civil Establishments and the conditions of service therein :

And whereas it is expedient, by reason of the general interruption of academic studies during the war, that special and temporary provision should be made for the admission of men of military age into His Majesty's Civil Service otherwise than by competitive examination :

Now, therefore, His Majesty, by and with the advice of His Privy Council, doth order, and it is hereby ordered, as follows :-

(1) Until such date as may be prescribed by is Majesty's Civil Service Commissioners (hereinafter called the Commissioners) with the approval of the Lords Commissioners of His Majesty's Treasury (hereinafter called the Treasury) by notice published by them in the Majesty's London Gazette, appointments within the scope of Clause 5 of the Principal Order may be made by selection on a competitive basis, but without competitive examination, through the agency of a Selection Board or Boards appointed by the Treasury, and according to regulations framed or to be from time to time framed by the Commissioners, and approved by the Treasury, and such appointments shall be deemed to have been made by means of competitive examinations under Clause 5 of the said Order.

(2) All men who have served either in His Majesty's Naval, Military, or Air Forces, or being unfit for general service in those Forces have been employed in one or more of His Majesty's Civil Departments during the war, and are in a position to satisfy the Commissioners and the Selection Board that they are of the requisite age, health, character, and educational and other qualifications prescribed in the said regulations, shall be eligible to compete for such appointments on application in the form prescribed by the Commissioners, and on payment of such fees as they may from time to time prescribe by notice published in the London Gazette.

(3) Clause 6 of the Principal Order shall not apply to candidates selected for appointment in the manner prescribed by this Order, but in lieu thereof the following provision shall apply :-

"After the candidate has been selected for appointment and his certificate of qualification has been issued by the Commissioners, he shall enter on a period of probation of two years or such extended period not exceeding three years in all as may be prescribed by the Head of his Department. During this time his conduct, capacity, and fitness for permanent employment in His Majesty's Civil Service shall be subjected to such tests as may be determined by the Head of his Department and he shall not be finally appointed to the Public Service unless

the Head of his Department satisfactory proof of his fitness for permanent employment,'

WHEREAS on the 20th day of January VV 1914, an International Convention for the Safety of Life at Sea, and for purposes incidental thereto, was duly entered into by His Majesty and the other Signatory Powers more especially referred to and set out in the said Convention :

And whereas a Statute 4 & 5 Geo. V, c. 50, intituled "An Act to make such amendments of the law relating to Merchant Shipping as are necessary or expedient to give effect to an Inter-national Convention for the Safety of Life at Sea" (being the Convention above referred to) was passed on the 10th day of August 1914, the short title of which is "The Merchant Shipping (Convention) Act, 1914": And whereas by Section 29, Sub-section 5,

of the said Act it was provided as follows :-

"This Act shall come into operation on the 1st day of July 1915 :

Provided that His Majesty may, by Order in Council, from time to time postpone the coming into operation of this Act for such period, not exceeding on any occasion of postponement one year, as may be specified in the Order "

And whereas by divers Orders in Council the coming into operation of the said Act has been from time to time postponed, and now stands postponed, by virtue of an Order in Council of the 16th day of January 1918, for a period of one year from the 1st day of January 1918 :

And whereas His Majesty deems it expedient, owing to conditions arising from a state of War, that the provisions of the said Act should be further postponed :

Now, therefore, His Majesty, by and with the advice of His Privy Council, in pursuance of the powers vested in Him by the aboverecited provision, and of all other powers Him thereunto enabling, doth order, and it is hereby ordered, that the provisions of the Merchant Shipping (Convention) Act, 1914, shall be postponed from coming into operation until the 1st day of July 1919.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations,

and in particular by a Proclamation dated the 23rd day of May 1916, and amended on the 16th day of January 1918, entitled "The Trading with the Enemy (Statutory List) Proclamation," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last-mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State :

And whereas the Statutory List contained in the last-mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the Statutory List should be further varied as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered,

That the Statutory List be varied as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

Note (1). — All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidated List, No. 68A) consolidating all previous Lists, up to and including that of the 15th November 1918, together with List No. 69 of November 29th, List No. 70 of December 13th, and the List herewith annexed, contain all the names which up to this date are included in the Statutory List. (as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

NOTE (2).—Where a firm is mentioned in the List, every partner in the firm is also included in the List, and all dealings with any partner in the firm, as well as all dealings with the firm, are prohibited: and conversely, all dealings with a firm, any partner in which is mentioned in the List, are also prohibited.

Note (3).—Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specially mentioned.

Note (4).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia, or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

NOTE (5).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable .ubstitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required. General enquiries for new connections abroad should be addressed to The Comptroller-General, Department of Overseas Trade (Development and Intelligence), 73 Basinghall Street, London, E.C. 2.

Note (6).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information. as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

NOTE (7).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company; and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

MAKING CLAIMS IN RESPECT OF LOSS.

The Board of Agriculture for Scotland, in exercise of the power conferred on them by Part IV. of the Corn Production Act, 1917, as amended by the Corn Production (Amendment) Act, 1918, hereby make the following Regulation :---

1. Claims made in terms of subsection (9) of Section nine of the Corn Production Act, 1917, in respect of loss suffered by reason of the exercise of the powers conferred on the Board by the said section, shall be made to the Board at any time before the first day of April 1919, or before the expiration of a period of fifteen months from the date of the service of the notice or order, or from the date on which possession was taken, whichever date is latest.

Provided that where the period during which the notice or order has effect or the period of possession exceeds one year in duration, the claim may be niade at any time within three months of the expiration of such period or of the date of the termination of the war in any case where possession is continued beyond that date, subject to the right of any person to make a further claim in respect of such continued occupation in terms of the Defence of the Realm (Acquisition of Land) Act, 1916, or other enactment authorising the continuation of occupation.

2. This Regulation may be cited as the Cultivation Claims (Scotland) Order, 1918.
