By the Lords of His Majesty's Most Honourable Privy Council.—No. 74.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May 1916, and amended on the 16th day of January 1918, entitled "The Trading with the Enemy (Statutory List) Proclamation," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last-mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last-mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of

State for Foreign Affairs to the effect that the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to Order, and it is hereby Ordered,

That the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

NOTE (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidated List, No. 68A) consolidating all previous Lists up to and including that of the 15th November 1918, together with List No. 69 of 29th November, List No. 70 of 13th December, List No. 71 of 20th December 1918, List No. 72 of 3rd January, List No. 73 of 17th January 1919, and the List herewith annexed, contain all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

NOTE (2).—Where a firm is mentioned in the List, every partner in the firm is also included in the List, and all dealings with any partner in the firm, as well as all dealings with the firm, are

prohibited: and conversely, all dealings with a firm any partner in which is mentioned in the List are also prohibited.

NOTE (3).—Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specially mentioned.

NOTE (4).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

NOTE (5).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required. *General enquiries for new connections abroad should be addressed to The Comptroller-General, Department of Overseas Trade (Development and Intelligence), 73 Basinghall Street, London, E.C. 2.*

NOTE (6).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

NOTE (7).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms such as "Handel Maatschappij" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappij"

or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappij van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

WHEREAS it is provided by Section 2 of the Customs (Exportation) Prohibition Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas by a Proclamation, dated the 10th day of May 1917, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited :

And whereas by subsequent Orders of Council, and by the Proclamation, dated the 18th day of December 1918, the said Proclamation was amended and added to in certain particulars :

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect :—

That the Proclamation, dated the 10th day of May 1917, as amended and added to by subsequent Orders of Council, and by the Proclamation, dated the 18th day of December 1918, should be further amended by making the following amendments in and additions to the Schedule to the same :—

TRADE BOARDS ACTS, 1909 AND 1918.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established under that Act, and the Trade Boards Provisional Orders Confirmation Act, 1913, for certain branches of the Machine-made Lace and Net Finishing trade as defined in the Regulations made by the Board of Trade and dated 16th March 1914, hereby give notice as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to vary the following General Minimum Piece-Rates of Wages at present fixed and set out in the Schedule of their notice dated 17th June 1918, for the Drawing and Plain Cutting of Lace which is the product of Warp machines, and for Threading, Cutting and Ticketing of Hair Nets.

The Trade Board gave similar notice that they propose to fix General Minimum Piece-Rates for Ripping and Roving of Lace other than Warp Lace, and to cancel the General Minimum Piece-Rate at present fixed for the Scolloping of Lace which is the product of Warp machines.

On application to the Trade Board further information will be given as to the rates proposed, if in the opinion of the Trade Board the applicant is likely to be affected thereby.

The Trade Board will consider any objections to their proposals to vary, fix, and cancel, General Minimum Piece-Rates which may be lodged with them within two months from the 23rd January 1919. Such objections should be in writing, and should be sent to the Secretary of the Lace Finishing Trade Board, Old Serjeant's Inn, 5 Chancery Lane, London, W.C. 2.

ORDER BY HIS MAJESTY.

Whereas it is provided by Section 2 of the Air Force (Constitution) Act, 1917, that, subject to the provisions of that Act, it shall be lawful for His Majesty by order signified under the hand of a Secretary of State to make orders with respect to the government, pay, allowances and pensions of the Royal Air Force and with respect to all other matters and things relating to the Royal Air Force; and that subject to the provisions of any such Order the Air Council may make general or special regulations with regard to any matter with respect to which His Majesty may make Orders under this Section; and

Whereas it is expedient to provide for the manner in which the services and pay of officers appointed to temporary commissions in the Royal Air Force during the present war shall be terminated;

Now, therefore, His Majesty, in exercise of the powers conferred on Him by the said Act and of all other powers Him thereunto enabling, is pleased to order, and it is hereby ordered, that any temporary commission in the Royal Air Force granted during the present war shall be terminated at such time as in the opinion of the Air Council shall be expedient, and that any

such commission shall terminate and cease to have effect on the specified date to be determined by or under instructions from the Air Council, and that the holder of any such commission shall on or before such specified date be notified thereof in such manner as may be determined by or under instruction from the Air Council. The specified date shall also be the date given to the notification of termination of the commission in the London Gazette.

ORDER BY HIS MAJESTY.

Whereas it is provided by Section 2 of the Air Force (Constitution) Act, 1917, that, subject to the provisions of that Act, it shall be lawful for His Majesty by order signified under the hand of a Secretary of State to make orders with respect to the government, pay, allowances and pensions of the Royal Air Force and with respect to all other matters and things relating to the Royal Air Force; and that subject to the provisions of any such Order the Air Council may make general or special regulations with regard to any matter with respect to which His Majesty may make Orders under this Section; and

Whereas it is expedient to provide that officers who have been given temporary commissions in the Royal Air Force may be granted the privilege of being released from actual air-force duty in order to return to civil life before the termination of the present war;

Now, therefore, His Majesty, in exercise of the powers conferred on Him by the said Act and of all other powers Him thereunto enabling, is pleased to order, and it is hereby ordered, that officers so released shall not from the date on which they cease to perform air-force duties be entitled to Air Force pay and allowances, neither shall any period during which they are so released count towards any gratuity or for non-effective benefits, nor shall they be eligible for promotion during that period.

RULES PUBLICATION ACT, 1893.

In conformity with the provisions of Section 1 of the Statute 56 and 57 Victoria, ch. 66, notice is hereby given that the Secretary of State for India in Council proposes, with the advice and assistance of the Civil Service Commissioners, at the expiry of forty days from the date of this Gazette, to make Rules as

shown below, in pursuance of the powers conferred on him by Section 1 of the Indian Civil Service (Temporary Provisions) Act, 1915 (5 and 6 George V., ch. 87), for the appointment to the Indian Civil Service otherwise than by the annual Open Competition (which will still continue to be held) of British subjects who have during the war served in His Majesty's Navy, Army, or Air Forces.

On account of urgency the Secretary of State in Council has, under Sec. 2 of the Statute 56 and 57 Victoria, ch. 66, made these Rules to come into operation forthwith as provisional rules to continue in force until rules have been made in accordance with the provisions of Sec. 1 of that Act.

RULES.

"It will rest with the Civil Service Commissioners to determine whether candidates are qualified in respect of nationality, age, character, education, and war service as defined in the following Regulations:—

"1. (a) Every candidate must be either a British subject or a ruler or subject of any State in India in respect of whom the Governor-General in Council has made a declaration under Sec. 96 (a) of the Government of India Act, 1915, as amended by Sec. 3 of the Government of India (Amendment) Act, 1916.

"(b) If the candidate (being a British subject) or his father or his mother was not born within His Majesty's Dominion and allegiance, the father must at the time of the candidate's birth have been a British subject or the subject of a State in India and still be (or have continued to be until his death) a British subject or a subject of such State.

"2. Every candidate for appointment to be made under these Rules must have served in His Majesty's Naval, Military, or Air Forces during the war for at least one year, or, if his service be less than one year, have been retired or discharged on account of wounds or sickness resulting from such service.

"3. Every candidate must have been born on or after the 2nd August 1891, and on or before the 1st August 1899.

"4. Every candidate must be of good character in civil and military life.

"5. Every candidate must have received continuous and systematic education of a high type until at least the age of 18, and must produce satisfactory evidence that if he has not received University education, he would have been justified in proceeding from school to a University with a view to taking high honours.

"6. Candidates must submit to the Civil Service Commissioners an application in the form prescribed by them, and pay on application such fee as is appointed by them.

"7. Candidates who appear from their forms of application to be *prima facie* eligible for appointment to the Indian Civil Service will be subject to such tests as the Civil Service Commission may prescribe in the way of (a)

a qualifying examination, written or oral; (b) the production of written evidence, including school record, university record (if any), military record, and personal references; (c) interview by Selection Board; (d) medical examination.

"8. Candidates recommended by the Civil Service Commissioners will be accepted by the Secretary of State for India in Council as Selected Candidates for the Indian Civil Service, subject to any further inquiries that he may find it necessary to institute, and will be required to undergo such period of probation as may be hereafter prescribed. At the end of this period of probation they will be tested by the Civil Service Commissioners, or by an authority in India specially empowered in this behalf, in Indian Law and Languages, and in any other subjects which may be prescribed, and in riding. They will not be appointed to the Civil Service of India until they have been certified to have fulfilled these tests."

CERTIFICATION OF INFECTED AREAS.

(1) THE BOARD OF AGRICULTURE FOR SCOTLAND, by virtue and in exercise of the powers vested in them under the Destructive Insects and Pests Acts, 1877 and 1907, and of every other power enabling them in that behalf, and for the purposes of Article 2 (1) of the Wart Disease of Potatoes (Scotland) Order of 1918, hereby certify that as from the 1st February 1919, the areas described in the Schedule annexed hereto shall, unless and until the Board otherwise certify, be infected areas for the purposes of the said Order : Provided that the provisions of the said Order so far as they relate to infected areas shall not apply to holdings exceeding half an acre in extent situated in the areas described in the said Schedule except—

- (a) Holdings exceeding half an acre in extent or parts of them to which, because of an outbreak of Wart Disease or for any other reason, the aforesaid provisions already apply ; or
- (b) Holdings exceeding half an acre in extent or parts of them which may, subsequent to the date of this Certificate, be found to be infected with Wart Disease or to which, in the opinion of an Inspector, Wart Disease is likely to spread, and in respect of which a notice applying the provisions of the Wart Disease of Potatoes (Scotland) Order of 1918 may be served by an In-

pector of the Board or of the Local Authority.

(2) In this Certificate the terms " Inspector," " The Board," " The Local Authority," " Holdings " and " Wart Disease " shall have the same respective meanings as in the Wart Disease of Potatoes (Scotland) Order of 1918.
