[The KING's Most Excellent Majesty in Council.

THIS day the Right Honourable Sir James Rose Innes, K.C.M.G., Chief Justice of South Africa, having been appointed a Member of His Majesty's Most Honourable Privy Council on the 3rd day of February 1915, was, by His Majesty's command, sworn, and took his place at the Board accordingly.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 25th day of March 1919, in the words following, viz. :—

“Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of

services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council :

“And whereas by Your Majesty's Order in Council of the 8th day of November 1918, sanction was given to the payment of Supplementary Separation Allowances, in certain circumstances, to the wives and dependants of Seamen, Marines, and Reservists, holding the Rating or Rank of Ordinary Seaman, Able Seaman, Private, or any relative Rating or Rank in other Branches of Your Majesty's Naval and Marine Forces :

“And whereas the grant of War Bonus, in addition to pay, to men serving in Your Majesty's Navy, Army, and Air Forces, has produced a change in the relative position of Seamen in the Navy and Privates in the Army :

“We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the alteration in the conditions as regards award of Supplementary Separation Allowance as indicated in the Schedule hereto, with effect from the 6th February 1919.

“The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.”

“SCHEDULE.

“It shall be a condition of the award of a Supplementary Separation Allowance that the Seaman or Marine, in respect of whom it is

claimed, shall have declared in favour of the claimant a weekly allotment from his wages which—

(a) If his Full Pay and Allowances in the nature thereof including War Bonus do not exceed 22s. 6d. a week, is not less than 1s. 6d. a week, or

(b) If his Full Pay and Allowances in the nature thereof exceed 22s. 6d. a week is not less than the weekly excess of such Full Pay and Allowances over 21s. provided that, if the excess be not an exact multiple of 6d., it shall be not less than the precise multiple of 6d. next below such excess."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS by Section 1 of the Marriage of British Subjects (Facilities) Act, 1915, it is (amongst other things) enacted as follows:—

"Where His Majesty is satisfied that the law in force in any part of His Majesty's Dominions outside the United Kingdom makes due provision for the publication of banns or for the giving of notice in respect of marriages between British Subjects intended to be solemnised or contracted in the United Kingdom, and for the recognition of certificates for marriage issued by Superintendent Registrars in England, and of certificates for marriage issued by Registrars, and certificates of proclamation of banns, in Scotland, and of certificates for marriage issued by Registrars in Ireland, as sufficient notice in respect of marriages between British Subjects intended to be solemnised or contracted in that part of His Majesty's Dominions, His Majesty may, by Order in Council, declare that this Section shall apply to that part of His Dominions, and in such case:—

"(a) Where a marriage is intended to be solemnised or contracted in the United Kingdom between a British Subject resident in England, Scotland, or Ireland, and a British Subject resident in that part of His Majesty's Dominions, a certificate of the publication of banns or a certificate of notice of marriage issued in accordance with such law shall in England have the same effect as a certificate for marriage issued by a Superintendent Registrar, and in Scotland and Ireland have the same effect as a certificate for marriage issued by a Registrar in Scotland and Ireland respectively; and

"(b) Where a marriage is intended to be

solemnised or contracted in that part of His Majesty's Dominions between a British Subject resident in that part and a British Subject resident in England, Scotland, or Ireland, a certificate for marriage may be issued in England by a Superintendent Registrar, or in Scotland or Ireland by a Registrar, in the like manner as if the marriage was to be solemnised or contracted under circumstances requiring the issue of such a certificate, and as if both such British Subjects were resident in England, Scotland, or Ireland, as the case may be."

And whereas by Section 1 of the Marriage of British Subjects (Facilities) Amendment Act, 1916, it is enacted as follows:—

"If His Majesty is satisfied that, for the purposes of a marriage to be solemnised or contracted in any part of His Dominions outside the United Kingdom between a British Subject resident in that part and a British Subject resident in England, Scotland, or Ireland, no notice of the marriage is, under the law in force in that part of His Dominions, required on the part of the person resident in England, Scotland, or Ireland, His Majesty may, by Order in Council, declare that Section 1 of the Marriage of British Subjects (Facilities) Act, 1915, shall apply to that part of His Dominions, notwithstanding that the law in force in that part does not make provision for the recognition of certificates for marriage issued in England, Scotland, and Ireland, and of certificates of proclamation of banns issued in Scotland, as sufficient notice in respect of such marriages as aforesaid, provided that the other conditions required by that Section are fulfilled."

And whereas by Section 2 of the first hereinbefore recited Act it is enacted that His Majesty may, by Order in Council, extend the said Act to any British Protectorate, and on the making of any such Order the said Act shall, subject to the provisions of the Order, have effect as if the Protectorate were part of His Majesty's Dominions:

And whereas His Majesty is satisfied that, for the purposes of a marriage to be solemnised or contracted in the British Protectorate herein-after mentioned between a British Subject resident therein and a British Subject resident in England, Scotland, or Ireland, no notice of the marriage is under the law in force in that Protectorate required on the part of the person resident in England, Scotland, or Ireland, and that under the said law the other conditions required by the hereinbefore recited Section 1 of the Marriage of British Subjects (Facilities) Act, 1915, are fulfilled:

Now, therefore, His Majesty, by virtue and in exercise of the powers by the above-recited Acts in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

Section 1 of the Marriage of British Subjects (Facilities) Act, 1915, shall apply to the British Protectorate hereunder mentioned:

Northern Rhodesia.

And the Right Honourable Viscount Milner, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the 10th day of May 1917, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited:

And whereas by subsequent Orders of Council, and by the Proclamations dated respectively the 18th day of December 1918, and the 12th day of March 1919, the said Proclamation was amended and added to in certain particulars:

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect:—

That the Proclamation, dated the 10th day of May 1917, as amended and added to by subsequent Orders of Council, and by the Proclamations dated respectively the 18th day of December 1918, and the 12th day of March 1919, should be further amended by making the following amendments in and additions to the Schedule to the same:—

(1) That the following headings should be deleted:—

- (A) Gold leaf;
- (A) Gold, liquid, including gold paint, gold enamel, gilding solution and all other pigments containing gold.

(2) That the following heading should be added:—

- (A) Gold, coin and bullion.

Now, therefore, their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, the Director of the War Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

DEFENCE OF THE REALM.
REGULATION 41DD.

GENERAL LICENCE IN CONNECTION WITH THE RESUMPTION OF TRADE WITH RUSSIAN POLAND AND ESTHONIA.

A general licence under Regulation 41DD of the Defence of the Realm Regulations is hereby granted by the Treasury to all persons engaged in banking, bill discounting, or any transaction in foreign moneys of exchange, or any business of a similar nature, to do, or to allow to be done, through him or through any account kept by him, any transaction whether or not involving the sending of money, credit, or securities, out of the United Kingdom necessary for the purpose of financing the movement of merchandise to or from Russian Poland and Esthonia.

COMPANIES ACTS, 1908 TO 1917.

REGULATIONS OF THE BOARD OF TRADE, DATED MARCH 26, 1919, AS TO THE CERTIFICATION OF COPIES AND TRANSLATIONS OF DOCUMENTS REQUIRED BY SECTION 274 OF THE COMPANIES (CONSOLIDATION) ACT, 1908 (8 EDW. 7, C. 69), TO BE LODGED WITH THE REGISTRAR OF JOINT STOCK COMPANIES.

In regard to certified copies and certified translations of documents required by section 274 of the Companies (Consolidation) Act, 1908, to be filed with the Registrar, the Board of Trade do hereby prescribe as in manner following, that is to say:—

(1) A certified copy of the Charter, Statutes or Memorandum and Articles of Association, or other Instrument constituting or defining the constitution of a Company in the case of a Company incorporated in a Foreign Country required to be filed with the Registrar under section 274 of the Companies (Consolidation) Act, 1908, shall be deemed to be certified as a true copy if in such Foreign Country it is:

(a) Duly certified as a true copy by an official of the Government to whose custody the original is committed, the signature or seal of such official being authenticated by any of the British Officials mentioned in section 6 of the Commissioners of Oaths Act, 1889, or in any Act amending the same, or

(b) Duly certified as a true copy by a Notary of such Foreign Country, the certificate of the Notary being authenticated by any of the British Officials mentioned in section 6 of the said Act or in any Act amending the same, or

(c) Duly certified as a true copy on oath by some officer of the Company before a person having authority to administer an oath as provided by section 3 of the said Act, the status of the person administering the oath being authenticated by any of the British Officials mentioned in section 6 of the said Act, or in any Act amending the same.

(2) A certified copy of the Charter, Statutes, or Memorandum and Articles of Association, or other Instrument constituting or defining the constitution of a Company, in the case of a Company incorporated in the Channel Islands, Isle of Man, or in any Colony, Island, Plantation, or place under the Dominion of His Majesty in Foreign Parts, required to be filed with the Registrar under section 274 aforesaid, shall be deemed to be certified as a true copy if in the Channel Islands, Colony, Island, Plantation, or places under the Dominion of His Majesty it is:

(a) Duly certified as a true copy by an official of the Government to whose custody the original is committed:

(b) Duly certified as a true copy by a Notary Public of such Colonies, Islands, or places aforesaid:

(c) Duly certified as a true copy on oath by some Officer of the Company before some person having authority to administer an oath as provided by section 3 of the Commissioners of Oaths Act, 1889.

(3) In the case of a company in which the Charter, Statutes, or Memorandum and Articles of Association, or other Instrument constituting or defining the constitution of the Company, is not written in the English language a certified

translation thereof required to be filed with the Registrar shall be deemed to be certified as a correct translation if certified to be a correct translation:

(a) When such translation is made out of the United Kingdom by

Any of the British Officials mentioned in section 6 of the Commissioners of Oaths Act, 1889, or by any person whom any such official certifies is known to him as competent to translate the document into the English language.

(b) Where such translation is made within the United Kingdom:

(1) In the case of a translation made in regard to a company whose place of business is established in England, by

(1) A Notary Public in England, or

(2) A Solicitor of the Supreme Court in England.

(2) In the case of a translation made in regard to a Company whose place of business is established in Ireland, by

(1) A Notary Public in Ireland, or

(2) A Solicitor of the Supreme Court in Ireland.

(3) In the case of a translation made in regard to a Company whose place of business is established in Scotland, by

(1) A Notary Public in Scotland,

(2) An Enrolled Law Agent.

(4) The Board of Trade may, in any particular case, if they think fit to do so, and upon such conditions as they think fit, permit certified copies or translations though not certified in accordance with the above requirements to be filed with the Registrar.

The Regulations made by the Board of Trade, dated the 29th day of March 1909, are hereby revoked, but without prejudice to the validity of any act done thereunder.

TRADING WITH POLAND.

GENERAL LICENCE.

Whereas by Royal Proclamation relating to Trading with the Enemy, dated the 9th day of September 1914, it was, amongst other things, declared as follows:—

“The expression ‘enemy country’ in this Proclamation means the territories of the German Empire and of the Dual Monarchy of Austria-Hungary together with all the Colonies and Dependencies thereof.”

And whereas it was also declared by the said Proclamation that from and after the date of the said Proclamation the persons therein referred to were prohibited from having certain transactions with any person or body of persons of whatever nationality resident or carrying on business in an enemy country:

And whereas it was further declared by the said Proclamation as follows :—

“Nothing in this Proclamation shall be taken to prohibit anything which shall be expressly permitted by Our Licence, or by the licence given on Our behalf by a Secretary of State, or the Board of Trade, whether such licences be especially granted to individuals or be announced as applying to classes of persons.”

And whereas by Proclamations, dated the 8th day of October 1914, the 7th day of January 1915, and the 14th day of September 1915, the said Proclamations, dated the 9th of September 1914, was amended as in those Proclamations set forth :

And whereas it is desirable to grant the licence hereinafter appearing :

Now, therefore, the Board of Trade, on behalf of His Majesty and in pursuance of the powers reserved in the said Proclamations and all other powers thereunto them enabling, do hereby give and grant licence to all persons and bodies of persons resident, carrying on business or being in the United Kingdom, to trade and have commercial and financial transactions with persons or bodies of persons resident or carrying on business in Poland :

Provided always that any licence which may be necessary in respect of any transaction under any prohibition of export or prohibition of import for the time being in force in the United Kingdom or in respect of any remittance of money out of the United Kingdom covered by Regulation 41D. of the Defence of the Realm Regulations, is first obtained :

Provided also that this licence shall not permit any person or body of persons to pay to any person or body of persons resident or carrying on business in Poland any sum of money which by the terms of the Trading with the Enemy Amendment Acts, 1914 and 1915, or either of them, is required to be paid to the Custodian appointed under the Trading with the Enemy Amendment Act, 1914, but such sums of money must be paid to the said Custodian.

Provided further that this licence shall not permit any person or body of persons to pay or deliver to any person or body of persons resident or carrying on business in Poland any sum of money or property of which, prior to the date hereof, notice has been or ought to have been given to the said Custodian under the said Acts or either of them.

And whereas the Trade Boards Acts, 1909 and 1918, do not apply to the trade specified in the appendix to this Order, and the Minister of Labour as respects that trade is of the aforesaid opinion ;

Now, therefore I, the Minister of Labour, in pursuance of the powers given to me by Section One of the Trade Boards Act, 1918, and by any other statute in that behalf do hereby make a Special Order that from and after the first day of April the following provision shall have effect (that is to say) :—

ARTICLE 1.—The Trade Boards Acts, 1909 and 1918, shall apply to the trade specified in the appendix to this Order.

ARTICLE 2.—This Order may be cited as the Trade Boards (Laundry) Order, 1919.

**HIGH-SPEED TOOL STEEL AND SCRAP
THEREFROM.**

In reference to the following Orders made by the Minister of Munitions, namely:—

The Steel Supplies (Metallurgical Coke, Iron and Steel) Order, 1916, dated the 7th July 1916.

- "(2) This Section shall operate in any area to which it is applied by Order of the Local Government Board, or, in Scotland and Ireland, the Local Government Board for Scotland and Ireland respectively:
- "Provided that no Order shall be made in respect of any area until a scheme for the gratuitous treatment of persons in that area suffering from venereal disease has been approved by the Local Government Board, or in Scotland and Ireland, the Local Government Board for Scotland and Ireland respectively, and is already in operation."

And whereas the Local Government Board for Scotland have approved a scheme for the gratuitous treatment of persons suffering from venereal disease within the area of the City and Royal Burgh of Glasgow, which scheme came into operation on the First day of December, Nineteen hundred and seventeen:

Now therefore We, the Local Government Board for Scotland, by this our Order, declare that Section One of the Venereal Disease Act, 1917, shall operate from and after the First day of May, Nineteen hundred and nineteen, within the area of the City and Royal Burgh of Glasgow.
