Colpoy's hired brig, off the Glenans, April 25. 1806.

My Lord-I have the honour to acquaint your Lordship, that on the 19th inft standing along shore between the Gienans and Iste Groer, with the Attack in company, I perceived two Chasse Marees at anchor in the entrance of the river Donillan, and which, upon our approach, quitted their anchorage, and ran up the river. Finding it netessation is the ground the figure of two gun hattery before the boats could get to them, I landed with twelve men from each brig, and after a short skirmish, got possession of and nailed up the guns (12-pounders); I afterwards brought the vessels down the river, and destroyed the signal post of Donillan. I am happy to acquaint your Lordship that the only damage we suftained was having some of our standing ranning rigging and fails cut.

I have to acknowledge the support I received from Lieutenant Swaine by his well directed fire upon the enemy's guns during the time we were reconnoitring the river and beach. I seel much obliged to Mr Wood, Assistant-Surgeon of the Growler, who veluntered his services, and attended the party that landed.
