HONOURS FOR MISCELLANEOUS SERVICES.

In recognition of his services whilst attached to the Staff of the Eastern Force in Egypt and Palestine.

Cdr. (now actg. Capt.) James Wolfe Murray, R.N.

Between the 14th and 28th August 1918, displayed great resource in bringing H.M.S. "Suffolk's" 12-pounder guns rapidly into action, and showed an excellent example of coolness and bravery under fire during the battles in the Ussuri District.

Cdr. John Wilfred Scott, R.N.

For valuable services in command of the units landed from H.M.S. "Cochrane" for the defence of Pechenga from the 3rd May 1918 to the 29th September 1918. During this period the force was frequently attacked by the enemy.

Lieut.-Cdr. Henry Hugh Gordon Dacres Stoker, R.N.

In recognition of his gallantry in making the passage of the Dardanelles in command of H.M. Australian Submarine "A. E. 2," on the 25th April 1915.

Lieut. Charles Henry Allen, R.N.

In recognition of his services as Commanding Officer of H.M. Submarine "E. 42," which carried out a successful attack on the German battle cruiser "Moltke," on the 25th April 1918.

Personally directed and controlled the firing of two of H.M.S. "Suffolk's" twelve-pounder guns against superior enemy forces in the battles on the Ussuri front between the 14th and 28th August 1918. Showed coolness and resource under fire.

Gnr. John Hawke Moffatt, R.N.

Displayed great coolness and precision in directing the fire of two of H.M.S. "Suffolk's" twelve-pounder guns during the battles on the Ussuri front between the 14th and 28th August 1918. Mr. Moffatt set a high example of bravery under fire, and when his observation post was attacked, continued to direct the fire until the enemy was close upon him, and by so doing prevented the enemy's armoured train advancing at a critical period.

Lieut. Lancelot Vivian Donne, D.S.C., R.N.

First Lieutenant of H.M. Submarine "E 42" during the successful attack by that vessel on the German Battle Cruiser "Moltke" on the 25th April 1918. The successful attack and the subsequent skilful manœuvring of "E 42" was largely due to his attention to detail and to his courage under trying conditions.

Now, therefore, I, the Minister of Labour, in pursuance of the powers given to me by Section One of the Trade Boards Act, 1918, and by any other statute in that behalf, do hereby make a Special Order that from and after the date hereof the following provision shall have effect (that is to say):

ARTICLE 1.—The Trade Boards Acts, 1909 and 1918, shall apply to the Trade specified in the Appendix of this Order.

ARTICLE 2.—This Order may be cited as the Trade Boards (Paper Bag Trade) Order, 1919.

APPENDIX.

TRADE.

The Paper Bag Trade, that is to say, the manufacture from paper (including gauze-lined or clothlined paper) of any bag or container without a gummed flap, including the operations of packing, parcelling, warehousing, receiving, store-keeping, despatching, time-keeping, lift-operating and cleaning, when these operations are carried on in connection with paper bag manufacture, and including the printing of paper bags when the printing apparatus is attached to the making apparatus; but excluding the manufacture of bags or containers with ungummed flaps (for use in the transmission of printed matter or samples) when made by the same processes as gummed envelopes, and excluding the manufacture of receptacles from cardboard, such as boxes, cartons or skillets.
