In virtue of the powers conferred on me by the National Galleries of Scotland Act, 1906 (6 Edw. VII., Ch. 50), I, the Right Honourable Robert Munro, K.C., M.P., His Majesty's Secretary for Scotland, do hereby prescribe and order as follows:—

- (1) During the period of five years from the date of this Order, the Board of Trustees for the National Galleries of Scotland shall have power to apply from time to time out of the annuity of two thousand pounds payable to them in terms of Section 8 of the Act cited, sums not exceeding one thousand pounds in all, for the purpose of assisting the publication of drawings selected from the collection known as the National Art Survey.
- (2) This Order shall be read with the National Galleries of Scotland (Application of Annuity) Order, 1907, and may be cited as the National Galleries of Scotland (Application of Annuity) Order, 1919.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 3rd day of May 1919, in the words following, viz.:—

- "Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:
- "And whereas we have had under consideration an application from Admiral the Hon. Sir Stanley Colville, G.C.V.O., K.C.B., lately Commander-in-Chief at Portsmouth, for the time spent by his servant William Snook, Officers' Chief Steward, O.No. 172851, during the Dongola Expedition in 1896 to count for purposes of pension:

"And whereas the time served by Admiral (then Commander) Colville and certain other Officers who were lent to the Egyptian Government for duty with this Expedition, was allowed to count as full service for pay, half-pay, and retirement:

"And whereas we consider it just that a similar concession should be made to Snook, who was with Commander Colville at the time:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the time spent by William Snook with the Dongola Expedition being allowed to count for purposes of pension.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, dated 31st October 1918, the Trade Board established under the Trade

When employed at $18\frac{1}{2}$ and under 19 years of age, 37s. 6d. per week.

When employed at 19 and under 191 years of age, 41s. per week.

When employed at $19\frac{1}{2}$ and under 20 years of age, 43s. 6d. per week.

When employed at 20 and under 201 years of age, 46s. per week.

When employed at 20½ and under 21 years of age, 50s. per week.

When employed at 21 and upwards, 55s. perweek.

B. Female Workers.

When employed under 14½ years of age, 12s. 6d. per week.

When employed at 14½ and under 15 years of age, 13s. 6d. per week.

When employed at 15 and under 15½ years of age, 14s. 6d. per week.

When employed at 15½ and under 16 years of age, 15s. 6d. per week.

When employed at 16 and under 16½ years of age, 17s. per week.

When employed at 16½ and under 17 years of age, 18s. 6d. per week.

When employed at 17 and under $17\frac{1}{2}$ years of age, 20s. 6d. per week.

When employed at 17½ and under 18 years of age, 22s. 6d. per week.

When employed at 18 and under 181 years of age, 27s. per week.

When employed at 18½ and under 19 years of age, 28s. 6d. per week.

When employed at 19 and under 191 years of age, 29s. 6d. per week.

When employed at 19½ and under 20 years of age, 30s. 6d. per week.

When employed at 20 and under 201 years of age, 31s. 6d. per week.

When employed at 20½ and under 21 years of age, 32s. 6d. per week.

When employed at 21 and upwards, 35s. per week.

The above rates are for a week not exceeding 48 hours.

The above Trade Board also give similar notice that they propose to Fix Overtime Rates under Section 3 (1) (c) of the Trade Boards Act, 1918, to apply in respect of male and female workers as follows:—

MALE AND FEMALE WORKERS (ALL AGES).

For the first two hours Overtime on any day-except Sundays and Customary Public Holidays, the Overtime Rate shall be equivalent to TIME AND A QUARTER, that is to say, one and a quarter times the minimum rate otherwise applicable.

For Overtime after the first two hours on any day, the Overtime Rate shall be equivalent to TIME AND A HALF, that is to say, one and a half times the minimum rate otherwise applicable.

For all time worked on Sundays and Customary and Statutory Holidays, the Overtime Rate shall be equivalent to DOUBLE TIME, that is to say, twice the minimum rate otherwise applicable.

In compliance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board propose to declare the NORMAL NUMBER OF HOURS OF WORK PER WEEK TO BE 48.

The Trade Board will consider any objections to the above Proposals to Fix which may be lodged with them within two months from 12th May 1919. Such objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary of the Tobacco Trade Board (Great Britain), 5 Chancery Lane, London, W.C. 2.

^{*} Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
