DEALINGS IN GERMAN-OWNED GOODS EX ENEMY VESSELS.

GENERAL LICENCE.

The Board of Trade, on behalf of His Majesty, and in pursuance of the powers reserved in the Trading with the Enemy Proclamations and all other powers thereunto them enabling, do hereby give and grant licence, so far as the Trading with the Enemy legislation is concerned, to all persons residing, carrying on business or being in the United Kingdom to purchase, import and deal in goods that are owned by persons or bodies of persons resident or carrying on business in Germany, and that are or were at the outbreak of war on board enemy vessels that have been handed over to the Allied and Associated Governments :

Provided always that any licence or permit which may be necessary in respect of any such transaction under any prohibition of import or use or other restriction or regulation (not being a prohibition, restriction or regulation imposed by or made under the Trading with the Enemy legislation) for the time being in force in the United Kingdom is first obtained :

Provided also that payment for any such goods is made to the Accountant General, Ministry of Shipping, for account of the German Government Fund.

NOTICE OF INTENTION TO MAKE SPECIAL ORDER.

TRADE BOARDS ACTS 1909 AND 1918.

1. The Minister of Labour hereby gives notice that he intends, pursuant to the powers conferred upon him by Section One of the Trade Boards Act, 1918, to make a Special Order applying the Trade Boards Acts, 1909 and 1918, to the Trade specified in the Appendix to this notice.

2. Copies of the Draft Special Order may be obtained on application in writing to the Secretary, Ministry of Labour, Montagu House, Whitehall, London, W. 1.

3. Objections to the Draft Special Order must be sent to the Minister of Labour at the above address within 42 days from the date of this notice.

4. Every objection must be in writing, and must state :---

ADMIRALTY NOTICE TO MARINERS. No. 1019 of the year 1919. WIRELESS DIRECTION FINDING STATIONS.

1. Wireless direction finding (D.F.) stations are stations set up ashore equipped with receiving apparatus which enables them to acserrain the direction from which wireless signals transmitted by another station emanate.

2. The accuracy with which bearings can be taken depends on the conditions outlined below ; but, although in general the bearings taken by a station within the sector over which it is designed to work can generally be considered accurate to within two degrees, the administrations controlling these stations cannot accept any responsibility for the consequences of a bearing being inaccurate.

3. It is, however, pointed out that if at least three D.F. stations can be employed and if they are so situated as to give intersecting bearings, considerable reliance can be placed upon the result of three simultaneous bearings thus obtained, provided that the "triangle of error" (sometimes called the "cocked hat") formed by the intersection of the bearings is small.

4. In order to obtain the greatest possible degree of accuracy, it is important that the ship should not transmit with too much power. Signals should, however, he fairly strong and clear; great care must be taken to keep the note and strength steady, and to pay strict attention to spacing.

5. It must be borne in mind that it is impossible for the majority of existing D.F. stations to distinguish between a bearing and its reciprocal (i.e., there is always a possible

error of 180°), and that bearings are often unreliable at night and in very bad weather, also when the direction runs roughly parallel with the coast-line.

6. The methods of asking for and giving bearings and the waves to be used will shortly be standardised by International agreement; and the particulars of the D.F. stations will eventually appear in the International List of Radiotelegraph Stations. Meanwhile, each country is publishing regulations governing the use of its own D.F. stations as set out below.

7. It should be noted that there are two principal systems of D.F. stations at present in use, viz. :-

(a) Where each D.F. station is fitted with transmitting and receiving gear and work independently of others.

(b) Where several D.F. stations (all of them usually near a harbour entrance or difficult passage) are linked together by special land telegraph lines, being thus controlled by one station which alone is fitted with transmitting apparatus. The controlling station in such cases is not necessarily a D.F. station, but may be an ordinary coast station.

10. A ship requiring a bearing should call the D.F. station required, and transmit a govern*ment* message requesting the bearing.

Example :-- A ship S.S. "Nonsuch," call sign XYZ, calls up Chebucto Head in the ordinary way and, on receiving "K" (go on), makes the

month) 10.50 M. (time) = Officer in charge Chebbucto Head = Request bearing = Master + XYZ.

11. The D.F. station will then acknowledge receipt of the message and, if not ready to take the bearing at once, will direct the ship to wait.

12. When ready to take the bearing, the D.F. station will make "K" (go on), whereupon the ship will make the figure "2" thirty times, commencing with the "Call" and ending with the "Cross" and her own call signal. 13. If the D.F. station is not satisfied with the bearing, it will make the "repeat" sign (2) and the ship will grain make the figure "2"

(?) and the ship will again make the figure " 2 " as above, but only twenty times.

14. In default of such request for a repetition, the D.F. station does not transmit until it is ready to give the bearing. To do so, the station calls the ship and sends (as a government message) the TRUE bearing of the ship from the station in degrees from 0° to 359°, the angles being measured from true north (0°) clockwise through true east (90°), true south (180°), and true west (270°).

18. These stations are available for use at about 30 miles range from the harbour entrance. They keep watch and take bearings on the 600metre wave.

19. The ship calls up the station or stations required and requests her bearing or position by means of the abbreviations shown below :-

20. The station will, if necessary, direct the ship to wait and, when ready for taking the bearing, will make "K" (go on). 21. The ship will then transmit :---

(i.) Her own call signal repeated for 30 seconds.

(ii.) A "dash" 5 seconds long.

(iii.) Her own call signal thrice. (iv.) A "dash" 5 seconds long.

(v.) Her own call signal thrice, then a "dash," and so on for one complete minute (i.e., for $1\frac{1}{2}$ minute in all), finishing with "K" (go on).

22. The station then calls the ship, and makes " $\overline{\text{QTE}}$ " followed by the true bearing in degrees (0° to 359°), as in para. 14, and the name of the D.F. station which obtained the bearing, or else "QTF" and the position in latitude and longitude. All numbers will be spelt out in words.

23. The ship acknowledges receipt by repeat-

ing back, in figures, the bearing or bearings or the position as the case may be.

24. When working with independent stations ships should always ask for bearings. Controlling stations may be requested to give bearings or positions as the master may elect.

26. All the above D.F. stations keep watch and take bearings on the 450 metres wave (see note). Except as shown in the notes they all work as independent stations and can transmit, as well as receive, on 450 metres.

Note.-Ships with Marconi apparatus can adjust their transmitting gear very nearly to this wave (using reduced power) by cutting out half the primary transmitting condenser and adjusting the A.T.I. till the earth lamp shows maximum current in the aerial. The primary slider should be "all in."

27. The actual procedure to be adopted by ships requiring bearings will depend upon what stations are concerned. It should be observed that if the stations to be called do not all keep watch on the same wave (e.g., Malin Head and Larne), bearings should be asked for separately. If on the other hand the stations to be called all keep watch on the same wave (e.g., Lizard and Carnsore), they should be called up together and the bearings taken in one operation. If, however, two or more stations are linked by special land lines (e.g., Peterhead and Berwick), only one of them should be called up (i.e., the nearest of them which is fitted with transmitting apparatus). In such cases, however, the ship must specify in the preliminary signal the D.F. stations which are required to supply bearings.

28. The following abbreviations are to be used :-Signal.

Meaning.

QTE ?... "What is my true bearing from you (or from ____) ? "

"Your true bearing from me (or from ——) was —— degrees." QTE ...

29. The ship calls the station or stations on the appropriate wave, making "QTE ?" in conjunction, if necessary, with the call signals

of the stations from which bearings are required and also (if the call is NOT made on 450 metres) by the figures "450," signifying that the ship will shift to 450 metres for the taking of the bearing. The ship then awaits instructions.

Example 1.

A ship whose call signal is XYZ requires bearings from Peterhead (BVL) and Berwick (BVG) and thinks that the latter is nearest.

The ship, having first shifted to 450 metres, calls Berwick thus :

"Call "BVG BVG de XYZ QTE BVL BVG ? She then awaits instructions.

Example 2.

The ship requires a bearing from Seaview (BXK). The ship has to use 600 metres to call Malin Head (GMH).

She calls on 600 metres, thus :--

"Call" GMH GMH de XYZ QTE BXK ? 450.

She then gets ready to shift to 450 metres and awaits instructions.

30. The station or stations called then make the necessary arrangements and, when ready, answer in alphabetical order of their call signals (if more than one was originally called) and make "K" (go on) preceded by "450" if 450 had been made in the original call.

Example 1.

Berwick, in Example 1 above, warns Peterhead by land line and, when both are ready, makes on 450 metres :--"Call "XYZ de BVG K

Example 2.

Malin Head, in Example 2 above, warns Seaview by land line and then makes on 600 metres : " Call " XYZ de GMH 450 K

Malin head then shifts to 450 metres so as to be ready to give the result when received by wire from Seaview.

31. On receiving "K," the ship, having shifted transmitting wake to 450 metres (if not already done), then makes her own call signal for 45 seconds and awaits the result.

Example 1.

The ship, in Example 1 above, makes on 450 metres :-

"Call" BVG de XYZ XYZ XYZ, &c. (for 45 seconds) XYZ

Example 2.

The same as Example 1, reading GMH for BVG.

32. The station or stations then reply (in alphabetical order if more than one) either asking the ship to repeat (?) or giving the result. The result is given by the signal QTE followed as necessary by the call signal and by a group of three figures (000 to 359) indicating the true bearing from 0° to 359°, reckoned as in paragraph 14, of the shp from the station. Several bearings can be combined into one message, each bearing immediately following the call signal of the station which took it. The time of handing in is always expressed in Greenwich mean time for all messages giving bearings to merchant ships.

Example 1.

Peterhead, in Example 1 above, is not satisfied with the bearing and informs Berwick. Berwick makes on 450 metres :-

"Call "XYZ de BVG ?

The ship at once complies by making on 450 metres :-

"Call " BVG de XYZ XYZ XYZ, &c. (for 45 seconds) XYZ

Peterhead is then satisfied that the bearing is 130° and informs Berwick, while Berwick finds that its own result is 37°. Berwick therefore makes 450 metres :-

"Call" XYZ XYZ de BVG 1 9.45 M $(time) = QTE BVL 130 BVG 037 \times BVG$

Example 2.

Seaview, in Example 2 above, gets a satisfactory bearing of 329° and informs Malin Head. The latter makes on 450 metres :--

"Call" XYZ XYZ de GMH 2 10.46 S $(time) = QTE BXK 329 \times GMH$

Example 3.

Had the ship merely asked Lizard (BVY) for a bearing, Lizard, finding it to be 246°, would make on 450 metres :-

"Call " XYZ XYZ de BVY 1 7.6 M. $(time) = QTE 246 \times BVY.$

33. The ship, on receiving the result, acknowledges receipt in the ordinary way, and makes the "end of work" sign. This sign is then repeated by the station or stations concerned. It is important that the "end of work" sign should not be omitted, since it not only indicates that the operation is finished, but it also shows that all concerned are about to resume watch on their normal wave.

COUNTY OF PEEBLES.

ORDER of the LOCAL GOVERNMENT BOARD FOR SCOTLAND in terms of Section 83 of the Public Health (Scotland) Act, 1987, authorising a combination of certain Local Authorities for the carrying out of a scheme for the diagnosis, treatment, and prevention of Venereal Diseases.

WHEREAS WE, the Local Government Board for Scotland, by an Order dated the 26th day of October 1916, made certain regulations in terms of Section 78 in Part IV. of the Public Health (Scotland) Act, 1897, with a view to the diagnosis, treatment and prevention of Venereal Diseases, which are endemic and infectious diseases ;

And whereas We are empowered by Section 83 of the aforesaid Public Health (Scotland) Act, 1897, by Order to authorise or require any two or more Local Authorities to act together for the purposes of Part IV. of the aforesaid Act, and to prescribe the mode of such joint action and of defraying the costs thereof;

And whereas the following Authorities are Local Authorities within the meaning of the aforesaid Public Health (Scotland) Act, 1897, videlicet :

(1) The County Council of the County of Peebles;

(2) The Town Council of the Burgh of Innerleithen;

(3) The Town Council of the Burgh of Peebles; And whereas it is expedient that a combination of the aforesaid Local Authorities be effected for the purposes specified in Our Order of 26th October 1916 aforesaid;

Now therefore We, the Local Government Board for Scotland, in pursuance of the powers vested in Us as aforesaid, to make the following Order :---

Combination of Authorities.

Article I.—From and after the date of the coming into operation of this Order, the said Local Authorities (hereinafter referred to as the "Combining Authorities") are authorised by Us to act together for the purpose of carrying out the Regulations contained in Our Order of 26th October 1916 aforesaid, or any further Regulations that we may make hereafter with reference to the diagnosis, treatment, and prevention of Venereal Diseases.

Formation of Joint Committee.

Article 2 (1).—All things that may be necessary for the purpose of carrying out the aforesaid Regulations within the districts of the aforesaid Local Authorities shall be undertaken by a Joint Committee, to be called the Peeblesshire Venereal Diseases Joint Committee (hereinafter referred to as "the Joint Committee ").

Number and qualifications of members.

(2).—The Joint Committee shall consist of six members elected from the members of the Combining Authorities or such other number as We may from time to time determine.

Representation of Authorities.

(3).—Of the said six members the said County Council shall appoint three of their members as their representatives and the Town Council of the said Burgh of Peebles two, and the Town Council of the said Burgh of Innerleithen one of their members as their representatives all in the manner hereinafter provided. Provided that, when it appears to Us necessary, We may readjust the representation of the said Local Authorities on the Joint Committee.

Tenure of Office of Members.

(4).-The said members to be appointed by the said County Council shall be appointed triennially at the first meeting of the said County Council held after the triennial election of County Councillors; the said members to be appointed by the said Town Councils shall be appointed annually at meetings of the said Town Councils in the months of November or December. Each of the said members to be appointed by the said County Council shall hold office for the period of three years from the date of his appointment, or for such shorter period as he shall remain a member of the said County Council, and each of the said members of the said Town Councils shall hold office for one year from the date of his appointment, or for such shorter period as he shall remain a member of the Town Council appointing him. Retiring members shall be eligible for re-appointment. The names and addresses of the said members shall, immediately after their respective appointments, be intimated to the clerk of the Joint Committee by the clerks of the Combining Authorities making the respective appointments.

Filling up Vacancies.

(5).—In the event of any vacancy occurring in the Joint Committee from any cause the

local authority in whose representation the vacancy has occurred, may fill up the same, *ad interim*, and upon such interim appointment being made, the name and address of the member so appointed shall be intimated to the clerk of the Joint Committee. Each of the members appointed *ad interim* shall hold office till the first ensuing triennial or annual appointment, as the case may be, of members of the Joint Committee by the Local Authority whose representative he is, or for such shorter period as he may remain a member of the Local Authority appointing him.

Appointment of First Representatives.

(6).—The first appointment of members of the Joint Committee shall be made as early as practicable after the date of this Order, by the said County Council and Town Councils, in as nearly as may be the manner above provided in regard to triennial and annual appointments of said members; the names and addresses of the said members so first appointed shall be intimated to the County Clerk of Peebles who shall, convene the first meeting of the Joint Committee to be held at Peebles; each of the members so first appointed by the said County Council shall, if he remains a member of the said County Council, hold office till the first meeting of the said County Council after the next election of County Councillors held after the date of this Order, when representatives of the said County Council shall be appointed for the then ensuing three years; and each of the members so first appointed by the said Town Councils shall, if he. remains a member of the Town Council appointing him, hold office till the months of November or December as the case may be in the year in which the next election of Town Councillors, after the date of this Order takes place, when representatives of the said Town Councils shall be appointed for the ensuing year.

Quorum.

(7).—The quorum of the Joint Committee shall, unless the Committee otherwise determine, be not less than one-fourth of the whole number of the Committee. The Joint Committee may act notwithstanding any vacancy or vacancies caused by insufficient appointment of members or otherwise, provided that a quorum exists.

Annual Meeting-Election of Chairman, etc.

(8).—A general meeting of the Joint Committee shall be held annually on such date in the month of January or February as the Committee shall determine. At the general meeting or some adjournment thereof the members shall elect one of their number to be chairman for the year then ensuing, and another to be vice-chairman for the same period : Provided that at the first meeting of the Joint Committee convened in terms of Article 2!(6) hereof, the members shall elect one of their number to be chairman for the period till the first annual general meeting in terms hereof, and another to be vice-chairman for the same period.

Meetings and Powers of Joint Committee.

(9).—The Joint Committee shall meet for the despatch of business at such other times and at

such place or places as they may from time to time fix. They shall have power (1) to make standing orders regulating their proceedings and business; (2) to fix the quorum for meetings; (3) to appoint such sub-committees as they may from time to time consider necessary; (4) to appoint a clerk (who may also be treasurer) and such other officers and servants as may be considered necessary, and to pay them such salaries as the Joint Committee may from time to time think proper; and (5) to delegate to the subcommittees and officers so appointed such of their powers as they may see fit.

(10).—The decisions of the Joint Committee shall not be subject to the review of any of the Combining Authorities.

Finance—Basis of Contribution—Requisition for Funds.

Article 3 (1).—The whole expenditure incurred by or under the authority of the Joint Committee in carrying out the Regulations referred to in Article 1 hereof, under deduction of the sums received by them from Government Grant and other sources, shall be defrayed by the Combining Authorities in proportion to the populations of their respective districts according to the latest available census returns.

(2).—The Joint Committee shall, between the 15th day of May and the 15th day of June in each year, prepare an estimate of their expenditure under this Article during the year to the 15th day of May succeeding, and shall, not later than 15th June, transmit a copy of such estimate to each of the Combining Authorities, and shall at the same time certify to each of such Combining Authorities the proportion of the total estimated expenditure falling to be defrayed by them.

(3).—The Joint Committee shall fix (a) the date in each year on or before which the proportions of the amount of the estimated expenditure for the year or (b) the dates in each year on or before which instalments of the proportions of the estimated expenditure for the year are to be paid to them by the several Combining Authorities; and shall intimate such date or dates to these Authorities who shall make payment of the amounts on or before the dates so fixed and intimated.

(4).—The Joint Committee shall make up and transmit to Us claims for any Government Grant-in-aid payable in respect of the expenditure incurred by them or under their authority upon the diagnosis, treatment, and prevention of Venereal Diseases, and shall receive such Government Grant-in-aid payable in respect of such expenditure.

Accounts and Audit.

Article 4 (1).—The provision as to the preparation and audit of accounts of County Councils as contained in Sections 68 to 70 of the Local Government (Scotland) Act, 1889, as amended by the Local Government (Scotland) Act, 1908, shall, *mutatis mutandis*, apply to the preparation and audit of accounts of the Joint Committee.

(2).—The audited accounts shall show the sums payable during the year by each of the Combining Authorities under Article 3 of this Order. A copy of the audited accounts shall be transmitted to each of the Combining Authorities, and any necessary adjustment in the

accounts between the Joint Committee and these Authorities shall thereafter be made and intimation of the same shall be transmitted by the Joint Committee to the Authorities. A copy of the audited accounts shall also be transmitted to Us by the Joint Committee.

Power to amend Order.

Article 5.—This Order may be amended by Us after consultation with the Joint Committee from time to time as We may deem necessary.

Grant-in-Aid.

Article 6.—Nothing in this Order shall affect Our powers in connection with the administration and distribution of any grant-in-aid of the cost of the diagnosis, treatment, and prevention of Venereal Diseases.

Appeal to Local Government Board.

Article 7.—Any dispute or difference arising among the Combining Authorities as to the interpretation or implement of the terms of this Order may be submitted to Us for Our determination by the Joint Committee or by any of the Combining Authorities, and Our decision in regard thereto shall be final and binding on all parties.

Date of Order coming into Operation.

Article 8.—This Order shall, notwithstanding the date hereof, be held to have come into operation as from the sixteenth day of May in the year one thousand nine hundred and nineteen.

And whereas the aforesaid Local Authorities have by a Minute of Agreement dated 20th and 28th January, 4th, 10th, and 19th February and 17th and 20th March 1919, and (subject as provided in Article 2 hereof) approved by Us, recorded their willingness to act together for the purposes of carrying out the aforesaid Regulations ;

Now Therefore We, the Local Government Board for Scotland, in pursuance of the powers vested in Us as aforesaid, do make the following Order :-

Combination of Authorities.

Article 1.-From and after the date of this Order, the said Local Authorities (hereinafter referred to as the "Combining Authorities") are authorised by Us to act together in the manner set forth in the aforesaid Minute of Agreement and in any amendment thereof that We may approve for the purpose of carrying out the Regulations contained in Our Order of 26th October 1916 aforesaid, or any further Regulations that we may make hereafter and which may be binding on them, with reference to the diagnosis, treatment, and prevention of Venereal Diseases.

Accounts and Audit.

Article 2.-With reference to Article sixteenth of the said Minute of Agreement, it is hereby provided that the provisions as to the preparation and audit of Accounts of County Councils, as contained in Sections 68 to 70 of the Local Government (Scotland) Act, 1889, as amended by the Local Government (Scotland) Act, 1908, shall mutatis mutandis apply to the preparation and audit of the accounts of the Joint Committee.

Power to Amend Order.

Article 3.-This Order may, in so far as authorised by the aforesaid Section 83 of the Public Health (Scotland) Act, 1897, be amended by Us after consultation with the Combining Authorities from time to time as We may deem necessary.
