BY THE KING. A PROCLAMATION FOR A BANK HOLIDAY.

GEORGE R.I.

TE, considering that it is desirable that Tuesday, the First day of July next, should be kept as a close holiday in all Banks throughout the United Kingdom, do hereby, by and with the advice of Our Privy Council, and in pursuance of Section four of the Bank Holidays Act, 1871, appoint the said Tuesday, the first day of July next, to be observed as a Bank holiday in the United Kingdom, for the purposes of the said Act, and We do, by this Our Royal Proclamation, command the said day to be so observed, and all Our loving subjects to order themselves accordingly:

And whereas it is customary for the usual Bank Holidays to be kept as holidays by Our loving subjects generally and not only for the purposes of the said Act, but it is not Our intention that the said First day of July should be kept as a general holiday in the United Kingdom:

Now, therefore, We do hereby enjoin that the said First day of July shall not be kept as or deemed by virtue of this Our Royal Proclamation to be a holiday in the United Kingdom, for any purposes whatsoever other than the purposes of the said Act.

BY THE KING. A PROCLAMATION

RELATING TO THE IMPORTATION OF CERTAIN ARTICLES INTO THE UNITED KINGDOM.

GEORGE R.I.

THEREAS by Section forty-three of the Customs Consolidation Act, 1876, it is provided that the importation of arms, ammunition, gunpowder, or any other goods may

be prohibited by Proclamation:

And whereas by certain Proclamations entitled Prohibition of Import Proclamations the importation of certain goods has been pro-

hibited accordingly:

And whereas it is expedient that the importa-tion into the United Kingdom of certain other

goods should be prohibited:

Now, therefore, We, by and with the advice of Our Privy Council, in pursuance of the said Act and of all other powers enabling Us in that behalf, do hereby proclaim, direct, and ordain as follows :-

As from and after the date hereof, subject this twenty-fifth day of June, in the as hereinafter provided, the importation into the United Kingdom of the following articles is hereby prohibited, viz. :-

Chemicals of all descriptions.

Electrical goods and apparatus, including electrical plant and machinery of all kinds, and insulating materials of all descriptions.

Scientific, mathematical, and optical in-

Tungsten powder and ferro-tungsten.

Provided always, and it is hereby declared, that this prohibition shall not apply to any such goods which are imported under licence given by or on behalf of the Board of Trade, and subject to the provisions and conditions of such licence.

This Proclamation may be cited as the Prohibition of Import (No. 32) Proclamation, 1919.

HEREAS by sub-section one of section nine of the Scottish Board of Health Act, 1919, it is enacted that the Act shall come into operation upon such day or days as may be appointed by Order in Council and that different days may be appointed for different purposes and provisions of the Act.

Now, therefore, His Majesty, by and with the advice of His Privy Council, in pursuance of the Scottish Board of Health Act, 1919, and of all other powers enabling Him in that behalf, is pleased to order and it is hereby ordered as

- 1. For such of the provisions of the said Act as are hereinafter mentioned the appointed day shall be (1) the 25th day of June 1919 in the case of sections one and three, (2) the 1st day of July 1919 in the case of section two, paragraphs (a), (b), and (i) of sub-section one of section four, and both provisos to the said sub-section, subsections two, three, four, and five of section four, section five, section six (except so far as relating to the Highlands and Islands (Medical Service) Board), section seven, section eight, and subsection four of section nine; except so far as paragraph (a) of sub-section one of section four relates to powers and duties conferred or imposed upon the Local Government Board for Scotland by any Act of Parliament passed, or Provisional Order confirmed, or other Instrument made, on or after the 1st day of July 1919, but during the present session of Parliament, in respect of which powers and duties the appointed day shall be the day on which the Act, Order or Instrument comes into operation.
- 2. The Interpretation Act, 1889, applies for the purpose of the interpretation of this Order as it applies for the interpretation of an Act of Parlia nent.

3. This Order may be cited as the Scottish Board of Health Act, 1919 (Date of Commencement) (No. 1) Order, 1919.

HEREAS the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, as amended by the Secretary for Scotland Act, 1885, made a Representation that he has received a copy of an Interlocutor by the Sheriff-Substitute at Banff, dated the 20th May 1919, and made on a Petition of the Reverend George Arthur Macdonald Dickson, the Minister of the Parish of Fordyce, in the County of Banff, and certain persons assessed for the relief of the poor within the said Parish, finding that the Burial Ground of the said Parish is offensive, and contrary to decency:

And whereas in the said Representation it is recommended that the Churchyard at Fordyce in the said Parish of Fordyce, in the County of Banff, should be closed forthwith, in terms of the said first-named Act, except for the interment therein of the surviving spouses of persons already interred therein; Provided that, with regard to interments taking place after the date when the Closing Order comes into operation, (1) the exercise of the right of burial shall not be injurious to the public health, or offensive or contrary to decency, (2) Notice be given to the Clerk of the Parish Council of Fordyce on the day preceding that on which a grave is to be opened, and (3) no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin:

Now, therefore, His Majesty in Council is pleased to give Notice of such Representation, and to order that the same be taken into consideration by a Committee of the Privy Council

on the 1st day of August next:

And His Majesty is further pleased to direct that this Order, or Notice thereof, be published in the Edinburgh Gazette, and that copies of this Order, or Notice thereof, be fixed as required by the above-mentioned Act on the doors of the Church of, or on some other conspicuous places within, the Parish of Fordyce aforesaid, one month before such Representation is so considered.

REGULATION, DATED JUNE 21, 1919, MADE BY THE SECRETARY OF STATE UNDER SECTION 5 OF THE LOCOMOTIVES ON HIGHWAYS ACT,

Notwithstanding anything in No. 10 of the Regulation, dated 31st July 1907, petroleum spirit may be kept for the purposes of light locomotives in iron or steel drums or barrels of a capacity not exceeding 50 gallons, provided the following conditions are observed :-

(a) The storehouse must be situated at a

distance of at least 20 feet from any other | Regulations Respecting building or any highway or public footpath.

(b) Provision must be made by excavation or by the erection of retaining walls to prevent outflow of the spirit in the event of fire if such outflow would be likely to endanger life or

cause damage to the property of others.

(c) Notice shall be given to the Local Authority, and the duly authorised officer of such Authority shall be allowed to inspect the spirit in the same manner as is provided in No. 7 of the said Regulations.

This Regulation shall remain in force until 31st December 1923, unless sooner revoked.

OPEN COMPETITIVE Examinations for the Situation of Female Writing Assistant in the General Post Office, in London, in the Office of the PUBLIC TRUSTEE, AND IN THE NATIONAL HEALTH INSURANCE COMMISSIONS FOR ENGLAND AND SCOTLAND.

These Regulations are liable to alteration from time to time.

- 1. The limits of age for these situations are 16 and 18. If an examination begins in one of the first six months of any year, Candidates must be of the prescribed age on the first day of February in that year. If an Examination begins in one of the last six months of any year, Cardidates must be of the prescribed age on the first day of August in that year.
- 2. Candidates will be required to satisfy the Civil Service Commissioners that they are duly qualified in respect of health and character. No person will be eligible who is not a natural-born British subject, and the child of a father also a natural-born British subject.
- 3. At each Examination the number of Candidates to be selected will be such as may from time to time be fixed.
- 4. The Examination will be in the following subjects, viz.:-
 - 1. English Composition.
 - 2. Handwriting.
 - 3. Spelling.
 - 4. Arithmetic.
 - 5. Geography.
 - 6. Reading Manuscript.
- 5. No Candidate will be admitted to Examination who does not, at such time as may be fixed by the Civil Service Commissioners, produce an undertaking, signed by her Parent or Guardian, that she will, if successful, reside either with her parents or guardians, or with relations or friends approved by such parents or guardians.

Candidates who fail to obtain such an aggregate number of marks as may indicate in the judgment of the Civil Service Commissioners a competent amount of general proficiency will not be regarded as qualified.

- 6. Candidates for the Post Office Service must be at least five feet in height.
- 7. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to attend the examination, dated before the commencement of the competition.
- 8. Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchequer, will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.
- 9. Application for permission to attend an Examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.

Treasury Chambers, 26th June 1919,

An Order in Council was passed on the 25th instant bringing into immediate operation sections one and three of the Scottish Board of Health Act and fixing the 1st July as the date of transfer to the new Board of the powers and duties of the Local Government Board for Scotland, the Scottish Insurance Commissioners, and (so far as relating to the medical inspection and treatment of children and young persons) the Scottish Education Department.

The KING having been pleased, in pursuance of section one of the Act, to approve the appointment of a Scottish Board of Health, the Board is now in being and its personnel (so far as not already laid down in the Act) will shortly be completed under the advice and direction of the Secretary for Scotland as President of the Board.

CORN PRODUCTION ACT, 1917.

THE DISTRICT AGRICULTURAL WAGES COMMITTEE FOR THE MORAY FIRTH DISTRICT (No. 2).

Notice of the coming into force of Overtime Rates of wages for Agricultural Workmen in the area comprising:—

THE DISTRICT AGRICULTURAL WAGES COMMITTEE FOR DUMFRIES AND GALLOWAY, duly certified by the Board of Agriculture for Scotland under the Second Schedule of the Corn Production Act, 1917, hereby give notice that the following Minimum Rates of Wages for Workmen employed in Agriculture for time work which were fixed by them on the 2nd day of June 1919, in terms of the Schedule hereto, not having been disallowed by the Central Agricultural Wages Committee for Scotland within the period prescribed by the Board, have come into force under Clause 6 of the Second Schedule, with effect from said 2nd day of June 1919, and will remain in force until cancelled or varied either wholly or in part by the Committee.

SCHEDULE.

1. The minimum rates hereby fixed are inclusive of the value of any benefits or advantages received by the workmen in part payment of wages, reckoned according to the values determined by the District Wages Committee under Section 12 (1) (b) of the Act.

The minimum rates hereby fixed shall apply to all workmen who are wholly or partly employed in agriculture within the meaning of Section 17 (1) of the Corn Production Act during such time as they are so employed, with the exception of Agricultural Students and Discharged Soldiers and Sailors under training in Forestry.

3. The minimum rates hereby fixed per week shall apply to all workmen who are engaged for whole-time work for a week or any longer period, and the rates fixed per hour shall apply in other cases.

4. When a workman is engaged for whole-time work for a week or any longer period, the minimum rate applicable shall be payable in full even although, through no fault, failure, or disability of the workman, the hours agreed upon between him and his employer and actually worked are less than the number of hours on which the minimum rate is to be reckoned.

5. The minimum rates hereby fixed are to be reckoned as applying to the working hours per week as follows:—

From February 1 to June 15, 9 hours per day.

From June 16 to October 15, 10 hours per day.

From October 16 to January 31, 8 hours per day.

The foregoing are exclusive of meal times and time required for stable work, and of 21 whole holidays or 42 half-holidays, none of which shall be demandable during 10 weeks of hay and harvest.

The minimum rates for overtime shall be the ordinary rates plus one-quarter more during hay and harvest, and the ordinary rates for any other period. Subject to Clause 7 of this Schedule, all employment in excess of the working hours defined in Clause 5 shall be treated as overtime employment.

7. The minimum rates hereby fixed shall for a ploughman cattleman, or shepherd be increased by 5s. per week or $1\frac{1}{4}$ d. per hour, for the time during which he is under contract of employment or employed as such, and no stable work, byre work shepherding, or other work necessary for the health and comfort of animals shall be reckoned as overtime employment.

8. The minimum rates hereby fixed shall be increased by 2s. 6d. a week for the first dog, and an additional 2s. a week for each | 26th June 1919.

additional dog which the workman is required by the conditions of his employment to keep and feed.

9. Subject to the above conditions, the minimum rate for a male workman over 18 years of age shall be 33s. per week or 8d. per hour.

10. From and after the date on which this Order comes into operation, the Orders heretofore made by this Committee shall be varied or cancelled so far as may be necessary to give effect to this Order.

11. The area comprises the Counties of Dumfries, Kirkcudbright, and Wigtown.
